7	"(B) Eligibility.—To be selected to re-
8	ceive a grant under this paragraph, a service in-
9	stitution—
10	"(i) may be located in any State; and
11	"(ii) shall—
12	"(I) submit to the Secretary and
13	application at such time, in such man-
14	ner, and containing such information
15	as the Secretary may require;
16	"(II) meet criteria established by
17	the Secretary; and
18	"(III) agree to the terms and
19	conditions of the grant, as established
20	by the Secretary.
21	"(C) Priority.—In awarding grants
22	under this paragraph, the Secretary shall give
23	priority to service institutions that—
24	"(i) serve both breakfast and lunch

3	"(D) Duration.—A service institution
4	that receives a grant under this paragraph may
5	use the grant funds during the 5-fiscal-year pe-
6	riod beginning in fiscal year 2011.
7	"(E) Travel reimbursement.—A serv-
8	ice institution that receives a grant under this
9	paragraph may use grant funds to provide re-
10	imbursement for travel to satellite congregate
11	feeding sites.
12	"(F) Funding.—
13	"(i) In General.—On October 1,
14	2010, out of any funds in the Treasury not
15	otherwise appropriated, the Secretary of
16	the Treasury shall transfer to the Sec-
17	retary to carry out this section
18	\$10,000,000, to remain available until ex-
19	pended.
20	"(ii) Receipt and acceptance.—
21	The Secretary shall be entitled to receive,
22	shall accept, and shall use to carry out this
23	section the funds transferred under clause
24	(i), without further appropriation.

1	"(iii) Limitation.—Not more than 1
2	percent of the funds made available under
3	clause (i) may be used by the Secretary for
4	the administrative costs of carrying out
5	this paragraph.".
