A BILL

To provide grants to cities with high unemployment rates to provide job training, public works, and economic development programs, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Jobs for Urban Sus-
- 5 tainability in America Act".

1 SEC. 2. GRANTS TO CITIES WITH HIGH UNEMPLOYMENT.

- 2 (a) Department of Commerce Grants for Pub-
- 3 LIC WORKS AND ECONOMIC DEVELOPMENT.—The Sec-
- 4 retary of Commerce shall use the funds made available
- 5 to the Secretary under section 3(a)(2) to make additional
- 6 grants—
- 7 (1) to cities with high unemployment, under
- 8 sections 201, 203, 207, and 209 of the Public Works
- 9 and Economic Development Act of 1965; and
- 10 (2) under the Trade Adjustment Assistance for
- 11 Firms Program under chapters 3 and 5 of title II
- of the Trade Act of 1974.
- 13 (b) Department of Labor Grants for Job
- 14 Training Programs.—The Secretary of Labor shall use
- 15 the funds made available to the Secretary under section
- $16 \ 3(a)(1)$ to carry out adult and dislocated worker employ-
- 17 ment and training activities under chapter V of subtitle
- 18 B of title I of the Workforce Investment Act of 1998 (29
- 19 U.S.C. 2861 et seq.) to benefit cities with high unemploy-

- 21 (c) CITY WITH HIGH UNEMPLOYMENT DEFINED.—
- 22 For purposes of this section, the term "city with high un-
- 23 employment" means a city that—
- 24 (1) has a population of at least 600,000 people;
- 25 and

1 (2) has, for each month beginning with January 2 2009, and ending on the date of the enactment of 3 this Act, an unemployment rate of 10 percent or 4 more. SEC. 3. FUNDING. (a) Funding From the TARP.—Of funds made 6 available to the Secretary of the Treasury under title I 8 of the Emergency Economic Stabilization Act of 2008 (12 U.S.C. 5211 et seq.) that remain unobligated, the Sec-10 retary of the Treasury shall— 11 (1) make \$5,000,000,000 available to the Sec-12 retary of Labor to carry out section 2(a); and 13 (2) make \$5,000,000,000 available to the Sec-14 retary of Commerce to carry out section 2(b). 15 (b) AUTHORIZATION.—The amounts described under subsection (a) shall be deemed to be for actions authorized 16 under title I of the Emergency Economic Stabilization Act of 2008. 18
