Mr. FRELINGHUYSEN introduced the following bill; which was referred to the Committee on Natural Resources

A BILL

To designate the library and archives gallery at the Washington's Headquarters Museum at Morristown National Historical Park in the State of New Jersey, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. FINDINGS.**

4 Congress finds that—

5 (1) in 1933, Lloyd W. Smith was instrumental
6 in the establishment of the Nation's first national
7 historical park, Morristown National Historical
8 Park, in Morristown, New Jersey, with his donation

1 of much of the land for the Jockey Hollow Unit of
2 the park;

3 (2) in 1955, upon his death, his extensive li-
4 brary and archival collection was donated to Morris-
5 town National Historical Park, provided that an ap-
6 propriate building was constructed to house the col-
7 lection;

8 (3) in 1957, a new library wing to the Washing-
9 ton's Headquarters Museum was built to house the
10 collections;

11 (4) in 2007, a new and larger library wing was
12 added to the museum to better preserve and display
13 the extensive collection, and the former library wing
14 of the museum was converted to an archives gallery;
15 and

16 (5) Lloyd W. Smith's significant contributions
17 to the establishment of the Morristown National
18 Historical Park and to the establishment of the re-
19 nowned library with an extensive archives collection
20 should be recognized.

21 **SEC. 2. DESIGNATION OF LIBRARY AND ARCHIVES GAL-**
22 **LERY AT THE WASHINGTON'S HEAD-**
23 **QUARTERS MUSEUM.**

24 (a) DESIGNATION.—The library and archives gallery
25 located in the Washington's Headquarters Museum at

1 Morristown National Historical Park shall be known and
2 designated as the “Lloyd W. Smith Library” and the
3 “Lloyd W. Smith Archives Gallery”, respectively.

4 (b) REFERENCES.—Any reference in a law, map, reg-
5 ulation, document, paper, or other record of the United
6 States to the library and archives gallery at the Washing-
7 ton’s Headquarters Museum referred to in subsection (a)
8 shall be deemed to be a reference to the “Lloyd W. Smith
9 Library” and the “Lloyd W. Smith Archives Gallery”, re-
10 spectively.
