## A BILL

To amend the Minuteman Missile National Historic Site Establishment Act of 1999 to modify the boundary of the Minuteman Missile National Historic Site in South Dakota, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Minuteman Missile Na-
- 5 tional Historic Site Boundary Modification Act".

### 1 SEC. 2. BOUNDARY MODIFICATION AND LAND TRANSFER.

2	(a) Boundary Modification.—Subsection (a) of
3	section 3 of the Minuteman Missile National Historic Site
4	Establishment Act of 1999 (Public Law 106–115; 113
5	Stat. 1540) is amended—
6	(1) by redesignating paragraphs (3) and (4) as
7	paragraphs (4) and (5), respectively;
8	(2) by inserting after paragraph (2), the fol-
9	lowing new paragraph (3):
10	"(3) Visitor facility and administrative
11	SITES.—The historic site shall also consist of the
12	land and interests in land generally depicted on the
13	map referred to as 'Minuteman Missile National
14	Historic Site Boundary Modification', numbered
15	406/80,011 and dated July 17, 2009, including—
16	"(A) approximately 25 acres of land lo-
17	cated north of exit 131 on Interstate 90 in
18	Jackson County, South Dakota, for the con-
19	struction and use of a visitor facility and ad-
20	ministrative site; and
21	"(B) approximately 3.65 acres of land lo-
22	cated at the Delta 1 Launch Control Facility,
23	for the construction and use of a parking lot
24	and for other administrative purposes."; and
25	(3) in paragraph (4) (as redesignated by para-
26	graph (1) of this section)—

1	(A) by striking the heading and inserting
2	the following new heading: "AVAILABILITY OF
3	MAPS.—''; and
4	(B) by striking "The map described in
5	paragraph (2)" and inserting the following:
6	"The maps described in paragraphs (2) and
7	(3)".
8	(b) Land Transfer.—Subsection (e) of such section
9	is amended—
10	(1) in paragraph (1), by striking "paragraph
11	(2)" and inserting "paragraphs (2) and (3)"; and
12	(2) by adding at the end the following new
13	paragraph:
14	"(3) Buffalo gap national grassland
15	BOUNDARY MODIFICATION.—
16	"(A) Land Transfer.—The Secretary of
17	Agriculture shall—
18	"(i) transfer administrative jurisdic-
19	tion over the land described in subsection
20	(a)(3) to the Secretary; and
21	"(ii) modify the boundaries of the
22	Buffalo Gap National Boundary Grassland
23	to exclude such land from the boundaries
24	of the Grassland.

"(B) AVAILABILITY OF MAP.—As soon as is practicable after the transfer specified in subparagraph (A) occurs, the Secretary shall prepare a map and a legal description of the Minuteman Missile National Historic Site, including the land described in subsection (a)(3) to be placed on file and available for public inspection in the appropriate offices of the National Park Service."
