A BILL

To amend the Congressional Budget Act of 1974 to require Congress to establish a unified and searchable database on a public website for congressional earmarks.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Earmark Trans-
- 5 parency Act of 2010".

1	SEC. 2. UNIFIED AND SEARCHABLE DATABASE FOR CON-
2	GRESSIONALLY DIRECTED SPENDING ITEMS.
3	(a) In General.—Title III of the Congressional
4	Budget Act of 1974 is amended by adding at the end the
5	following new section:
6	"UNIFIED AND SEARCHABLE DATABASE FOR
7	CONGRESSIONALLY DIRECTED SPENDING ITEMS
8	"Sec. 316. (a) Establishment of Database.—
9	Within six months after the date of enactment of this sec-
10	tion, the Clerk of the House of Representatives and the
11	Secretary of the Senate shall jointly establish a searchable
12	website, available to the public at no cost, listing all re-
13	quests by Members of Congress for congressionally di-
14	rected spending items.
15	"(b) Content.—The website established under sub-
16	section (a) shall be comprised of a database including the
17	following information for each congressionally directed
18	spending item requested by a Member of Congress:
19	"(1) The fiscal year in which the item would be
20	funded.
21	"(2) The number of the bill or joint resolution
22	for which the request is made, if available.
23	"(3) The amount of the initial request made by
24	the Member of Congress.
25	"(4) The amount approved by the committee of
26	jurisdiction.

1	"(5) The amount carried in the bill or joint res-
2	olution (or accompanying report) as passed by the
3	House, as passed by the Senate, and as transmitted
4	to the President, as applicable.
5	"(6) The name of the department or agency,
6	and the account or program, through which the item
7	will be funded.
8	"(7) The name and the State or district of the
9	Member of Congress who made the request.
10	"(8) The name and address of the intended re-
11	cipient.
12	"(9) The type of organization (public, private
13	nonprofit, or private for profit entity) of the in-
14	tended recipient.
15	"(10) The project name, description, and esti-
16	mated completion date.
17	"(11) A justification of the benefit to taxpayers.
18	"(12) Whether the request is for a continuing
19	project and if so, when funds were first appropriated
20	for such project.
21	"(13) A description, if applicable, of all non-
22	Federal sources of funding.
23	"(14) Its current status in the legislative proc-
24	ess, including whether it was carried in any bill or
25	joint resolution (or accompanying report) passed by

1	either House, added in a committee of conference
2	between the Houses (or joint explanatory statement
3	of managers) or in an amendment between the
4	Houses, or included in a bill or joint resolution en-
5	acted into law, including any changes in the final
6	dollar amount.
7	"(c) Accessibility of Data.—The website estab-
8	lished under subsection (a) shall allow the public to—
9	"(1) search, sort, and download all information
10	in the database in a machine-readable format;
11	"(2) ascertain through a single search, by indi-
12	vidual Member of Congress, the total number and
13	dollar value of congressionally directed spending
14	items requested by that Member and the total num-
15	ber and dollar value of such items contained in bills
16	or joint resolutions as passed by either House or en-
17	acted into law by fiscal year;
18	"(3) search and aggregate data based on any
19	category set forth in subsection (b); and
20	"(4) access the website from the home page of
21	the website of the Clerk of the House of Representa-
22	tives and of the Secretary of the Senate.
23	"(d) Timeliness of Data.—(1) Within 5 calendar
24	days of receipt of a request for a congressionally directed

25 spending item from a Member of Congress, each com-

- 1 mittee of the House of Representatives and of the Senate
- 2 shall provide to the Clerk of the House of Representatives
- 3 or the Secretary of the Senate, as applicable, the initial
- 4 information regarding that request that is required under
- 5 this section to be placed on the website established under
- 6 subsection (a). That committee shall provide up-to-date in-
- 7 formation to the Clerk or Secretary, as applicable.
- 8 "(2) The Clerk of the House of Representatives and
- 9 the Secretary of the Senate shall post on the website es-
- 10 tablished under subsection (a) the information received
- 11 under paragraph (1) within 2 calendar days (excluding
- 12 Saturdays, Sundays, or legal holidays except when the
- 13 House or Senate is in session on such a day).
- 14 "(e) Point of Order.—(1) It shall not be in order
- 15 to consider any bill or joint resolution, or amendment
- 16 thereto or conference report thereon unless it meets the
- 17 requirements of this section.
- "
 (2) Subsections (c)(1) and (d)(2) of section 904 of
- 19 the Congressional Budget Act of 1974 are each amended
- 20 by inserting '316, ' after '313, '.
- 21 "(f) Definitions.—As used in this section—
- "(1) the term 'congressionally directed spending
- 23 item' means a provision or report language included
- primarily at the request of a Member of Congress
- providing, authorizing, or recommending a specific

1	amount of discretionary budget authority, credit au-
2	thority, or other spending authority for a contract
3	loan, loan guarantee, grant, loan authority, or other
4	expenditure with or to an entity, or targeted to a
5	specific State, locality, or congressional district
6	other than through a statutory or administrative for-
7	mula-driven or competitive award process; and
8	"(2) the term 'Member of Congress' means a
9	Senator in, a Representative in, or a Delegate or

9 Senator in, a Representative in, or a Delegate or 10 Resident Commissioner to, the Congress.".

11 (b) CONFORMING AMENDMENT.—The table of con-12 tents set forth in section 1(b) of the Congressional Budget 13 and Impoundment Control Act of 1974 is amended by in-14 serting after the item relating to section 315 the following
