## AN ACT

To provide for the conveyance of a small parcel of National Forest System land in the Francis Marion National Forest in South Carolina, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

### SECTION 1. LAND CONVEYANCE, FRANCIS MARION NA-2 TIONAL FOREST, SOUTH CAROLINA. 3 (a) Conveyance Required.—Upon the tender of consideration from the First Baptist Church of Bonneau, 4 5 108 West Church Street, Bonneau, South Carolina (in this section referred to as the "Bonneau Baptist Church"), the Secretary of Agriculture shall sell and quit-8 claim to Bonneau Baptist Church all right, title, and in-9 terest of the United States in and to a parcel of National 10 Forest System land in the Francis Marion National Forest 11 consisting of up to approximately 3 acres, as generally depicted on a map titled, "First Baptist Church of Bonneau 13 Cemetery Tract" and dated May 6, 2010. The conveyance shall be subject to valid existing rights and the other provisions of this section. 15 16 (b) Consideration.— 17 (1) Cash consideration.—As consideration 18 for the conveyance under subsection (a), Bonneau 19 Baptist Church shall pay to the Secretary cash con-20 sideration in an amount equal to the market value 21 of the land. 22 (2) Market value.—The market value of the 23 land conveyed under subsection (a) shall be deter-24 mined by an appraisal approved by the Secretary 25 based on appraisal instructions prescribed by the

Secretary for a separate lot unconnected with a larg-

- 1 er parcel, unencumbered by any permit or restrictive
- 2 covenant (other than the restriction required by sub-
- 3 section (f)), and otherwise in conformity with the
- 4 Uniform Appraisal Standards for Federal Land Ac-
- 5 quisitions.
- 6 (3) Deposit and use of proceeds.—The
- 7 consideration received by the Secretary under this
- 8 subsection shall be deposited into the account in the
- 9 Treasury established by Public Law 90–171 (com-
- monly known as the Sisk Act; 16 U.S.C. 484a). The
- monies so deposited shall be available to the Sec-
- retary, until expended and without further appro-
- priation, for the acquisition of lands and interests in
- land in the Francis Marion National Forest in South
- 15 Carolina.
- 16 (c) Survey.—The land to be conveyed under sub-
- 17 section (a) shall be surveyed, and such survey and result-
- 18 ing land description shall be subject to approval by the
- 19 Secretary.
- 20 (d) Costs.—The Secretary shall require the Bonneau
- 21 Baptist Church to pay all reasonable costs associated with
- 22 the conveyance under subsection (a), including—
- 23 (1) appraisal;
- 24 (2) survey;

- 1 (3) closing costs, including deed recordation;
- 2 and
- 3 (4) any administrative and environmental anal-
- 4 yses required by law or regulation.
- 5 (e) Treatment of Existing Special Use Au-
- 6 THORIZATION.—Upon completion of the conveyance under
- 7 subsection (a), the Special Use Authorization provided to
- 8 Bonneau Baptist Church for use of the conveyed lands
- 9 shall be deemed to be terminated.
- 10 (f) Restriction on Use of Conveyed Land.—
- 11 The deed of conveyance for the land conveyed under sub-
- 12 section (a) shall restrict the use of the conveyed land to
- 13 cemetery purposes. Structures may not be erected on the
- 14 conveyed land, other than for monumentation or cemetery
- 15 maintenance facilities.
- 16 (g) Compliance With Federal Laws and Regu-
- 17 LATIONS.—The conveyance of the land under subsection
- 18 (a) is subject to compliance with existing laws and regula-
- 19 tions.
- 20 (h) Additional Terms and Conditions.—The
- 21 Secretary may require such additional terms and condi-
- 22 tions in connection with the conveyance under subsection
- 23 (a) as the Secretary considers appropriate to protect the
- 24 interests of the United States.

#### 1 SEC. 2. STATUTORY PAY-AS-YOU-GO LANGUAGE.

- 2 The budgetary effects of this Act, for the purpose of
- 3 complying with the Statutory Pay-As-You-Go Act of 2010,
- 4 shall be determined by reference to the latest statement
- 5 titled "Budgetary Effects of PAYGO Legislation" for this
- 6 Act, submitted for printing in the Congressional Record
- 7 by the Chairman of the House Budget Committee, pro-
- 8 vided that such statement has been submitted prior to the
- 9 vote on passage.
