## A BILL

To provide for grants from the Secretary of Education to State and local educational agencies for EnergySmart schools and Energy Star programs.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "School Building En-
- 5 hancement Act".
- 6 SEC. 2. GRANT PROGRAM.
- 7 The Secretary of Education may provide grants—

1	(1) to State educational agencies and local edu-
2	cational agencies for providing intensive technical as-
3	sistance for, and assisting the implementation of, the
4	EnergySmart Schools Program of the Department
5	of Energy and the Energy Star for K-12 School
6	Districts program of the Environmental Protection
7	Agency;
8	(2) to local educational agencies that become
9	partners through the Energy Star for K-12 School
10	Districts program of the Environmental Protection
11	Agency; and
12	(3) to State educational agencies for use in the
13	development of State-level school energy efficiency
14	quality plans, in partnership with the Department of
15	Energy, including—
16	(A) standards for school building design,
17	construction, and renovation; and
18	(B) proposals for the systematic improve-
19	ment (including benchmarks and timelines) of
20	environmental conditions in and around schools
21	throughout the State, including—
22	(i) environmentally preferable pur-
23	chasing of products for instruction and
24	maintenance;

1	(ii) increasing the use of alternative
2	energy fuels in school buses; and
3	(iii) maximization of transportation
4	choices for students, staff, and other mem-
5	bers of the community.
6	SEC. 3. FEDERAL SHARE.
7	The Federal share of the cost of a project or activity
8	carried out using funds from a grant under this Act shall
9	not exceed 90 percent.
10	SEC. 4. GRANT PRIORITY.
11	In providing grants under section 2(1), the Secretary
12	of Education shall give priority to projects to provide as-
13	sistance to school districts that have a demonstrated need
14	for energy efficiency improvement.
15	SEC. 5. DEFINITION.
16	For purposes of this Act, the terms "State edu-
17	cational agency" and "local educational agency" have the
18	meanings given those terms in section 9101 of the Ele-
19	mentary and Secondary Education Act of 1965 (20 U.S.C.
20	7801).
21	SEC. 6. AUTHORIZATION OF APPROPRIATIONS.
22	There are authorized to be appropriated to the Sec-

23 retary of Education to carry out this Act such sums as

- 1 may be necessary for the period encompassing fiscal years
- 2 2009 through 2014.
