AN ACT

To amend title 18, United States Code, to provide penalties for aiming laser pointers at airplanes, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Securing Aircraft
- 3 Cockpits Against Lasers Act of 2010".
- 4 SEC. 2. PROHIBITION AGAINST AIMING A LASER POINTER
- 5 AT AN AIRCRAFT.
- 6 (a) Offense.—Chapter 2 of title 18, United States
- 7 Code, is amended by adding at the end the following:
- 8 "§ 39A. Aiming a laser pointer at an aircraft
- 9 "(a) Whoever knowingly aims the beam of a laser
- 10 pointer at an aircraft in the special aircraft jurisdiction
- 11 of the United States, or at the flight path of such an air-
- 12 craft, shall be fined under this title or imprisoned not
- 13 more than 5 years, or both.
- 14 "(b) As used in this section, the term 'laser pointer'
- 15 means any device designed or used to amplify electro-
- 16 magnetic radiation by stimulated emission that emits a
- 17 beam designed to be used by the operator as a pointer
- 18 or highlighter to indicate, mark, or identify a specific posi-
- 19 tion, place, item, or object.
- 20 "(c) This section does not prohibit aiming a beam
- 21 of a laser pointer at an aircraft, or the flight path of such
- 22 an aircraft, by—
- "(1) an authorized individual in the conduct of
- 24 research and development or flight test operations
- conducted by an aircraft manufacturer, the Federal
- Aviation Administration, or any other person author-

- 1 ized by the Federal Aviation Administration to con-
- 2 duct such research and development or flight test
- 3 operations;
- 4 "(2) members or elements of the Department of
- 5 Defense or Department of Homeland Security acting
- 6 in an official capacity for the purpose of research,
- development, operations, testing or training; or
- 8 "(3) by an individual using a laser emergency
- 9 signaling device to send an emergency distress sig-
- 10 nal.
- 11 "(d) The Attorney General, in consultation with the
- 12 Secretary of Transportation, may provide by regulation,
- 13 after public notice and comment, such additional excep-
- 14 tions to this section, as may be necessary and appropriate.
- 15 The Attorney General shall provide written notification of
- 16 any proposed regulations under this section to the Com-
- 17 mittees on the Judiciary of the House and Senate, the
- 18 Committee on Transportation and Infrastructure in the
- 19 House, and the Committee on Commerce, Science and
- 20 Transportation in the Senate not less than 90 days before
- 21 such regulations become final.".
- 22 (b) CLERICAL AMENDMENT.—The table of sections
- 23 at the beginning of chapter 2 of title 18, United States
- 24 Code, is amended by inserting after the item relating to
- 25 section 39 the following new item:

[&]quot;39A. Aiming a laser pointer at an aircraft.".

1 SEC. 3. COMPLIANCE WITH PAYGO.

- 2 The budgetary effects of this Act, for the purpose of
- 3 complying with the Statutory Pay-As-You-Go Act of 2010,
- 4 shall be determined by reference to the latest statement
- 5 titled "Budgetary Effects of PAYGO Legislation" for this
- 6 Act, submitted for printing in the Congressional Record
- 7 by the Chairman of the Committee on the Budget of the
- 8 House of Representatives, provided that such statement
- 9 has been submitted prior to the vote on passage.
