## A BILL

To amend title II of the Social Security Act to prohibit access of prisoners to Social Security account numbers.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "No Prisoner Access
- 5 to Social Security Numbers Act of 2010".
