A BILL

To amend title XVIII of the Social Security Act to provide for Medicare coverage of comprehensive Alzheimer's disease and other dementia diagnosis and services in order to improve care and outcomes for Americans living with Alzheimer's disease by increasing detection, diagnosis, care, and planning.

- 1 Be it enacted by the Senate and House of Representa-

1 SECTION 1. SHORT TITLE.

2	This Act may be cited as the "HOPE for Alzheimer's:
3	Health Outcomes, Planning, and Education Act".
4	SEC. 2. MEDICARE COVERAGE OF COMPREHENSIVE ALZ-
5	HEIMER'S DISEASE AND OTHER DEMENTIA
6	DIAGNOSIS AND SERVICES.
7	(a) In General.—Section 1861 of the Social Secu-
8	rity Act is amended—
9	(1) in subsection $(s)(2)$ —
10	(A) by striking "and" at the end of sub-
11	paragraph (EE);
12	(B) by adding "and" at the end of sub-
13	paragraph (FF); and
14	(C) by adding at the end the following new
15	subparagraph:
16	"(GG) comprehensive Alzheimer's disease and
17	other dementia diagnosis and services (as defined in
18	subsection (iii));"; and
19	(2) by adding at the end the following new sub-
20	section:
21	"Comprehensive Alzheimer's Disease and Other
22	Dementia Diagnosis and Services
23	"(iii)(1) The term 'comprehensive Alzheimer's disease
24	and other dementia diagnosis and services' means the
25	services described in paragraph (2) furnished to an indi-
26	vidual—

1	"(A) who does not already have a diagnosis of
2	Alzheimer's disease or other dementia; and
3	"(B) for whom there has been a determination
4	by a physician or practitioner (as defined in section
5	1842(b)(18)(C)), in a medical setting such as a phy-
6	sician's office, a skilled nursing facility, a community
7	health center, or another similar setting, that the in-
8	dividual—
9	"(i) may have a cognitive impairment or
10	dementia; and
11	"(ii) has a need for a diagnostic evaluation
12	for Alzheimer's disease or another dementia.
13	"(2) The services described in this paragraph are the
14	following:
15	"(A) A diagnostic evaluation, including referral
16	to a specialist if recommended, in accordance with
17	guidelines specified by the Secretary.
18	"(B) If the individual is diagnosed with Alz-
19	heimer's disease or another dementia under the eval-
20	uation under subparagraph (A), care planning serv-
21	ices (with the individual or with one or more family
22	caregivers of the individual without the presence of
23	the individual), including assistance understanding
24	the diagnosis as well as the medical and non-medical
25	options for ongoing treatment, services, and sup-

- 2 treatments, services, and supports.
- 3 "(C) Medical record documentation, with re-
- 4 spect to an individual, of the diagnostic evaluation
- 5 under subparagraph (A) and any care planning serv-
- 6 ices under subparagraph (B).
- 7 "(3) The Secretary shall establish standards to carry
- 8 out this subsection in consultation with Alzheimer's dis-
- 9 ease and other dementia stakeholders, including patients
- 10 and their advocates, and medical experts in the areas of
- 11 detection, diagnostics, and care planning.".
- 12 (b) Payment.—Section 1833(a)(1) of the Social Se-
- 13 curity Act (42 U.S.C. 1395l(a)(1)) is amended by striking
- 14 "and" before "(X)" and inserting before the semicolon at
- 15 the end the following: ", and (Y) with respect to com-
- 16 prehensive Alzheimer's disease and other dementia diag-
- 17 nosis and services (as defined in section 1861(iii)), the
- 18 amount paid shall be an amount equal to 80 percent of
- 19 the amount determined under a fee schedule established
- 20 by the Secretary'.
- 21 (c) Effective Date.—The amendments made by
- 22 this section shall apply to services furnished on or after
- 23 January 1, 2011.

1	SEC. 3. FEDERAL COORDINATED HEALTH CARE OFFICE
2	STUDY AND REPORT.
3	(a) Study.—The Federal Coordinated Health Care
4	Office (as established under section 2602 of the Patient
5	Protection and Affordable Care Act (42 U.S.C. 1315b))
6	shall conduct a study to identify—
7	(1) barriers to the detection of Alzheimer's dis-
8	ease and other dementias for dual eligible individuals
9	(as defined in subsection (f) of such section 2602);
10	(2) barriers to the furnishing of comprehensive
11	Alzheimer's disease and other dementia diagnosis
12	and services (as defined in section 1866(iii) of the
13	Social Security Act, as added by section 2) to such
14	individuals; and
15	(3) ways to eliminate the barriers described in
16	paragraphs (1) and (2).
17	(b) Report.—Not later than 2 years after the date
18	of the enactment of this Act, the Federal Coordinated
19	Health Care Office shall submit to Congress a report on
20	the study conducted under subsection (a) together with
21	recommendations for such legislation and administrative
22	actions as the Office determines appropriate.
