Murphy of Pennsylvania (for himself and Mr. Reyes) introduced the following bill; which was referred to the Select Committee on Intelligence (Permanent Select), and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned

## A BILL

To enhance the cybersecurity of the United States, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Cybersecurity En-
- 5 hancement Act of 2010".
- 6 SEC. 2. NSA CYBERSECURITY HONORS PILOT PROGRAM.
- 7 (a) Establishment.—The Director of the National
- 8 Security Agency may establish a pilot program to recruit
- 9 highly-skilled persons that are pursing or have obtained

- 1 a graduate degree in a field related to cybersecurity. Such
- 2 pilot program shall be known as the "NSA Cybersecurity
- 3 Honors Program".
- 4 (b) Program.—A pilot program established under
- 5 subsection (a) may provide prospective employees of the
- 6 National Security Agency that are pursuing or have ob-
- 7 tained a graduate degree in a field related to cybersecurity
- 8 with recruitment, retention, and promotion incentives.
- 9 (c) Termination.—A pilot program established
- 10 under subsection (a) shall terminate on the date that is
- 11 five years after the date on which such pilot program is
- 12 established.
- 13 (d) Reports.—Not later than one year after the date
- 14 on which a pilot program is established under subsection
- 15 (a), and annually thereafter until the date that is one year
- 16 after the termination of such pilot program under sub-
- 17 section (c), the Director of the National Security Agency
- 18 shall submit to Congress a report describing the imple-
- 19 mentation of such pilot program, including an assessment
- 20 of the effectiveness of such pilot program and whether
- 21 such pilot program should be permanently authorized.

1	SEC. 3. REPORT ON GUIDELINES AND LEGISLATION TO IM-
2	PROVE CYBERSECURITY OF THE UNITED
3	STATES.
4	(a) Initial.—Not later than one year after the date
5	of the enactment of this Act, the Director of National In-
6	telligence, in consultation with the Attorney General, the
7	Director of the National Security Agency, the White
8	House Cybersecurity Coordinator, and any other officials
9	the Director of National Intelligence considers appro-
10	priate, shall submit to Congress a report containing guide-
11	lines or legislative recommendations, if appropriate, to im-
12	prove the capabilities of the intelligence community and
13	law enforcement agencies to protect the cybersecurity of
14	the United States. Such report shall include guidelines or
15	legislative recommendations on—
16	(1) improving the ability of the intelligence
17	community to detect hostile actions and attribute at-
18	tacks to specific parties;
19	(2) the need for data retention requirements to
20	assist the intelligence community and law enforce-
21	ment agencies;
22	(3) improving the ability of the intelligence
23	community to anticipate nontraditional targets of
24	foreign intelligence services; and
25	(4) the adequacy of existing criminal statutes to
26	successfully deter cyber attacks, including statutes

- 1 criminalizing the facilitation of criminal acts, the
- 2 scope of laws for which a cyber crime constitutes a
- 3 predicate offense, trespassing statutes, data breach
- 4 notification requirements, and victim restitution
- 5 statutes.
- 6 (b) Subsequent.—Not later than one year after the
- 7 date on which the initial report is submitted under sub-
- 8 section (a), and annually thereafter for two years, the Di-
- 9 rector of National Intelligence, in consultation with the
- 10 Attorney General, the Director of the National Security
- 11 Agency, the White House Cybersecurity Coordinator, and
- 12 any other officials the Director of National Intelligence
- 13 considers appropriate, shall submit to Congress an update
- 14 of the report required under subsection (a).
