## A BILL

To amend the Dodd-Frank Wall Street Reform and Consumer Protection Act to repeal the Office of Financial Research.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. REPEAL OF THE OFFICE OF FINANCIAL RE-**  
4       **SEARCH.**

5       (a) IN GENERAL.—Subtitle B of title I of the Dodd-  
6       Frank Wall Street Reform and Consumer Protection Act  
7       is hereby repealed.

8       (b) CONFORMING AMENDMENTS TO THE DODD-  
9       FRANK ACT.—The Dodd-Frank Wall Street Reform and  
10      Consumer Protection Act is amended—

 2 (5);

3 (2) in section 111—

4 (A) in subsection (b)(2)—

5 (i) by striking subparagraph (A); and

6 (ii) by redesignating subparagraphs

 10 paragraphs (C), (D), and (E)” and inserting  
 11 “subparagraphs (B), (C), and (D)”;

14 (i) in subparagraph (A), by striking  
 15 “direct the Office of Financial Research  
 16 to”;

17 (ii) by striking subparagraph (B); and

18 (iii) by redesignating subparagraphs  
 19 (C), (D), (E), (F), (G), (H), (I), (J), (K),  
 20 (L), (M), and (N) as subparagraphs (B),  
 21 (C), (D), (E), (F), (G), (H), (I), (J), (K),  
 22 (L), and (M), respectively; and

23 (B) in subsection (d)—

24 (i) in paragraph (1), by striking “the

1 agencies, and” and inserting “member  
2 agencies and”;

3 (ii) in paragraph (2), by striking “the  
4 Office of Financial Research, any member  
5 agency, and” and inserting “any member  
6 agency and”;

7 (iii) in paragraph (3)—

8 (I) by striking “, acting through  
9 the Office of Financial Research,”  
10 each place it appears; and

11 (II) in subparagraph (B), by  
12 striking “the Office of Financial Re-  
13 search or”; and

14 (iv) in paragraph (5)(A), by striking  
15 “, the Office of Financial Research,”;

16 (4) in section 116, by striking “, acting through  
17 the Office of Financial Research,” each place it ap-  
18 pears; and

19 (5) by striking section 118.

20 (c) CONFORMING AMENDMENT TO THE PAPERWORK  
21 REDUCTION ACT.—Section 2(5) of the Paperwork Reduc-  
22 tion Act is amended by striking “the Office of Financial  
23 Research,”.

1       (d) TECHNICAL AMENDMENTS.—The table of con-  
2 tents for the Dodd-Frank Wall Street Reform and Con-  
3 sumer Protection Act is amended—

4           (1) by striking the item relating to section 118;

6           (2) by striking the items relating to subtitle B  
7       of title I.
