## A BILL

4	(a) Adjustment of Deadline for Collection.—
5	Section 103A(b)(3)(A) of the Uniformed and Overseas
6	Citizens Absentee Voting Act (42 U.S.C. 1973ff—
7	2a(b)(3)(A)) is amended by striking "on the seventh day"
8	and inserting the following: "on the last Friday (or, in
9	the case of an election occurring prior to the regularly
10	scheduled general election for Federal office held in No-
11	vember 2012, on the seventh day)".
12	(b) Use of Carriers.—Section $103A(b)(2)$ of such
13	Act (42 U.S.C. 1973ff—2a(b)(2)) is amended to read as
14	follows:
15	"(2) Expedited delivery service.—
16	"(A) In General.—The Presidential des-
17	ignee shall provide expedited mail delivery serv-
18	ice for all such marked absentee ballots of ab-
19	sent uniformed services voters that are collected
20	on or before the deadline described in para-

22	"(B) AGREEMENTS WITH POSTAL SERVICE
23	FOR ELECTIONS PRIOR TO 2012.—With respect
24	to elections occurring prior to the regularly
25	scheduled general election for Federal office
26	held in November 2012, the Presidential des-

ignee shall carry out this section in cooperation and coordination with the United States Postal Service, and shall provide expedited mail delivery service for all such marked absentee ballots of absent uniformed services voters that are collected on or before the deadline described in paragraph (3) and then transferred to the United States Postal Service."
