**AN ACT**

To provide for the conveyance of parcels of land to Mantua,  
Box Elder County, Utah.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Box Elder Utah Land  
5       Conveyance Act”.

1 **SEC. 2. CONVEYANCE OF CERTAIN LANDS TO MANTUA, BOX**  
2 **ELDER, UTAH.**

3 (a) CONVEYANCE REQUIRED.—The Secretary of Ag-  
4 riculture shall convey, without consideration, to the town  
5 of Mantua, Utah (in this section referred to as the  
6 “town”), all right, title, and interest of the United States  
7 in and to parcels of National Forest System land in the  
8 Wasatch-Cache National Forest in Box Elder County,  
9 Utah, consisting of approximately 31.5 acres within sec-  
10 tion 27, township 9 north, range 1 west, Salt Lake merid-  
11 ian and labeled as parcels A, B, and C on the map entitled  
12 “Box Elder Utah Land Conveyance Act” and dated July  
13 14, 2008.

14 (b) SURVEY.—If necessary, the exact acreage and  
15 legal description of the lands to be conveyed under sub-  
16 section (a) shall be determined by a survey satisfactory  
17 to the Secretary. The cost of the survey shall be borne  
18 by the town.

19 (c) USE OF LAND.—As a condition of the conveyance  
20 under subsection (a), the town shall use the land conveyed  
21 under such subsection for public purposes.

22 (d) REVERSIONARY INTEREST.—In the quitclaim  
23 deed to the town prepared as part of the conveyance under  
24 subsection (a), the Secretary shall provide that the land  
25 conveyed to the town under such subsection shall revert

1 to the Secretary, at the election of the Secretary, if the  
2 land is used for other than public purposes.

3 (e) ADDITIONAL TERMS AND CONDITIONS.—The  
4 Secretary may require such additional terms and condi-  
5 tions in connection with the conveyance authorized under  
6 subsection (a) as the Secretary considers appropriate to  
7 protect the interests of the United States.
