# A BILL

To improve the Federal contracting process with respect to veterans, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Veteran-Owned Small
- 5 Business Contracting Fairness Act of 2010".
- 6 SEC. 2. PARITY IN SMALL BUSINESS SET-ASIDES.
- 7 Section 31(b)(2)(B) of the Small Business Act (15
- 8 U.S.C. 657a(b)(2)(B)) is amended by striking "shall" and
- 9 inserting "may".

#### 1 SEC. 3. VERIFICATION OF VETERAN-OWNED BUSINESSES.

- 2 (a) IN GENERAL.—Section 8127(f) of title 38, United
- 3 States Code, is amended—
- 4 (1) in paragraph (1) by striking "through (6)"
- 5 and inserting "through (7)"; and
- 6 (2) by adding at the end the following:
- 7 "(7) A business concern may not be included in the
- 8 database until the Secretary verifies that the concern is
- 9 a small business concern owned and controlled by veterans
- 10 or a small business concern owned and controlled by serv-
- 11 ice-disabled veterans.".
- 12 (b) Procurement Program for Small Business
- 13 CONCERNS OWNED AND CONTROLLED BY SERVICE-DIS-
- 14 ABLED VETERANS.—
- 15 (1) IN GENERAL.—Section 36 of the Small
- Business Act (15 U.S.C. 657f) is amended by add-
- ing at the end the following:
- 18 "(f) Verification.—A business concern may not
- 19 participate in the program under this section unless such
- 20 concern is included as a small business concern owned and
- 21 controlled by service-disabled veterans in the database
- 22 maintained by the Secretary of Veterans Affairs pursuant
- 23 to section 8127(f) of title 38, United States Code.".
- 24 (2) Effective date.—The amendment in
- paragraph (1) shall take effect on the date that is
- 26 60 days after the date of enactment of this Act.

8	controlled by service-disabled veterans'," before "or
9	a 'small business concern owned and controlled by
10	women'"; and
11	(2) in subparagraph (A) by striking "or 31"
12	and inserting "31, or 36".
