1 Be it enacted by the Senate and House of Representa-

2 tives of the United States of America in Congress assembled,

#### **3** SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Smithsonian Institu-5 tion Facilities Authorization Act of 2009".

6 SEC. 2. LABORATORY AND SUPPORT SPACE, EDGEWATER,
7 MARYLAND.

8 (a) AUTHORITY TO DESIGN AND CONSTRUCT.—The 9 Board of Regents of the Smithsonian Institution is au-10 thorized to design and construct laboratory and support 11 space to accommodate the Mathias Laboratory at the 12 Smithsonian Environmental Research Center in Edge-13 water, Maryland.

(b) AUTHORIZATION OF APPROPRIATIONS.—There is
authorized to be appropriated to carry out this section a
total of \$41,000,000 for fiscal years 2009 through 2011.
Such sums shall remain available until expended.

#### 18 SEC. 3. LABORATORY SPACE, GAMBOA, PANAMA.

(a) AUTHORITY TO CONSTRUCT.—The Board of Re20 gents of the Smithsonian Institution is authorized to con21 struct laboratory space to accommodate the terrestrial re-

search program of the Smithsonian tropical research insti tute in Gamboa, Panama.

3 (b) AUTHORIZATION OF APPROPRIATIONS.—There is
4 authorized to be appropriated to carry out this section a
5 total of \$14,000,000 for fiscal years 2009 and 2010. Such
6 sums shall remain available until expended.

#### 7 SEC. 4. GREENHOUSE FACILITY, SUITLAND, MARYLAND.

8 (a) AUTHORITY TO CONSTRUCT.—The Board of Re-9 gents of the Smithsonian Institution is authorized to con-10 struct a greenhouse facility at its museum support facility 11 in Suitland, Maryland, to maintain the horticultural oper-12 ations of, and preserve the orchid collection held in trust 13 by, the Smithsonian Institution.

(b) AUTHORIZATION OF APPROPRIATIONS.—There is
authorized to be appropriated \$12,000,000 to carry out
this section. Such sums shall remain available until expended.
