Mr. WALZ (for himself, Mr. MILLER of Florida, Mr. BILIRAKIS, and Mr. PASCRELL) introduced the following bill; which was referred to the Committee on Veterans' Affairs

A BILL

To amend title 38, United States Code, to improve the provision of rehabilitative services for veterans with traumatic brain injury, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Veterans’ Traumatic
5 Brain Injury Rehabilitative Services’ Improvements Act of
6 2010”.

1 **SEC. 2. REHABILITATIVE SERVICES FOR VETERANS WITH**
2 **TRAUMATIC BRAIN INJURY.**

3 (a) REHABILITATION PLANS AND SERVICES.—Sec-
4 tion 1710C of title 38, United States Code, is amended—

5 (1) in subsection (a)(1), by inserting before the
6 semicolon the following: “with the goal of maxi-
7 mizing the individual’s independence and quality of
8 life”;

9 (2) in subsection (b)—

10 (A) in paragraph (1)—

11 (i) by inserting after “improving” the
12 following: “(and sustaining improvement
13 in)”;

14 (ii) by inserting “behavioral,” after
15 “cognitive”;

16 (iii) by inserting “and mental health”
17 after “functioning”; and

18 (iv) by inserting “, quality of life,”
19 after “independence”;

20 (B) in paragraph (2), by inserting “reha-
21 bilitative services and” before “rehabilitative
22 components”; and

23 (C) in paragraph (3)—

24 (i) by striking “treatments” the first
25 place it appears and inserting “services”;
26 and

1 (ii) by striking “treatments and” the
2 second place it appears; and

3 (3) by adding at the end the following new sub-
4 section:

5 “(h) For purposes of this section, and sections 1710D
6 and 1710E of this title, the term ‘rehabilitative services’
7 includes—

8 “(1) rehabilitative services, as defined in section
9 1701(8) of this title;

10 “(2) services (which may be of ongoing dura-
11 tion) to sustain, and prevent loss of, functional gains
12 that have been achieved; and

13 “(3) any other services or supports that may
14 contribute to maximizing an individual’s independ-
15 ence and quality of life.”

16 (b) PROGRAM.—Section 1710D(a) of title 38, United
17 States Code, is amended—

18 (1) by inserting “and rehabilitative services”
19 after “long-term care”; and

20 (2) by striking “treatment”.

21 (c) COOPERATIVE AGREEMENTS.—Section 1710E(a)
22 of title 38, United States Code, is amended by inserting
23 “, including rehabilitative services,” after “medical serv-
24 ices”.
