## A BILL

To direct the Secretary of the Army to seek to enter into certain contracts regarding the self-protective adaptive roller kit II system.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SELF-PROTECTIVE ADAPTIVE ROLLER KIT II**  
4       **SYSTEM.**

5       (a) PURCHASE OR LEASE OF TECHNICAL DATA  
6       PACKAGE.—Not later than 10 days after the date of the  
7       enactment of this Act, and in accordance with subsection  
8       (b)(2), the Secretary of the Army shall seek to enter into  
9       a contract with Pearson Engineering Limited of New-  
10      castle, the United Kingdom, for the purchase or unlimited

1 lease of the self-protective adaptive roller kit II system  
2 technical data package.

3 (b) PROCUREMENT OF SYSTEM.—

4 (1) PRODUCTION.—Not later than three days  
5 after the date on which the Secretary enters into a  
6 contract under subsection (a), the Secretary shall  
7 seek to enter into contracts with any domestic man-  
8 ufacturer with capacity to produce the self-protective  
9 adaptive roller kit II system for the production of  
10 such system.

11 (2) TERMINATION OF TECHNICAL DATA PACK-  
12 AGE CONTRACT.—If no contract is entered into  
13 under paragraph (1) by the date that is 30 days  
14 after the date on which the Secretary enters into a  
15 contract under subsection (a), the Secretary shall  
16 terminate the contract entered into under subsection  
17 (a).

18 (c) PANAMA CITY GENERATION THREE.—

19 (1) FAILURE TO ENTER INTO TECHNICAL DATA  
20 PACKAGE CONTRACT.—If no contract is entered into  
21 under subsection (a) by the date that is 30 days  
22 after the date of the enactment of this Act, the Sec-  
23 retary of the Army shall coordinate with the Sec-  
24 retary of the Navy to procure the Panama City Gen-  
25 eration Three roller system.

1           (2) FAILURE TO ENTER INTO PRODUCTION  
2       CONTRACT.—If no contract is entered into under  
3       subsection (b)(1) by the date that is 30 days after  
4       the date on which the Secretary enters into a con-  
5       tract under subsection (a), the Secretary of the  
6       Army shall coordinate with the Secretary of the  
7       Navy to procure the Panama City Generation Three  
8       roller system.

9       (d) SELF-PROTECTIVE ADAPTIVE ROLLER KIT II  
10   SYSTEM TECHNICAL DATA PACKAGE DEFINED.—In this  
11   section, the term “self-protective adaptive roller kit II sys-  
12   tem technical data package” means the technical draw-  
13   ings, specifications, and other engineering data necessary  
14   for the production of the self-protective adaptive roller kit  
15   II system.
