## A BILL

To direct the Administrator of the Small Business Administration to establish a loan guarantee program to assist small business concerns that manufacture clean energy technologies in the United States, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Small Business Clean  
5       Energy Financing Act of 2010”.

1 **SEC. 2. CLEAN ENERGY TECHNOLOGY LOAN GUARANTEE**  
2 **PROGRAM.**

3 (a) ESTABLISHMENT.—The Administrator of the  
4 Small Business Administration shall establish a program  
5 under which the Administrator is authorized to guarantee  
6 the loans of small business concerns that manufacture a  
7 clean energy technology in the United States.

8 (b) ADMINISTRATION.—Except as otherwise specified  
9 in this section and to the extent practicable, the Adminis-  
10 trator shall carry out the program under subsection (a)  
11 in a manner similar to the loan program under section  
12 7(a) of the Small Business Act (15 U.S.C. 636(a)).

13 (c) DEFINITIONS.—In this section, the following defi-  
14 nitions apply:

15 (1) CLEAN ENERGY TECHNOLOGY.—The term  
16 “clean energy technology” means a technology re-  
17 lated to the production, use, transmission, storage,  
18 control, or conservation of energy that will con-  
19 tribute to a stabilization of atmospheric greenhouse  
20 gas concentrations through reduction, avoidance, or  
21 sequestration of energy-related emissions and—

22 (A) reduce the need for additional energy  
23 supplies by using existing energy supplies with  
24 greater efficiency or by transmitting, distrib-  
25 uting, or transporting energy with greater effec-

1           tiveness through the infrastructure of the  
2           United States; or

3           (B) diversify the sources of the energy sup-  
4           ply of the United States to strengthen energy  
5           security and to increase supplies with a favor-  
6           able balance of environmental effects if the en-  
7           tire technology system is considered.

8           (2) SMALL BUSINESS CONCERN.—The term  
9           “small business concern” has the meaning given  
10          that term under section 3(a) of the Small Business  
11          Act (15 U.S.C. 632(a)).
