#### 1 SECTION 1. PERSONS ELIGIBLE FOR INTERMENT IN NA-

- 2 TIONAL CEMETERIES.
- 3 (a) In General.—Section 2402 of title 38, United
- 4 States Code, is amended by adding at the end the fol-
- 5 lowing new paragraph:
- 6 "(9) Subject to section 5303A(b)(4) of this title, any
- 7 member of a reserve component of the Armed Forces, and
- 8 any member of the Army National Guard or the Air Na-
- 9 tional Guard, who performed a period of active duty for
- 10 training and was discharged or released from such period
- 11 of active duty for training under conditions that were
- 12 other than dishonorable.".
- 13 (b) MINIMUM SERVICE REQUIREMENTS FOR CER-
- 14 TAIN INDIVIDUALS.—Section 5303A(b) of title 38, United
- 15 States Code, is amended by adding at the end the fol-
- 16 lowing new paragraph:
- 17 "(4) For purposes of section 2402(9) of this title, the
- 18 minimum active duty service requirements under this sub-
- 19 section shall apply to a period of active duty for training
- 20 in the same manner that such requirements apply to a
- 21 period of active duty.".
- 22 SEC. 2. BURIAL AND FUNERAL EXPENSES OF CERTAIN VET-
- ERANS.
- 24 (a) In General.—Section 2302(a) of title 38,
- 25 United States Code, is amended by striking "\$300" and
- 26 inserting "\$500".

- 1 (b) Death in Department Facility; Plot Al-
- 2 LOWANCE.—Section 2303 of title 38, United States Code,
- 3 is amended by striking "\$300" each place it appears and
- 4 inserting "\$500".
- 5 SEC. 3. EFFECTIVE DATE.
- 6 The amendments made by this Act shall apply with
- 7 respect to deaths occurring on or after the date of the
- 8 enactment of this Act.
