## A BILL

To amend title 10, United States Code, to provide for greater transparency in the conversion of Department of Defense functions previously performed by contractors to performance by Department of Defense employees, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1	SECTION 1. TRANSPARENCY IN CONVERSION OF FUNC-
2	TIONS TO PERFORMANCE BY DEPARTMENT
3	OF DEFENSE CIVILIAN EMPLOYEES.
4	(a) In General.—Chapter 146 of title 10, United
5	States Code, is amended by adding at the end the fol-
6	lowing new section:
7	"§ 2477. Transparency in conversion of functions to
8	performance by Department of Defense
9	civilian employees
10	"(a) Provision of Information.—The Secretary
11	of Defense shall submit to Congress and make publicly
12	available on an Internet Web site the following informa-
13	tion:
14	"(1) The total number of jobs, performed by
15	both Department of Defense civilian employees and
16	contractors, in each State and at each military in-
17	stallation.
18	"(2) The total number of Department of De-
19	fense functions converted from performance by con-
20	tractors to performance by Department of Defense
21	civilian employees in each State and at each military
22	installation, and the task area of each such function.
23	"(b) Cost of Performance Comparisons.—The
24	Secretary of Defense shall make publicly available the
25	comparison of the cost of performance of each Department
26	of Defense function that is converted from performance

- 2 civilian employees.
- 3 "(c) Small Business Concern Appeal Proce-
- 4 Dure.—Any small business concern (under the meaning
- 5 given that term in section 3 of the Small Business Act
- 6 (15 U.S.C. 632)) that performs a Department of Defense
- 7 function that is converted to performance by Department
- 8 of Defense civilian employees and that by reason of such
- 9 conversion loses 33 percent or more of the revenue gen-
- 10 erated by the concern through contracts or 33 percent or
- 11 more of the employees of the concern may appeal the con-
- 12 version of the function to the Inspector General of the
- 13 military department concerned or to the Secretary of De-
- 14 fense.".
- 15 (b) Clerical Amendment.—The table of sections
- 16 at the beginning of such chapter is amended by adding
- 17 at the end the following new item:

"2477. Transparency in conversion of functions to performance by Department of Defense civilian employees.".
