## A BILL

To amend title 10, United States Code, to codify the Military Spouse Career Advancement Account program (MyCAA) conducted by the Department of Defense to assist spouses of members of the Armed Forces serving on active duty to pursue educational opportunities and career training, to ensure that such educational opportunities and training are available to all military spouses, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- This Act may be cited as the "MyCAA Act".

1	SEC. 2. MILITARY SPOUSE CAREER ADVANCEMENT AC-
2	COUNT PROGRAM (MYCAA).
3	(a) Codification of MyCAA Program.—Sub-
4	section (a) of section 1784a of title 10, United States
5	Code, is amended by adding at the end the following new
6	paragraph:
7	"(3)(A) As one of the programs established under
8	this section to assist spouses of members of the armed
9	forces, the Secretary shall continue to carry out the Mili-
10	tary Spouse Career Advancement Account (MyCAA) pro-
11	gram, under which an eligible spouse may receive up to
12	\$6,000 in tuition assistance for education and training
13	courses and licensing and credentialing fees.
14	"(B) Financial assistance provided under the MyCAA
15	program shall be available to cover the costs of the fol-
16	lowing:
17	"(i) State certifications for teachers, medical
18	professionals, and other occupations requiring recog-
19	nized certifications.
20	"(ii) Licensing exams and related preparation
21	courses.
22	"(iii) Continuing education classes, including
23	classes offered through professional associations.
24	"(iv) Degree programs, including programs at
25	four-year colleges and universities, leading to em-
26	ployment in portable careers.

- 1 "(v) Secondary education completion courses,
- 2 GED tests, and English as a Second Language
- 3 (ESL) classes.
- 4 "(C) Financial assistance provided under the MyCAA
- 5 program may not be used to pay for computers, applica-
- 6 tion, graduation or membership fees, student activity
- 7 cards, child care, parking, transportation, or medical serv-
- 8 ices.
- 9 "(D) An eligible spouse must obtain an approved
- 10 MyCAA Financial Assistance document before incurring
- 11 the tuition fees for which payment under the program is
- 12 sought. The MyCAA program does not provide reimburse-
- 13 ments of any kind to spouses for any reason. Once the
- 14 eligible spouse obtains the MyCAA Financial Assistance
- 15 document, there is no deadline before which the spouse
- 16 must complete the education or training courses for which
- 17 assistance is sought under the program.".
- 18 (b) Guarantee of Education and Training Op-
- 19 PORTUNITIES FOR MILITARY SPOUSES.—Subsection
- 20 (a)(1) of such section is amended by striking "may estab-
- 21 lish" and inserting "shall establish".
- (c) Eligible Military Spouses.—Subsection (b)
- 23 of such section is amended—
- 24 (1) by inserting "(1)" before "Assistance"; and

- 1 (2) by adding at the end the following new 2 paragraph:
- 3 "(2) The Secretary of Defense may not restrict par-
- 4 ticipation in the MyCAA program required by subsection
- 5 (a)(3) to the spouses of members serving in particular
- 6 grades. Instead, subject to the availability of funds for the
- 7 MyCAA program, the Secretary shall make the MyCAA
- 8 program available to all eligible spouses.".
