## A BILL

To provide a biennial budget for the United States Government.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Biennial Budgeting  
5 and Appropriations Act of 2010”.

6 **SEC. 2. REVISION OF TIMETABLE.**

7 Section 300 of the Congressional Budget Act of 1974  
8 (2 U.S.C. 631) is amended to read as follows:

## 1 “TIMETABLE

2 “SEC. 300. (a) IN GENERAL.—Except as provided by  
 3 subsection (b), the timetable with respect to the congres-  
 4 sional budget process for any Congress (beginning with  
 5 the One Hundred Fourteenth Congress) is as follows:

## “First Session

On or before:	Action to be completed:
First Monday in February .....	President submits budget rec- ommendations.
February 15 .....	Congressional Budget Office submits report to Budget Committees.
Not later than 6 weeks after budget submission.	Committees submit views and esti- mates to Budget Committees.
April 1 .....	Budget Committees report concurrent resolution on the biennial budget.
May 15 .....	Congress completes action on concur- rent resolution on the biennial bud- get.
May 15 .....	Biennial appropriation bills may be considered in the House.
June 10 .....	House Appropriations Committee re- ports last biennial appropriation bill.
June 30 .....	House completes action on biennial appropriation bills.
October 1 .....	Biennium begins.

## Second Session

On or before:	Action to be completed:
February 15 .....	President submits budget review.

The last day of the session .....	Congress completes action on bills and resolutions authorizing new budget authority for the succeeding bien- nium.

6 “(b) SPECIAL RULE.—In the case of any first session  
 7 of Congress that begins in any year during which the term  
 8 of a President (except a President who succeeds himself)  
 9 begins, the following dates shall supersede those set forth  
 10 in subsection (a):

4 Congressional Budget and Impoundment Control Act of  
5 1974 (2 U.S.C. 621(2)) is amended by striking “each  
6 year” and inserting “biennially”.

7 (b) DEFINITIONS.—

8 (1) BUDGET RESOLUTION.—Section 3(4) of  
9 such Act (2 U.S.C. 622(4)) is amended by striking  
10 “fiscal year” each place it appears and inserting “bi-  
11 ennium”.

15 “(11) The term ‘biennium’ means the period of  
16 2 consecutive fiscal years beginning on October 1 of

18 ticable after the completion of each quarter of the fiscal  
19 year, prepare an analysis comparing revenues, spending,  
20 and the deficit or surplus for the current fiscal year to  
21 assumptions included in the congressional budget resolu-  
22 tion. In preparing this report, the Director of the Congres-  
23 sional Budget Office shall combine actual budget figures  
24 to date with projected revenue and spending for the bal-  
25 ance of the fiscal year. The Director of the Congressional

1 Budget Office shall include any other information in this  
2 report that it deems useful for a full understanding of the  
3 current fiscal position of the Federal Government. The re-  
4 ports mandated by this subsection shall be transmitted by  
5 the Director to the Senate and House Committees on the  
6 Budget, and the Congressional Budget Office shall make  
7 such reports available to any interested party upon re-  
8 quest.”.

9 (j) COMPLETION OF HOUSE ACTION ON REGULAR  
10 APPROPRIATION BILLS.—Section 309 of such Act (2  
11 U.S.C. 640) is amended—

12 (1) by striking “It” and inserting “Except  
13 whenever section 300(b) is applicable, it”;

15 year” after “July”;

11 (2) striking “year before the year in which the  
12 fiscal year begins” and inserting “calendar year pre-  
13 ceding the calendar year in which the biennium be-  
14 gins”.

15 **SEC. 6. TWO-YEAR APPROPRIATIONS; TITLE AND STYLE OF**  
16 **APPROPRIATIONS ACTS.**

17 Section 105 of title 1, United States Code, is amend-  
18 ed to read as follows:

19 **“§ 105. Title and style of appropriations Acts**

20 “(a) The style and title of all Acts making appropria-  
21 tions for the support of the Government shall be as fol-  
22 lows: ‘An Act making appropriations (here insert the ob-  
23 ject) for each fiscal year in the biennium of fiscal years  
24 (here insert the fiscal years of the biennium).’.

1       “(b) All Acts making regular appropriations for the  
2 support of the Government shall be enacted for a biennium  
3 and shall specify the amount of appropriations provided  
4 for each fiscal year in such period.

5       “(c) For purposes of this section, the term ‘biennium’  
6 has the same meaning as in section 3(11) of the Congres-  
7 sional Budget and Impoundment Control Act of 1974 (2  
8 U.S.C. 622(11)).”.

9       **SEC. 7. MULTIYEAR AUTHORIZATIONS.**

10       (a) IN GENERAL.—Title III of the Congressional  
11 Budget Act of 1974 is amended by adding at the end the  
12 following new section:

13       “MULTIYEAR AUTHORIZATIONS OF APPROPRIATIONS

14       “SEC. 316. (a) POINT OF ORDER.—(1)(A) It shall  
15 not be in order in the House of Representatives or the  
16 Senate to consider any measure that contains a specific  
17 authorization of appropriations for any purpose unless the  
18 measure includes such a specific authorization of appro-  
19 priations for that purpose for not less than each fiscal year  
20 in one or more bienniums.

21       “(B) For purposes of this paragraph, a specific au-  
22 thorization of appropriations is an authorization for the  
23 enactment of an amount of appropriations or amounts not  
24 to exceed an amount of appropriations (whether stated as  
25 a sum certain, as a limit, or as such sums as may be nec-  
26 essary) for any purpose for a fiscal year.

1       “(2) Paragraph (1) does not apply with respect to  
 2 an authorization of appropriations for a single fiscal year  
 3 for any program, project, or activity if the measure con-  
 4 taining that authorization includes a provision expressly  
 5 stating the following: ‘Congress finds that no authoriza-  
 6 tion of appropriation will be required for [Insert name of  
 7 applicable program, project, or activity] for any subse-  
 8 quent fiscal year.’.

9       “(3) For purposes of this subsection, the term ‘meas-  
 10 ure’ means a bill, joint resolution, amendment, motion, or  
 11 conference report.”.

12       (b) AMENDMENT TO TABLE OF CONTENTS.—The  
 13 table of contents set forth in section 1(b) of the Congres-  
 14 sional Budget and Impoundment Control Act of 1974 is  
 15 amended by adding after the item relating to section 315  
 16 the following new item:

“Sec. 316. Multiyear authorizations of appropriations.”.

17 **SEC. 8. GOVERNMENT STRATEGIC AND PERFORMANCE**  
 18 **PLANS ON A BIENNIAL BASIS.**

19       (a) STRATEGIC PLANS.—Section 306 of title 5,  
 20 United States Code, is amended—

21           (1) in subsection (a), by striking “September  
 22 30, 1997” and inserting “September 30, 2014”;

23           (2) in subsection (b)—

24                   (A) by striking “at least every three years”  
 25 and inserting “at least every 4 years”; and

1 (B) by striking “five years forward” and  
2 inserting “six years forward”; and

3 (3) in subsection (c), by inserting a comma  
4 after “section” the second place it appears and add-  
5 ing “including a strategic plan submitted by Sep-  
6 tember 30, 2014, meeting the requirements of sub-  
7 section (a)”.

8 (b) BUDGET CONTENTS AND SUBMISSION TO CON-  
9 GRESS.—Paragraph (28) of section 1105(a) of title 31,  
10 United States Code, is amended by striking “beginning  
11 with fiscal year 1999, a” and inserting “beginning with  
12 fiscal year 2016, a biennial”.

13 (c) PERFORMANCE PLANS.—Section 1115 of title 31,  
14 United States Code, is amended—

15 (1) in subsection (a)—

16 (A) in the matter before paragraph (1) by  
17 striking “an annual” and inserting “a bien-  
18 nial”;

19 (B) in paragraph (1) by inserting after  
20 “program activity” the following: “for both  
21 years 1 and 2 of the biennial plan”;

22 (C) in paragraph (5) by striking “and”  
23 after the semicolon;

1 (D) in paragraph (6) by striking the period  
2 and inserting a semicolon; and inserting “and”  
3 after the inserted semicolon; and

4 (E) by adding after paragraph (6) the fol-  
5 lowing:

6 “(7) cover each fiscal year of the biennium be-  
7 ginning with the first fiscal year of the next biennial  
8 budget cycle.”;

9 (2) in subsection (d) by striking “annual” and  
10 inserting “biennial”; and

11 (3) in paragraph (6) of subsection (f) by strik-  
12 ing “annual” and inserting “biennial”.

13 (d) MANAGERIAL ACCOUNTABILITY AND FLEXI-  
14 BILITY.—Section 9703 of title 31, United States Code, re-  
15 lating to managerial accountability, is amended—

16 (1) in subsection (a)—

17 (A) in the first sentence by striking “Be-  
18 ginning with fiscal year 1999, the” and insert-  
19 ing “Beginning with fiscal year 2016, the bien-  
20 nial” and by striking “annual”; and

21 (B) by striking “section 1105(a)(29)” and  
22 inserting “section 1105(a)(28)”;

23 (2) in subsection (e)—

24 (A) in the first sentence by striking “one  
25 or” before “years”;

1 (B) in the second sentence by striking “a  
2 subsequent year” and inserting “for a subse-  
3 quent 2-year period”; and

4 (C) in the third sentence by striking  
5 “three” and inserting “four”.

6 (e) PILOT PROJECTS FOR PERFORMANCE BUDG-  
7 ETING.—Section 1119 of title 31, United States Code, is  
8 amended—

9 (1) in paragraph (1) of subsection (d), by strik-  
10 ing “annual” and inserting “biennial”; and

11 (2) in subsection (e), by striking “annual” and  
12 inserting “biennial”.

13 (f) STRATEGIC PLANS.—Section 2802 of title 39,  
14 United States Code, is amended—

15 (1) in subsection (a), by striking “September  
16 30, 1997” and inserting “September 30, 2014”;

17 (2) in subsection (b), by striking “at least every  
18 three years” and inserting “at least every 4 years”;

19 (3) by striking “five years forward” and insert-  
20 ing “six years forward”; and

21 (4) in subsection (c), by inserting a comma  
22 after “section” the second place it appears and in-  
23 serting “including a strategic plan submitted by  
24 September 30, 2014, meeting the requirements of  
25 subsection (a)”.

1 (g) PERFORMANCE PLANS.—Section 2803(a) of title  
2 39, United States Code, is amended—

3 (1) in the matter before paragraph (1), by  
4 striking “an annual” and inserting “a biennial”;

5 (2) in paragraph (1), by inserting after “pro-  
6 gram activity” the following: “for both years 1 and  
7 2 of the biennial plan”;

8 (3) in paragraph (5), by striking “and” after  
9 the semicolon;

10 (4) in paragraph (6), by striking the period and  
11 inserting “; and”; and

12 (5) by adding after paragraph (6) the following:

13 “(7) cover each fiscal year of the biennium be-  
14 ginning with the first fiscal year of the next biennial  
15 budget cycle.”.

16 (h) COMMITTEE VIEWS OF PLANS AND REPORTS.—

17 Section 301(d) of the Congressional Budget Act (2 U.S.C.

18 632(d)) is amended by adding at the end “Each committee

19 of the Senate or the House of Representatives shall review

20 the strategic plans, performance plans, and performance

21 reports, required under section 306 of title 5, United

22 States Code, and sections 1115 and 1116 of title 31,

23 United States Code, of all agencies under the jurisdiction

24 of the committee. Each committee may provide its views

1 on such plans or reports to the Committee on the Budget  
2 of the applicable House.”.

3 (i) EFFECTIVE DATE.—

4 (1) IN GENERAL.—The amendments made by  
5 this section shall take effect on September 30, 2014.

6 (2) AGENCY ACTIONS.—Effective on and after  
7 the date of enactment of this Act, each agency shall  
8 take such actions as necessary to prepare and sub-  
9 mit any plan or report in accordance with the  
10 amendments made by it.

11 **SEC. 9. BIENNIAL APPROPRIATION BILLS.**

12 (a) IN THE HOUSE OF REPRESENTATIVES.—(1)  
13 Clause 2(a) of rule XXI of the Rules of the House of Rep-  
14 resentatives is amended by adding at the end the following  
15 new subparagraph:

16 “(3)(A) Except as provided by subdivision (B), an ap-  
17 propriation may not be reported in a general appropriation  
18 bill (other than a supplemental appropriation bill), and  
19 may not be in order as an amendment thereto, unless it  
20 provides new budget authority or establishes a level of ob-  
21 ligations under contract authority for each fiscal year of  
22 a biennium.

23 “(B) Subdivision (A) does not apply with respect to  
24 an appropriation for a single fiscal year for any program,  
25 project, or activity if the bill or amendment thereto con-

1 taining that appropriation includes a provision expressly  
2 stating the following: ‘Congress finds that no additional  
3 funding beyond one fiscal year will be required and the  
4 [Insert name of applicable program, project, or activity]  
5 will be completed or terminated after the amount provided  
6 has been expended.’.

7 “(C) For purposes of paragraph (b), the statement  
8 set forth in subdivision (B) with respect to an appropria-  
9 tion for a single fiscal year for any program, project, or  
10 activity may be included in a general appropriation bill  
11 or amendment thereto.”.

12 (2) Clause 5(b)(1) of rule XXII of the House of Rep-  
13 resentatives is amended by striking “or (c)” and inserting  
14 “or (3) or 2(c)”.

15 (b) IN THE SENATE.—(1) Title III of the Congres-  
16 sional Budget Act of 1974 (2 U.S.C. 631 et seq.) is  
17 amended by adding at the end the following:

18 “CONSIDERATION OF BIENNIAL APPROPRIATION BILLS  
19 “SEC. 317. It shall not be in order in the Senate in  
20 any odd-numbered year to consider any regular appropria-  
21 tion bill providing new budget authority or a limitation  
22 on obligations under the jurisdiction of the Committee on  
23 Appropriations for only the first fiscal year of a biennium,  
24 unless the program, project, or activity for which the new  
25 budget authority or obligation limitation is provided will  
26 require no additional authority beyond one year and will

1 be completed or terminated after the amount provided has  
2 been expended.”.

3 (2) The table of contents set forth in section 1(b) of  
4 the Congressional Budget and Impoundment Control Act  
5 of 1974 is amended by adding after the item relating to  
6 section 316 the following new item:

“Sec. 317. Consideration of biennial appropriation bills.”.

7 **SEC. 10. ASSISTANCE BY FEDERAL AGENCIES TO STANDING**  
8 **COMMITTEES OF THE SENATE AND THE**  
9 **HOUSE OF REPRESENTATIVES.**

10 (a) INFORMATION REGARDING AGENCY APPROPRIA-  
11 TIONS REQUESTS.—To assist each standing committee of  
12 the House of Representatives and the Senate in carrying  
13 out its responsibilities, the head of each Federal agency  
14 which administers the laws or parts of laws under the ju-  
15 risdiction of such committee shall provide to such com-  
16 mittee such studies, information, analyses, reports, and  
17 assistance as may be requested by the chairman and rank-  
18 ing minority member of the committee.

19 (b) INFORMATION REGARDING AGENCY PROGRAM  
20 ADMINISTRATION.—To assist each standing committee of  
21 the House of Representatives and the Senate in carrying  
22 out its responsibilities, the head of any agency shall fur-  
23 nish to such committee documentation, containing infor-  
24 mation received, compiled, or maintained by the agency  
25 as part of the operation or administration of a program,

1 or specifically compiled pursuant to a request in support  
2 of a review of a program, as may be requested by the  
3 chairman and ranking minority member of such com-  
4 mittee.

5 (c) SUMMARIES BY COMPTROLLER GENERAL.—With-  
6 in thirty days after the receipt of a request from a chair-  
7 man and ranking minority member of a standing com-  
8 mittee having jurisdiction over a program being reviewed  
9 and studied by such committee under this section, the  
10 Comptroller General of the United States shall furnish to  
11 such committee summaries of any audits or reviews of  
12 such program which the Comptroller General has com-  
13 pleted during the preceding six years.

14 (d) CONGRESSIONAL ASSISTANCE.—Consistent with  
15 their duties and functions under law, the Comptroller Gen-  
16 eral of the United States, the Director of the Congres-  
17 sional Budget Office, and the Director of the Congres-  
18 sional Research Service shall continue to furnish (con-  
19 sistent with established protocols) to each standing com-  
20 mittee of the House of Representatives or the Senate such  
21 information, studies, analyses, and reports as the chair-  
22 man and ranking minority member may request to assist  
23 the committee in conducting reviews and studies of pro-  
24 grams under this section.

1 **SEC. 11. REPORT ON TWO-YEAR FISCAL PERIOD.**

2 Not later than 180 days after the date of enactment  
3 of this Act, the Director of the Office of Management and  
4 Budget shall—

5 (1) determine the impact and feasibility of  
6 changing the definition of a fiscal year and the  
7 budget process based on that definition to a 2-year  
8 fiscal period with a biennial budget process based on  
9 the 2-year period; and

10 (2) report the findings of the study to the Com-  
11 mittees on the Budget of the House of Representa-  
12 tives and the Senate and the Committee on Rules of  
13 the House of Representatives.

14 **SEC. 12. SPECIAL TRANSITION PERIOD FOR THE 113TH**  
15 **CONGRESS.**

16 (a) **PRESIDENT'S BUDGET SUBMISSION FOR FISCAL**  
17 **YEAR 2014.**—The budget submission of the President  
18 pursuant to section 1105(a) of title 31, United States  
19 Code, for fiscal year 2014 shall include the following:

20 (1) An identification of the budget accounts for  
21 which an appropriation should be made for each fis-  
22 cal year of the fiscal year 2014–2015 biennium.

23 (2) Budget authority that should be provided  
24 for each such fiscal year for the budget accounts  
25 identified under paragraph (1).

1           (b) REVIEW AND RECOMMENDATIONS OF THE COM-  
2 MITTEES ON APPROPRIATIONS.—The Committee on Ap-  
3 propriations of the House of Representatives and the Sen-  
4 ate shall review the items included pursuant to subsection  
5 (a) in the budget submission of the President for fiscal  
6 year 2014 and include its recommendations thereon in its  
7 views and estimates made under section 301(d) of the  
8 Congressional Budget Act of 1974 within 6 weeks of that  
9 budget submission.

10           (c) ACTIONS BY THE COMMITTEES ON THE BUDG-  
11 ET.—(1) The Committee on the Budget of the House of  
12 Representatives and the Senate shall review the items in-  
13 cluded pursuant to subsection (a) in the budget submis-  
14 sion of the President for fiscal year 2014 and the rec-  
15 ommendations submitted by the Committee on Appropria-  
16 tions of its House pursuant to subsection (b) included in  
17 its views and estimates made under section 301(d) of the  
18 Congressional Budget Act of 1974.

19           (2) The report of the Committee on the Budget of  
20 each House accompanying the concurrent resolution on  
21 the budget for fiscal year 2014 and the joint explanatory  
22 statement of managers accompanying such resolution shall  
23 also include allocations to the Committee on Appropria-  
24 tions of its House of total new budget authority and total  
25 outlays (which shall be deemed to be made pursuant to

1 section 302(a) of the Congressional Budget Act of 1974  
2 for purposes of budget enforcement under section 302(f))  
3 for fiscal year 2015 from which the Committee on Appro-  
4 priations may report regular appropriation bills for fiscal  
5 year 2014 that include funding for certain accounts for  
6 each of fiscal years 2014 and 2015.

7 (3) The report of the Committee on the Budget of  
8 each House accompanying the concurrent resolution on  
9 the budget for fiscal year 2014 and the joint explanatory  
10 statement of managers accompanying such resolution shall  
11 also include the assumptions upon which such allocations  
12 referred to in paragraph (2) are based.

13 (d) GAO PROGRAMMATIC OVERSIGHT ASSIST-  
14 ANCE.—(1) During the first session of the 113th Congress  
15 the committees of the House of Representatives and the  
16 Senate are directed to work with the Comptroller General  
17 of the United States to develop plans to transition pro-  
18 gram authorizations to a multi-year schedule.

19 (2) During the 113th Congress, the Comptroller Gen-  
20 eral of the United States will continue to provide assist-  
21 ance to the Congress with respect to programmatic over-  
22 sight and in particular will assist the committees of Con-  
23 gress in designing and conforming programmatic oversight  
24 procedures for the fiscal year 2014–2015 biennium.

1       (e) CBO AUTHORIZATION REPORT.—On or before  
2 January 15, 2014, the Director of the Congressional  
3 Budget Office, after consultation with the appropriate  
4 committees of the House of Representatives and Senate,  
5 shall submit to the Congress a report listing (A) all pro-  
6 grams and activities funded during fiscal year 2014 for  
7 which authorizations for appropriations have not been en-  
8 acted for that fiscal year and (B) all programs and activi-  
9 ties funded during fiscal year 2014 for which authoriza-  
10 tions for appropriations will expire during that fiscal year,  
11 fiscal year 2015, or fiscal year 2016.

12       (f) PRESIDENT’S BUDGET SUBMISSION FOR FISCAL  
13 YEAR 2015.—The budget submission of the President  
14 pursuant to section 1105(a) of title 31, United States  
15 Code, for fiscal year 2015 shall include an evaluation of,  
16 and recommendations regarding, the transitional biennial  
17 budget process for the fiscal year 2014–2015 biennium  
18 that was carried out pursuant to this section.

19       (g) CBO TRANSITIONAL REPORT.—On or before  
20 March 31, 2014, the Director of the Congressional Budget  
21 Office shall submit to Congress an evaluation of, and rec-  
22 ommendations regarding, the transitional biennial budget  
23 process for the fiscal year 2014–2015 biennium that was  
24 carried out pursuant to this section.

1 **SEC. 13. EFFECTIVE DATE.**

2       Except as provided by sections 8, 11, and 12, this  
3 Act and the amendments made by it shall take effect on  
4 January 1, 2015, and shall apply to budget resolutions  
5 and appropriations for the biennium beginning with fiscal  
6 year 2016.

○
