AN ACT

To amend section 17 of the Richard B. Russell National School Lunch Act to include a condition of receipt of funds under the child and adult care food program.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. CONDITION OF RECEIPT OF FUNDS UNDER THE**
2 **CHILD AND ADULT CARE FOOD PROGRAM.**

3 Section 17 of the Richard B. Russell National School
4 Lunch Act (42 U.S.C. 1766) is amended by adding at the
5 end the following:

6 “(u) INELIGIBILITY OF INSTITUTIONS.—An institu-
7 tion shall be ineligible for funds under this section if such
8 institution employs a child care staff member who—

9 “(1) refuses to consent to a criminal back-
10 ground check that includes—

11 “(A) a search of the State criminal reg-
12 istry or repository in the State where the child
13 care staff member resides and each State where
14 such staff member previously resided;

15 “(B) a search of State-based child abuse
16 and neglect registries and databases in the
17 State where the child care staff member resides
18 and each State where such staff member pre-
19 viously resided;

20 “(C) a search of the National Crime Infor-
21 mation Center;

22 “(D) a Federal Bureau of Investigation
23 fingerprint check using the Integrated Auto-
24 mated Fingerprint Identification System; and

25 “(E) a search of the National Sex Of-
26 fender Registry established under the Adam

2 (42 U.S.C. 16901 et seq.);

3 “(2) makes a false statement in connection with
4 such criminal background check;

5 “(3) is registered or is required to be registered
6 on a State sex offender registry or the National Sex
7 Offender Registry established under the Adam
8 Walsh Child Protection and Safety Act of 2006 (42
9 U.S.C. 16901 et seq.); or

10 “(4) has been convicted of a felony consisting
11 of—

12 “(A) homicide;

13 “(B) child abuse or neglect;

14 “(C) a crime against children, including
15 child pornography;

16 “(D) spousal abuse;

17 “(E) a crime involving rape or sexual as-
18 sault;

19 “(F) kidnapping;

20 “(G) arson; or

1 “(H) physical assault, battery, or a drug-
2 related offense, committed within the past 5
3 years.”.
