1 SECTION 1. SHORT TITLE; REFERENCES.

2	(a) SHORT TITLE.—This Act may be cited as the
3	"Protecting Children Across State Lines Act".
4	(b) References.—Except as otherwise expressly
5	provided, whenever in this Act an amendment or repeal
6	is expressed in terms of an amendment to, or repeal of,
7	a section or other provision, the reference shall be consid-
8	ered to be made to a section or other provision of the Child

16	those reports involving a potential combination of ju-
17	risdictions, such as intrastate, interstate, Federal-
18	State, and State-Tribal, in a manner that ensures
19	appropriate action is taken to protect children.";

8	intrastate, interstate, Federal-State, and State-Trib-
9	al, including efforts to coordinate and ensure appro-
10	priate action is taken; and"; and

12	(A) in paragraph (1)(A), by inserting
13	"intrastate," before "interstate"; and
14	(B) in paragraph (1)(C), by inserting ",
15	which may include those children involved in re-
16	ports of child abuse or neglect with a potential
17	combination of jurisdictions, such as intrastate,
18	interstate, Federal-State, and State-Tribal,"
19	after "protection for children".
