- 3 SECTION 1. CREDIT FOR UNUSED SICK LEAVE UNDER THE
- 4 FEDERAL EMPLOYEES' RETIREMENT SYSTEM.
- 5 (a) IN GENERAL.—Section 8415 of title 5, United
- 6 States Code, is amended—

- 1 (1) by redesignating the second subsection (k) 2 and subsection (l) as subsections (l) and (m), respec-3 tively; and
- 4 (2) by amending subsection (l) (as so redesignated by paragraph (1)) to read as follows:
- 6 "(l) In computing any annuity under this section, the
- 7 total service of an employee who retires under section
- 8 8412 or 8414 or who dies leaving a survivor or survivors
- 9 entitled to benefits under subchapter IV includes the days
- 10 of unused sick leave to such employee's credit under a for-
- 11 mal leave system, except that these days will not be count-
- 12 ed in determining average pay or annuity eligibility under
- 13 this chapter. For the purpose of this subsection, in the
- 14 case of any such employee who is excepted from sub-
- 15 chapter I of chapter 63 under section 6301(2)(x)-(xiii),
- 16 the days of unused sick leave to such employee's credit
- 17 include any unused sick leave standing to such employee's
- 18 credit when such employee was excepted from such sub-
- 19 chapter.".
- 20 (b) Conforming Amendment.—Section 8422(d)(2)
- 21 of title 5, United States Code, is amended by striking
- 22 "8415(k)" and inserting "8415(l)".

13	"(B) For purposes of any computation under para-
14	graph (5) in the case of an individual who retires under
15	section 8412 or 8414 of title 5, United States Code, or
16	who dies leaving a survivor or survivors entitled to benefits
17	under subchapter IV of such chapter, sick leave creditable
18	under section 8415(l) of such title shall be equal to the
19	number of days by which—
20	"(i) the number of days of unused sick leave to
21	the individual's credit as of the date of retirement,
22	exceeds (if at all)
23	"(ii) the number of days of unused sick leave to
24	the individual's credit as of the effective date of the
25	individual's election under section 301.".

1 SEC. 3. EFFECTIVE DATE.

- 2 The amendments made by this Act shall take effect
- 3 on the date of enactment of this Act and shall apply with
- 4 respect to any annuity, entitlement to which is based on
- 5 a separation occurring on or after such date of enactment.
