RESOLUTION

Amending the Rules of the House of Representatives to guarantee reasonable time prior to the consideration of legislation.

1 Resolved,
2 SECTION 1. PURPOSE.
3 The purpose of this resolution is to—
4 (1) allow for a careful study of the facts and
5 potential impacts of legislative actions;
6 (2) restore public trust in elected representatives and the legislative process;
8 (3) foster bipartisanship;

1	(4) improve the quality of legislation by ena-
2	bling the close scrutiny of issues that the gravity of
3	our Nation's challenges require and deserve; and
4	(5) fulfill the promise of our Republic by pro-
5	viding the opportunities and time for public partici-
6	pation that empowers Members of Congress to rep-
7	resent their constituents as effectively as possible;
8	by amending the Rules of the House of Representatives
9	to improve Americans' representation in their Government
10	and the legislative process.

- 12 further consideration of the motion in the House for 2
- 13 hours, and the text of any such motion to recommit shall

- 16 and the public during such 2-hour period.".

- 2 anonymously and at no cost to the public, in a format that
- 3 can be searched by text.
- 4 "(b) Paragraph (a) may be waived by the affirmative
- 5 vote of two-thirds of the Members, a quorum being
- 6 present.".

7 SEC. 6. AVAILABILITY OF LEGISLATION AND AMENDMENTS

- 8 IN COMMITTEES AND SUBCOMMITTEES.
- 9 Clause 2 of rule XI of the Rules of the House of Rep-
- 10 resentatives is amended by adding at the end the following
- 11 new paragraph:
- "(q)(1) It shall not be in order in any committee, or
- 13 a subcommittee thereof, to consider any bill or resolution
- 14 until 72 hours (excluding Saturdays, Sundays and holi-
- 15 days, except for those hours when the House is in session
- 16 on such a day) after the text of such bill or resolution
- 17 has been made available to its Members, Delegates, the
- 18 Resident Commissioner, and the public on the Library of
- 19 Congress website, www.thomas.gov, in such a manner that
- 20 the bill or resolution is accessible using existing tech-
- 21 nology, anonymously and at no cost to the public, in a
- 22 format that is searchable by text.
- 23 "(2) Subparagraph (1) may be waived by the affirma-
- 24 tive vote of two-thirds of the Members, a quorum being
- 25 present.

- 1 "(3) Clause 9 of rule XVI (relating to the availability
- 2 of amendments) is applicable to the consideration of

3 amendments in any committee or subcommittee thereof.".
