The Senate amendments and the motion shall be considered as read. The motion shall be 10 debatable for one hour and 30 minutes as follows: 30 minutes equally divided and controlled by the chair and rank-11 ing minority member of the Committee on Appropriations; then 30 minutes equally divided and controlled by Rep-
- by Representative McGovern of Massachusetts or his designee and an opponent. The previous question shall be considered as ordered on the motion to final adoption

resentative Lee of California or her designee and an oppo-

nent; and then 30 minutes equally divided and controlled

- 21 tion shall be divided among the five House amendments.
- 22 The first portion of the divided question shall be consid-

- 3 Sec. 2. Upon adoption of the motion specified in the
- 4 first section of this resolution—
- 5 (a) the Clerk shall engross the action of the House
- 6 under that section as a single amendment; and
- 7 (b) a motion that the House concur in the Senate
- 8 amendment to the title shall be considered as adopted.
- 9 Sec. 3. The chair of the Committee on Appropria-
- 10 tions may insert in the Congressional Record not later
- 11 than July 3, 2010, such material as he may deem explana-
- 12 tory of the Senate amendments and the motion specified
- 13 in the first section of this resolution.
- 14 Sec. 4. House Resolution 1493 is hereby adopted.
- 15 Sec. 5. Clause 10(a) of rule XXI is amended to read
- 16 as follows:

 (a)(1) Except as provided in paragraphs (b) and (c),
- 18 it shall not be in order to consider any bill, joint resolu-

- 8 Emergency Deficit Control Act of 1985 and consistent
- 9 with sections 3(4), 3(8), and 4(c) of the Statutory Pay-
- 10 As-You-Go Act of 2010.
- 11 "(3) For the purpose of this clause, the terms 'budget
- 12 year', 'current year', and 'direct spending' have the mean-
- 13 ings specified in section 250 of the Balanced Budget and
- 14 Emergency Deficit Control Act of 1985, except that the
- 15 term 'direct spending' shall also include provisions in ap-
- 16 propriation Acts that make outyear modifications to sub-
- 17 stantive law as described in section 3(4)(C) of the Statu-
- 18 tory Pay-As-You-Go Act of 2010.".
