RESOLUTION

Amending the Rules of the House of Representatives to require House officers and employees to take annual factual training on the Constitution.

- 1 Resolved, That (a) rule XI of the Rules of the House
- 2 of Representatives is amended by adding at the end the
- 3 following new clause:
- 4 "Constitutional training for officers and employees
- 5 "7.(a)(1) The Subcommittee on the Constitution,
- 6 Civil Rights, and Civil Liberties of the Committee on the

- 1 Judiciary shall offer annual factual training on the Con-
- 2 stitution to each officer and employee of the House. Such
- 3 training shall—
- 4 "(A) involve the same class of employees for
- 5 whom the Committee on Standards of Official Con-
- 6 duct has determined ethics training to be appro-
- 7 priate under clause 3(a)(6); and
- 8 "(B) include such knowledge of the Constitu-
- 9 tion as may be determined appropriate by the Sub-
- 10 committee on the Constitution, Civil Rights, and
- 11 Civil Liberties of the Committee on the Judiciary.
- 12 "(b)(1) A new officer or employee of the House shall
- 13 receive training under this clause not later than 60 days
- 14 after beginning service to the House.
- 15 "(2) Not later than January 31 of each year, each
- 16 officer and employee of the House shall file a certification
- 17 with the Subcommittee on the Constitution, Civil Rights,
- 18 and Civil Liberties of the Committee on the Judiciary that
- 19 the officer or employee attended training on the Constitu-
- 20 tion in the last year as established by this clause.".
- 21 (b) The amendment made by this resolution shall
- 22 take effect immediately before noon, January 5, 2011.
