Directing the Attorney General to transmit to the House of Representatives all information in the Attorney General's possession regarding certain matters pertaining to

1 *Resolved*, That the Attorney General is directed to
2 transmit to the House of Representatives, not later than
3 14 days after the date of the adoption of this resolution,
4 copies of any document, record, memo, correspondence, or
5 other communication of the Department of Justice, in-
6 cluding the Office of the Solicitor General, or any portion
7 of any such communication, that refers or relates to—

8 (1) any legal guidance or recommendations
9 made since January 20, 2009, regarding additional
10 legal rights or protections, including under the Con-
11 stitution, statutes, and treaties, detainees held at
12 Naval Station, Guantanamo Bay, Cuba, receive
13 when transferred into the United States from such
14 Naval Station, Guantanamo Bay, Cuba; or

15 (2) pretrial detention, post conviction incarcer-
16 ation, or transportation within the United States, of
17 detainees held at Naval Station, Guantanamo Bay,
18 Cuba, who are to be transferred into the United
19 States for prosecution and trial in the United States
20 District Court of the Southern District of New York.
