To amend title 10, United States Code, to require the provision of medical and dental readiness services to certain members of the Selected Reserve and Individual Ready Reserve based on medical need, and for other purposes.

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Selected Reserve Con-
- 5 tinuum of Care Act".

6	(a) In General.—Section 1074a(g)(1) of title 10,
7	United States Code, is amended—
8	(1) by striking "may provide" and inserting
9	"shall provide"; and
10	(2) by striking "if the Secretary determines"
11	and inserting ", as applicable, if a qualified health
12	care professional determines, based on the member's
13	most recent annual medical exam or annual dental
14	exam, as the case may be,".
15	(b) Funding.—Subject to applicable provisions of
16	appropriations Acts, amounts available to the Department
17	of Defense for Defense Health Program shall be available
18	for the provision of medical and dental services under sec-
19	tion 1074a(g)(1) of title 10, United States Code, in ac-
20	cordance with the amendments made by subsection (a).
21	(c) Budgeting for Health Care.—In deter-
22	mining the amounts to be required for medical and dental
23	readiness services for members of the Selected Reserve

26	by subsection (a)), for purposes of the budget of the Presi-
