A BILL

To amend the Public Health Service Act to promote and improve the allied health professions.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Allied Health Reinvest-
- 5 ment Act".
- 6 SEC. 2. FINDINGS AND PURPOSE.
- 7 (a) FINDINGS.—Congress makes the following find-
- 8 ings:
- 9 (1) The United States Census Bureau and
- other reports highlight the increased demand for

- acute and chronic healthcare services among both the general population and a rapidly growing aging portion of the population.
 - (2) The calls for reduction in medical errors, increased patient safety, and quality of care have resulted in an amplified call for allied health professionals to provide healthcare services.
 - (3) Several allied health professions are characterized by workforce shortages, declining enrollments in allied health education programs, or a combination of both factors, and hospital officials have reported vacancy rates in positions occupied by allied health professionals.
 - (4) Many allied health education programs are facing significant economic pressure that could force their closure due to an insufficient number of students.
- 18 (b) Purpose.—It is the purpose of this Act to pro19 vide incentives for individuals to seek and complete high
 20 quality allied health education and training and provide
 21 additional funding to ensure that such education and
 22 training can be provided to allied health students so that
 23 the United States healthcare industry with have a supply
 24 of allied health professionals needed to support the health

- 3 SEC. 3. AMENDMENT TO THE PUBLIC HEALTH SERVICE

13	course of study or, at the discretion of the Secretary,

19	"(c) Loan Provisions.—Loans from any faculty
20	loan fund established pursuant to an agreement under this
21	section shall be made to an individual on such terms and
22	conditions as the allied health education program may de-
23	termine, except that—

1 "(1) such terms and conditions are subject to 2 any conditions, limitations, and requirements pre-3 scribed by the Secretary;

> "(2) in the case of any individual, the total of the loans for any academic year made by an allied health education program from loan funds established pursuant to agreements under this section may not exceed \$30,000, plus any amount determined by the Secretary on an annual basis to reflect inflation;

> "(3) upon completion by the individual of each of the first, second, and third year of full-time employment, as required under the loan agreement, as a faculty member in an allied health education program, the program shall cancel 20 percent of the principal and interest due on the amount of the unpaid portion of the loan on the first day of such employment;

"(4) upon completion by the individual of the fourth year of full-time employment, as required under the loan agreement, as a faculty member in an allied health education program, the program shall cancel 25 percent of the principal and interest due on the amount of the unpaid portion of the loan on the first day of such employment;

1 "(5) the loan may be used to pay the cost of 2 tuition, fees, books, laboratory expenses, and other 3 reasonable education expenses;

"(6) the loan shall be repayable in equal or graduated periodic installments (with the right of the borrower to accelerate repayment) over the 10-year period that begins 9 months after the individual ceases to pursue a course of study in an allied health education program; and

"(7) the loan shall—

"(A) beginning on the date that is 3 months after the individual ceases to pursue a course of study in an allied health education program, bear interest on the unpaid balance of the loan at the rate of 3 percent per year; or

"(B) subject to subsection (e), if the allied health education program determines that the individual will not complete such course of study or serve as a faculty member as required under the loan agreement under this subsection, bear interest on the unpaid balance of the loan at the prevailing market rate.

"(d) Payment of Proportionate Share.—Where all or any part of a loan (including interest thereon) is canceled under this section, the Secretary shall pay to the

1	allied health education program involved an amount equal
2	to the program's proportionate share of the canceled por-
3	tion, as determined by the Secretary.
4	"(e) REVIEW BY SECRETARY.—At the request of the
5	individual involved, the Secretary may review any deter-
6	mination by an allied health education program under this
7	section.
8	"SEC. 799C-8. SCHOLARSHIP PROGRAM FOR SERVICE IN
9	RURAL AND OTHER MEDICALLY UNDER-
10	SERVED AREAS.
11	"(a) Program Authorized.—The Secretary shall
12	establish a scholarship program (referred to in this section
13	as the 'program') to provide scholarships to individuals
14	seeking allied health education who agree to provide serv-
15	ice in rural and other medically underserved areas with
16	allied health personnel shortages.
17	"(b) Preference.—In awarding scholarships under
18	this section, the Secretary shall give preference to—
19	"(1) applicants who demonstrate the greatest
20	financial need, including minority applicants;
21	"(2) applicants who agree to serve in health

care facilities experiencing allied health shortages in

rural and other medically underserved areas;

1	"(3) applicants who are currently working in a
2	health care facility and who agree to serve the period
3	of obligated service at such facility; and
4	"(4) applicants with an interest in a practice
5	area of allied health that has unmet needs.

"(c) Program Requirements.—

- "(1) Contracts.—Under the program, the Secretary shall enter into contracts with eligible individuals under which such individuals agree to serve as allied health professionals for a period of not less than 2 years at a health care facility with a critical shortage of allied health professionals in consideration of the Federal Government agreeing to provide to the individuals scholarships for attendance in an allied health education program.
- "(2) ELIGIBLE INDIVIDUALS.—In this subsection, the term 'eligible individual' means an individual who is enrolled or accepted for enrollment as a full-time or part-time student in an allied health education program.

"(3) Service requirement.—

"(A) IN GENERAL.—The Secretary may not enter into a contract with an eligible individual under this section unless the individual agrees to serve as an allied health professional

1 at a health care facility with a critical shortage 2 of allied health professionals for a period of 3 full-time service of not less than 2 years, or for 4 a period of part-time service in accordance with 5 subparagraph (B). 6 "(B) Part-time Service.—An individual 7 may complete the period of service described in 8 subparagraph (A) on a part-time basis if the in-9 dividual has a written agreement that— "(i) is entered into by the facility and 10 11 the individual and is approved by the Sec-12 retary; and 13 "(ii) provides that the period of obli-14 gated service will be extended so that the 15 aggregate amount of service performed will 16 equal the amount of service that would be 17 performed through a period of full-time 18 service of not less than 2 years. 19 "(d) REPORTS.—Not later than 18 months after the date of enactment of this part, and annually thereafter, 20 21 the Secretary shall prepare and submit to the appropriate 22 committees of Congress a report describing the program 23 carried out under this section, including statements regarding—

1	"(1) the number of enrollees by specialty or dis-

18	benefits of the program.
19	"SEC. 799C-9. GRANTS FOR CLINICAL EDUCATION, INTERN-
20	SHIP, AND RESIDENCY PROGRAMS.
21	"(a) Program Authorized.—The Secretary shall
22	award grants to eligible entities to develop clinical edu-
23	cation, internship, and residency programs that encourage
24	mentoring and the development of specialties.

"(b) Eligible Entities.—To be eligible for a grant 1 2 under this section, an entity shall— 3 "(1) be a partnership of an allied health edu-4 cation program and a health care facility; and 5 "(2) prepare and submit to the Secretary an 6 application at such time, in such manner, and con-7 taining such information as the Secretary may re-8 quire. 9 "(c) Use of Funds.—An eligible entity shall use amounts received under a grant under this section to— 10 11 "(1) develop clinical education, internship, and 12 residency programs and curriculum and training 13 programs for graduates of an allied health education 14 program; "(2) provide support for faculty and mentors; 15 16 and 17 "(3) provide support for allied health profes-18 sionals participating in clinical education, internship, 19 and residency programs on both a full-time and 20 part-time basis. 21 "SEC. 799C-10. GRANTS FOR PARTNERSHIPS. 22 "(a) IN GENERAL.—The Secretary shall award 23 grants to eligible entities to enable such entities to form partnerships to carry out the activities described in this section. 25
