## A BILL

To conserve fish and aquatic communities in the United States through partnerships that foster fish habitat conservation, to improve the quality of life for the people of the United States, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE; TABLE OF CONTENTS.**

2 (a) **SHORT TITLE.**—This Act may be cited as the  
3 “National Fish Habitat Conservation Act”.

6 **SEC. 2. FINDINGS; PURPOSE.**

7 (a) **FINDINGS.**—Congress finds that—

8 (1) healthy populations of fish and other aquat-  
9 ie organisms depend on the conservation, protection,  
10 restoration, and enhancement of aquatic habitats in  
11 the United States;

12 (2) aquatic habitats (including wetlands,  
13 streams, rivers, lakes, estuaries, coastal and marine  
14 ecosystems, and associated riparian upland habitats  
15 that buffer those areas from external factors) per-  
16 form numerous valuable environmental functions  
17 that sustain environmental, social, and cultural val-  
18 ues, including recycling nutrients, purifying water,

1 attenuating floods, augmenting and maintaining  
2 stream flows, recharging ground water, acting as  
3 primary producers in the food chain, and providing  
4 essential and significant habitat for plants, fish,  
5 wildlife, and other dependent species;

6 (3) the extensive and diverse aquatic habitat re-  
7 sources of the United States are of enormous signifi-  
8 cance to the economy of the United States, pro-  
9 viding—

10 (A) recreation for 44,000,000 anglers;

11 (B) more than 1,000,000 jobs and approxi-  
12 mately \$125,000,000,000 in economic impact  
13 each year relating to recreational fishing; and

14 (C) approximately 500,000 jobs and an ad-  
15 ditional \$35,000,000,000 in economic impact  
16 each year relating to commercial fishing;

17 (4) at least 40 percent of all threatened species  
18 and endangered species in the United States are di-  
19 rectly dependent on aquatic habitats;

20 (5) certain fish species are considered to be eco-  
21 logical indicators of aquatic habitat quality, such  
22 that the presence of those species in an aquatic eco-  
23 system reflects high-quality habitat for other fish;

24 (6) loss and degradation of aquatic habitat, ri-  
25 parian habitat, water quality, and water volume

1 caused by activities such as alteration of water-  
2 courses, stream blockages, water withdrawals and di-  
3 versions, erosion, pollution, sedimentation, and de-  
4 struction or modification of wetlands have—

5 (A) caused significant declines in fish pop-  
6 ulations throughout the United States, espe-  
7 cially declines in native fish populations; and

8 (B) resulted in economic losses to the  
9 United States;

10 (7)(A) providing for the conservation and sus-  
11 tainability of fish and other aquatic organisms has  
12 not been fully realized, despite federally funded fish  
13 and wildlife restoration programs and other activi-  
14 ties intended to conserve aquatic resources; and

15 (B) that conservation and sustainability may be  
16 significantly advanced through a renewed commit-  
17 ment and sustained, cooperative efforts that are  
18 complementary to existing fish and wildlife restora-  
19 tion programs and clean water programs;

20 (8) the National Fish Habitat Action Plan pro-  
21 vides a framework for maintaining and restoring  
22 aquatic habitats to ensure perpetuation of popu-  
23 lations of fish and other aquatic organisms;

24 (9) the United States can achieve significant  
25 progress toward providing aquatic habitats for the

1 conservation and restoration of fish and other aquat-  
2 ie organisms through a voluntary, nonregulatory in-  
3 centive program that is based on technical and fi-  
4 nancial assistance provided by the Federal Govern-  
5 ment;

6 (10) the creation of partnerships between local  
7 citizens, Indian tribes, Alaska Native organizations,  
8 corporations, nongovernmental organizations, and  
9 Federal, State, and tribal agencies is critical to the  
10 success of activities to restore aquatic habitats and  
11 ecosystems;

12 (11) the Federal Government has numerous  
13 regulatory and land and water management agencies  
14 that are critical to the implementation of the Na-  
15 tional Fish Habitat Action Plan, including—

16 (A) the United States Fish and Wildlife  
17 Service;

18 (B) the Bureau of Land Management;

19 (C) the National Park Service;

20 (D) the Bureau of Reclamation;

21 (E) the Bureau of Indian Affairs;

22 (F) the National Marine Fisheries Service;

23 (G) the Forest Service;

24 (H) the Natural Resources Conservation  
25 Service; and

1           (~~I~~) the Environmental Protection Agency;  
2           (~~12~~) the United States Fish and Wildlife Serv-  
3           ice, the Forest Service, the Bureau of Land Manage-  
4           ment, and the National Marine Fisheries Service  
5           each play a vital role in—

6           (~~A~~) the protection, restoration, and en-  
7           hancement of the fish communities and aquatic  
8           habitats in the United States; and

9           (~~B~~) the development, operation, and long-  
10          term success of fish habitat partnerships and  
11          project implementation;

12          (~~13~~) the United States Geological Survey, the  
13          United States Fish and Wildlife Service, and the  
14          National Marine Fisheries Service each play a vital  
15          role in scientific evaluation, data collection, and  
16          mapping for fishery resources in the United States;  
17          and

18          (~~14~~) many of the programs for conservation on  
19          private farmland, ranchland, and forestland that are  
20          carried out by the Secretary of Agriculture, includ-  
21          ing the Natural Resources Conservation Service and  
22          the State and Private Forestry programs of the For-  
23          est Service, are able to significantly contribute to the  
24          implementation of the National Fish Habitat Action  
25          Plan through the engagement of private landowners.

1       (b) PURPOSE.—The purpose of this Act is to encour-  
2 age partnerships among public agencies and other inter-  
3 ested parties consistent with the mission and goals of the  
4 National Fish Habitat Action Plan—

5           (1) to protect and maintain intact and healthy  
6 aquatic habitats;

7           (2) to prevent further degradation of aquatic  
8 habitats that have been adversely affected;

9           (3) to reverse declines in the quality and quan-  
10 tity of aquatic habitats to improve the overall health  
11 of fish and other aquatic organisms;

12           (4) to increase the quality and quantity of  
13 aquatic habitats that support a broad natural diver-  
14 sity of fish and other aquatic species;

15           (5) to improve fisheries habitat in a manner  
16 that leads to improvement of the annual economic  
17 output from recreational, subsistence, and commer-  
18 cial fishing;

19           (6) to ensure coordination and facilitation of ac-  
20 tivities carried out by Federal departments and  
21 agencies under the leadership of—

22                   (A) the Director of the United States Fish  
23 and Wildlife Service;

1           (B) the Assistant Administrator for Fish-  
2           eries of the National Oceanic and Atmospheric  
3           Administration; and

4           (C) the Director of the United States Geo-  
5           logical Survey; and

6           (7) to achieve other purposes in accordance  
7           with the mission and goals of the National Fish  
8           Habitat Action Plan.

9 **SEC. 3. DEFINITIONS.**

10         In this Act:

11           (1) APPROPRIATE CONGRESSIONAL COMMIT-  
12           TEES.—The term “appropriate congressional com-  
13           mittees” means—

14           (A) the Committee on Commerce, Science,  
15           and Transportation and the Committee on En-  
16           vironment and Public Works of the Senate; and

17           (B) the Committee on Natural Resources  
18           of the House of Representatives.

19           (2) AQUATIC HABITAT.—

20           (A) IN GENERAL.—The term “aquatic  
21           habitat” means any area on which an aquatic  
22           organism depends, directly or indirectly, to  
23           carry out the life processes of the organism, in-  
24           cluding an area used by the organism for

1 spawning, incubation, nursery, rearing, growth  
2 to maturity, food supply, or migration.

3 (B) INCLUSIONS.—The term “aquatic  
4 habitat” includes an area adjacent to an aquat-  
5 ic environment, if the adjacent area—

6 (i) contributes an element, such as the  
7 input of detrital material or the promotion  
8 of a planktonic or insect population pro-  
9 viding food, that makes fish life possible;

10 (ii) protects the quality and quantity  
11 of water sources;

12 (iii) provides public access for the use  
13 of fishery resources; or

14 (iv) serves as a buffer protecting the  
15 aquatic environment.

16 (3) ASSISTANT ADMINISTRATOR.—The term  
17 “Assistant Administrator” means the Assistant Ad-  
18 ministrator for Fisheries of the National Oceanic  
19 and Atmospheric Administration.

20 (4) BOARD.—The term “Board” means the Na-  
21 tional Fish Habitat Board established by section  
22 4(a)(1).

23 (5) CONSERVATION; CONSERVE; MANAGE; MAN-  
24 AGEMENT.—The terms “conservation”, “conserve”,  
25 “manage”, and “management” mean to protect, sus-

1       tain, and, where appropriate, restore and enhance,  
 2       using methods and procedures associated with mod-  
 3       ern scientific resource programs (including protec-  
 4       tion, research, census, law enforcement, habitat  
 5       management, propagation, live trapping and trans-  
 6       plantation, and regulated taking)—

7               (A) a healthy population of fish, wildlife,  
 8               or plant life;

9               (B) a habitat required to sustain fish, wild-  
 10              life, or plant life; or

11             (C) a habitat required to sustain fish, wild-  
 12              life, or plant life productivity.

13       (6) DIRECTOR.—The term “Director” means  
 14       the Director of the United States Fish and Wildlife  
 15       Service.

16       (7) FISH.—

17             (A) IN GENERAL.—The term “fish” means  
 18              any freshwater, diadromous, estuarine, or ma-  
 19              rine finfish or shellfish.

20             (B) INCLUSIONS.—The term “fish” in-  
 21              cludes the egg, spawn, spat, larval, and other  
 22              juvenile stages of an organism described in sub-  
 23              paragraph (A).

24       (8) FISH HABITAT CONSERVATION PROJECT.—

1 (A) IN GENERAL.—The term “fish habitat  
2 conservation project” means a project that—

3 (i) is submitted to the Board by a  
4 Partnership and approved by the Secretary  
5 under section 6; and

6 (ii) provides for the conservation or  
7 management of an aquatic habitat.

8 (B) INCLUSIONS.—The term “fish habitat  
9 conservation project” includes—

10 (i) the provision of technical assist-  
11 ance to a State, Indian tribe, or local com-  
12 munity by the National Fish Habitat Con-  
13 servation Partnership Office or any other  
14 agency to facilitate the development of  
15 strategies and priorities for the conserva-  
16 tion of aquatic habitats; or

17 (ii) the obtaining of a real property  
18 interest in land or water, including water  
19 rights, in accordance with terms and condi-  
20 tions that ensure that the real property  
21 will be administered for the long-term con-  
22 servation of—

23 (I) the land or water; and

24 (II) the fish dependent on the  
25 land or water.

1           (9) INDIAN TRIBE.—The term “Indian tribe”  
 2 has the meaning given the term in section 4 of the  
 3 Indian Self-Determination and Education Assistance  
 4 Act (25 U.S.C. 450b).

5           (10) NATIONAL FISH HABITAT ACTION PLAN.—  
 6 The term “National Fish Habitat Action Plan”  
 7 means the National Fish Habitat Action Plan dated  
 8 April 24, 2006, and any subsequent revisions or  
 9 amendments to that plan.

10           (11) PARTNERSHIP.—The term “Partnership”  
 11 means an entity designated by the Board as a Fish  
 12 Habitat Conservation Partnership pursuant to sec-  
 13 tion 5(a).

14           (12) REAL PROPERTY INTEREST.—The term  
 15 “real property interest” means an ownership interest  
 16 in—

17                   (A) land;

18                   (B) water (including water rights); or

19                   (C) a building or object that is perma-  
 20 nently affixed to land.

21           (13) SECRETARY.—The term “Secretary”  
 22 means the Secretary of the Interior.

23           (14) STATE AGENCY.—The term “State agen-  
 24 cy” means—

25                   (A) the fish and wildlife agency of a State;

1           (B) any department or division of a de-  
 2           partment or agency of a State that manages in  
 3           the public trust the inland or marine fishery re-  
 4           sources of the State pursuant to State law or  
 5           the constitution of the State; or

6           (C) the fish and wildlife agency of the  
 7           Commonwealth of Puerto Rico, Guam, the Vir-  
 8           gin Islands, or any other territory or possession  
 9           of the United States.

10 **SEC. 4. NATIONAL FISH HABITAT BOARD.**

11       (a) ESTABLISHMENT.—

12           (1) IN GENERAL.—There is established a board,  
 13       to be known as the “National Fish Habitat  
 14       Board”—

15           (A) to promote, oversee, and coordinate the  
 16       implementation of this Act and the National  
 17       Fish Habitat Action Plan;

18           (B) to establish national goals and prior-  
 19       ities for aquatic habitat conservation;

20           (C) to designate Partnerships; and

21           (D) to review and make recommendations  
 22       regarding fish habitat conservation projects.

23       (2) MEMBERSHIP.—The Board shall be com-  
 24       posed of 27 members, of whom—

25           (A) 1 shall be the Director;

1           (B) 1 shall be the Assistant Administrator;

2           (C) 1 shall be the Chief of the Natural Re-  
3 sources Conservation Service;

4           (D) 1 shall be the Chief of the Forest  
5 Service;

6           (E) 1 shall be the Assistant Administrator  
7 for Water of the Environmental Protection  
8 Agency;

9           (F) 1 shall be the President of the Associa-  
10 tion of Fish and Wildlife Agencies;

11           (G) 1 shall be the Secretary of the Board  
12 of Directors of the National Fish and Wildlife  
13 Foundation appointed pursuant to section  
14 3(g)(2)(B) of the National Fish and Wildlife  
15 Foundation Establishment Act (16 U.S.C.  
16 3702(g)(2)(B));

17           (H) 4 shall be representatives of State  
18 agencies, 1 of whom shall be nominated by a re-  
19 gional association of fish and wildlife agencies  
20 from each of the Northeast, Southeast, Mid-  
21 west, and Western regions of the United States;

22           (I) 1 shall be a representative of the Amer-  
23 ican Fisheries Society;

24           (J) 2 shall be representatives of Indian  
25 tribes, of whom—

1 (i) † shall represent Indian tribes  
2 from the State of Alaska; and

3 (ii) † shall represent Indian tribes  
4 from the other States;

5 (K) † shall be a representative of the Re-  
6 gional Fishery Management Councils estab-  
7 lished under section 302 of the Magnuson-Ste-  
8 vens Fishery Conservation and Management  
9 Act (~~16 U.S.C. 1852~~);

10 (L) † shall be a representative of the Ma-  
11 rine Fisheries Commissions, which is composed  
12 of—

13 (i) the Atlantic States Marine Fish-  
14 eries Commission;

15 (ii) the Gulf States Marine Fisheries  
16 Commission; and

17 (iii) the Pacific States Marine Fish-  
18 eries Commission;

19 (M) † shall be a representative of the  
20 Sportfishing and Boating Partnership Council;  
21 and

22 (N) † shall be representatives selected  
23 from each of the following groups:

24 (i) The recreational sportfishing in-  
25 dustry.

- 1 (ii) The commercial fishing industry.
- 2 (iii) Marine recreational anglers.
- 3 (iv) Freshwater recreational anglers.
- 4 (v) Terrestrial resource conservation
- 5 organizations.
- 6 (vi) Aquatic resource conservation or-
- 7 ganizations.
- 8 (vii) The livestock and poultry produc-
- 9 tion industry.
- 10 (viii) The land development industry.
- 11 (ix) The row crop industry.
- 12 (x) Natural resource commodity inter-
- 13 ests, such as petroleum or mineral extrac-
- 14 tion.

15 (3) COMPENSATION.—A member of the Board

16 shall serve without compensation.

17 (4) TRAVEL EXPENSES.—A member of the

18 Board shall be allowed travel expenses, including per

19 diem in lieu of subsistence, at rates authorized for

20 an employee of an agency under subchapter I of

21 chapter 57 of title 5, United States Code, while

22 away from the home or regular place of business of

23 the member in the performance of the duties of the

24 Board.

25 (b) APPOINTMENT AND TERMS.—

1           (1) IN GENERAL.—Except as otherwise pro-  
2           vided in this subsection, a member of the Board de-  
3           scribed in any of subparagraphs (H) through (N) of  
4           subsection (a)(2) shall serve for a term of 3 years.

5           (2) INITIAL BOARD MEMBERSHIP.—Not later  
6           than 180 days after the date of enactment of this  
7           Act, the representatives of the board established by  
8           the National Fish Habitat Action Plan shall appoint  
9           the initial members of the Board described in sub-  
10          paragraphs (H) through (N) of subsection (a)(2).

11          (3) TRANSITIONAL TERMS.—Of the members  
12          described in subsection (a)(2)(N) initially appointed  
13          to the Board—

14                (A) 4 shall be appointed for a term of 1  
15                year;

16                (B) 4 shall be appointed for a term of 2  
17                years; and

18                (C) 3 shall be appointed for a term of 3  
19                years.

20          (4) VACANCIES.—A vacancy of a member of the  
21          Board described in any of subparagraphs (H)  
22          through (N) of subsection (a)(2) shall be filled by an  
23          appointment made by the remaining members of the  
24          Board.

1           (5) CONTINUATION OF SERVICE.—An individual  
2 whose term of service as a member of the Board ex-  
3 pires may continue to serve on the Board until a  
4 successor is appointed.

5           (6) REMOVAL.—If a member of the Board de-  
6 scribed in any of subparagraphs (H) through (N) of  
7 subsection (a)(2) misses 3 consecutive regularly  
8 scheduled Board meetings, the members of the  
9 Board may—

10                   (A) vote to remove that member; and

11                   (B) appoint another individual in accord-  
12                   ance with paragraph (4).

13           (c) CHAIRPERSON.—

14           (1) IN GENERAL.—The Board shall elect a  
15 member of the Board to serve as Chairperson of the  
16 Board.

17           (2) TERM.—The Chairperson of the Board shall  
18 serve for a term of 3 years.

19           (d) MEETINGS.—

20           (1) IN GENERAL.—The Board shall meet—

21                   (A) at the call of the Chairperson; but

22                   (B) not less frequently than twice each cal-  
23                   endar year.

24           (2) PUBLIC ACCESS.—All meetings of the  
25 Board shall be open to the public.

1 (e) PROCEDURES.—

2 (1) IN GENERAL.—The Board shall establish  
3 procedures to carry out the business of the Board,  
4 including—

5 (A) a requirement that a quorum of the  
6 members of the Board be present to transact  
7 business;

8 (B) a requirement that no recommenda-  
9 tions may be adopted by the Board, except by  
10 the vote of  $\frac{2}{3}$  of all members present and vot-  
11 ing;

12 (C) procedures for establishing national  
13 goals and priorities for aquatic habitat con-  
14 servation for the purposes of this Act;

15 (D) procedures for designating Partner-  
16 ships under section 5; and

17 (E) procedures for reviewing, evaluating,  
18 and making recommendations regarding fish  
19 habitat conservation projects.

20 (2) QUORUM.—A majority of the members of  
21 the Board shall constitute a quorum.

22 **SEC. 5. FISH HABITAT PARTNERSHIPS.**

23 (a) AUTHORITY TO DESIGNATE.—The Board may  
24 designate Fish Habitat Partnerships in accordance with  
25 this section.

1 (b) PURPOSES.—The purposes of a Partnership shall  
2 be—

3 (1) to coordinate the implementation of the Na-  
4 tional Fish Habitat Action Plan at a regional level;

5 (2) to identify strategic priorities for fish habi-  
6 tat conservation;

7 (3) to recommend to the Board fish habitat  
8 conservation projects that address a strategic pri-  
9 ority of the Board; and

10 (4) to develop and carry out fish habitat con-  
11 servation projects.

12 (c) APPLICATIONS.—An entity seeking to be des-  
13 igned as a Partnership shall submit to the Board an  
14 application at such time, in such manner, and containing  
15 such information as the Board may reasonably require.

16 (d) APPROVAL.—The Board may approve an applica-  
17 tion for a Partnership submitted under subsection (c) if  
18 the Board determines that the applicant—

19 (1) includes representatives of a diverse group  
20 of public and private partners, including Federal,  
21 State, or local governments, nonprofit entities, In-  
22 dian tribes, and private individuals, that are focused  
23 on conservation of aquatic habitats to achieve results  
24 across jurisdictional boundaries on public and pri-  
25 vate land;

1           (2) is organized to promote the health of impor-  
2           tant aquatic habitats and distinct geographical  
3           areas, keystone fish species, or system types, includ-  
4           ing reservoirs, natural lakes, coastal and marine en-  
5           vironments, and estuaries;

6           (3) identifies strategic fish and aquatic habitat  
7           priorities for the Partnership area in the form of  
8           geographical focus areas or key stressors or impair-  
9           ments to facilitate strategic planning and decision-  
10          making;

11          (4) is able to address issues and priorities on a  
12          nationally significant scale;

13          (5) includes a governance structure that—

14                (A) reflects the range of all partners; and

15                (B) promotes joint strategic planning and  
16          decisionmaking by the applicant;

17          (6) demonstrates completion of, or significant  
18          progress toward the development of, a strategic plan  
19          to address the causes of system decline in fish popu-  
20          lations, rather than simply treating symptoms in ac-  
21          cordance with the National Fish Habitat Action  
22          Plan; and

23          (7) ensures collaboration in developing a stra-  
24          tegic vision and implementation program that is sci-  
25          entifically sound and achievable.

1 **SEC. 6. FISH HABITAT CONSERVATION PROJECTS.**

2 (a) SUBMISSION TO BOARD.—Not later than March  
3 31 of each calendar year, each Partnership shall submit  
4 to the Board a list of fish habitat conservation projects  
5 recommended by the Partnership for annual funding  
6 under this Act.

7 (b) RECOMMENDATIONS BY BOARD.—Not later than  
8 July 1 of each calendar year, the Board shall submit to  
9 the Secretary a description, including estimated costs, of  
10 each fish habitat conservation project that the Board rec-  
11 ommends that the Secretary approve and fund under this  
12 Act, in order of priority, for the following fiscal year.

13 (c) CONSIDERATIONS.—The Board shall select each  
14 fish habitat conservation project to be recommended to the  
15 Secretary under subsection (b)—

16 (1) based on a recommendation of the Partner-  
17 ship that is, or will be, participating actively in ear-  
18 rying out the fish habitat conservation project; and

19 (2) after taking into consideration—

20 (A) the extent to which the fish habitat  
21 conservation project fulfills a purpose of this  
22 Act or a goal of the National Fish Habitat Ac-  
23 tion Plan;

24 (B) the extent to which the fish habitat  
25 conservation project addresses the national pri-  
26 orities established by the Board;

1           (C) the availability of sufficient non-Fed-  
2           eral funds to match Federal contributions for  
3           the fish habitat conservation project, as re-  
4           quired by subsection (e);

5           (D) the extent to which the fish habitat  
6           conservation project—

7                   (i) increases fishing opportunities for  
8                   the public;

9                   (ii) will be carried out through a coop-  
10                  erative agreement among Federal, State,  
11                  and local governments, Indian tribes, and

10 (1) REQUIREMENTS FOR EVALUATION.—No  
11 fish habitat conservation project may be rec-  
12 ommended by the Board under subsection (b) or  
13 provided financial assistance under this Act unless  
14 the fish habitat conservation project includes an  
15 evaluation plan designed—

16 (A) to appropriately assess the biological,  
17 ecological, or other results of the habitat protec-  
18 tion, restoration, or enhancement activities ear-

19 the Association of Fish and Wildlife Agencies, the  
20 consideration of fish habitat conservation projects by

22          (8) provide support to the Director regarding  
23 the development and implementation of the inter-  
24 agency operational plan under subsection (c);

1           (9) coordinate technical and scientific reporting  
2 as required by section 11;

3           (10) facilitate the efficient use of resources and  
4 activities of Federal departments and agencies to  
5 carry out this Act in an efficient manner; and

6           (11) provide support to the Board for national  
7 communication and outreach efforts that promote  
8 public awareness of fish habitat conservation.

9       (c) INTERAGENCY OPERATIONAL PLAN.—Not later  
10 than 1 year after the date of enactment of this Act, and  
11 every 5 years thereafter, the Director, in cooperation with  
12 the Assistant Administrator and the heads of other appro-  
13 priate Federal departments and agencies, shall develop an  
14 interagency operational plan for the National Fish Habi-  
15 tat Conservation Partnership Office that describes—

16           (1) the functional, operational, technical, sci-  
17 entific, and general staff, administrative, and mate-  
18 rial needs of the Office; and

19           (2) any interagency agreements between or  
20 among Federal departments and agencies to address

4 (2) STATES AND INDIAN TRIBES.—Each State  
5 and Indian tribe is encouraged to provide staff to

8 (3) DETAILEES AND CONTRACTORS.—The Na-  
9 tional Fish Habitat Conservation Partnership Office  
10 may accept staff or other administrative support  
11 from other entities—

12 (A) through interagency details; or

13 (B) as contractors.

14 (4) QUALIFICATIONS.—The staff of the Na-  
15 tional Fish Habitat Conservation Partnership Office  
16 shall include members with education and experience  
17 relating to the principles of fish, wildlife, and aquat-

19 (5) WAIVER OF REQUIREMENT.—The Secretary  
20 may waive all or part of the non-Federal contribu-

25 the requirement; and

1           (B) the probable benefit of the relevant

4           (e) REPORTS.—Not less frequently than once each  
5           year, the Director shall provide to the Board a report de-  
6           scribing the activities of the National Fish Habitat Con-  
7           servation Partnership Office.

8           **SEC. 8. TECHNICAL AND SCIENTIFIC ASSISTANCE.**

9           The Director, the Assistant Administrator, and the  
10          Director of the United States Geological Survey, in coordi-  
11          nation with the Forest Service and other appropriate Fed-  
12          eral departments and agencies, shall provide scientific and  
13          technical assistance to the Partnerships, participants in  
14          fish habitat conservation projects, and the Board, includ-  
15          ing by—

16               (1) providing technical and scientific assistance  
17               to States, Indian tribes, regions, local communities,  
18               and nongovernmental organizations in the develop-  
19               ment and implementation of Partnerships;

20               (2) providing technical and scientific assistance  
21               to Partnerships for habitat assessment, strategic  
22               planning, and prioritization;

23               (3) supporting the development and implemen-

8 for a national fish habitat assessment; and

9 (6) ensuring the availability of experts to con-  
10 duct scientifically based evaluation and reporting of  
11 the results of fish habitat conservation projects.

12 **SEC. 9. CONSERVATION OF AQUATIC HABITAT FOR FISH**  
13 **AND OTHER AQUATIC ORGANISMS ON FED-**  
14 **ERAL LAND.**

15 To the extent consistent with the mission and author-  
16 ity of the applicable department or agency, the head of  
17 each Federal department and agency responsible for ac-  
18 quiring, managing, or disposing of Federal land or water  
19 shall cooperate with the Assistant Administrator and the

22 department or agency.

23 **SEC. 10. COORDINATION WITH STATES AND INDIAN TRIBES.**

24 The Secretary shall provide a notice to, and coordi-

1 as applicable, of each State and Indian tribe within the  
2 boundaries of which an activity is planned to be carried  
3 out pursuant to this Act by not later than 30 days before

5 **SEC. 11. ACCOUNTABILITY AND REPORTING.**

9           (D) an assessment of the status of fish  
10          habitat conservation projects carried out with  
11          funds provided under this Act during that pe-  
12          riod, disaggregated by year, including—

13               (i) a description of the fish habitat  
14               conservation projects recommended by the

16               (ii) a description of each fish habitat  
17               conservation project approved by the Sec-  
18               retary under section 6(f), in order of pri-  
19               ority for funding;

20               (iii) a justification for—

12 December 31, 2010, and every 5 years thereafter, the  
13 Board shall submit to the appropriate congressional com-

16 (c) REVISIONS.—Not later than December 31, 2011,  
17 and every 5 years thereafter, the Board shall revise the  
18 goals and other elements of the National Fish Habitat Ac-  
19 tion Plan, after consideration of each report required by

21 **SEC. 12. REGULATIONS.**

22 late within a State the fishing or hunting of fish and

24 (c) **EFFECT ON INDIAN TRIBES.**—Nothing in this  
25 Act abrogates, abridges, affects, modifies, supersedes, or

1 alters any right of an Indian tribe recognized by treaty  
2 or any other means, including—

5           (2) Federal law (including regulations);

8           (d) ADJUDICATION OF WATER RIGHTS.—Nothing in

20           (2) PRIVATE PROPERTY PROTECTION.—Nothing  
21 in this Act permits the use of funds made available

12 ment.

13 **SEC. 14. NONAPPLICABILITY OF FEDERAL ADVISORY COM-**

1 **SEC. 2. FINDINGS; PURPOSE.**

10          (5) certain fish species are considered to be eco-  
11          logical indicators of aquatic habitat quality, such that  
12          the presence of those species in an aquatic ecosystem  
13          reflects high-quality habitat for other fish;

14          (6) loss and degradation of aquatic habitat, ri-  
15          parian habitat, water quality, and water volume  
16          caused by activities such as alteration of water-  
17          courses, stream blockages, water withdrawals and di-  
18          versions, erosion, pollution, sedimentation, and de-  
19          struction or modification of wetlands have—

20                (A) caused significant declines in fish popu-  
21                lations throughout the United States, especially  
22                declines in native fish populations; and

23                (B) resulted in economic losses to the  
24                United States;

1           (7)(A) *providing for the conservation and sus-*  
2           *tainability of fish and other aquatic organisms has*  
3           *not been fully realized, despite federally funded fish*  
4           *and wildlife restoration programs and other activities*  
5           *intended to conserve aquatic resources; and*

6           (B) *that conservation and sustainability may be*  
7           *significantly advanced through a renewed commit-*  
8           *ment and sustained, cooperative efforts that are com-*  
9           *plementary to existing fish and wildlife restoration*  
10          *programs and clean water programs;*

11          (8) *the National Fish Habitat Action Plan pro-*  
12          *vides a framework for maintaining and restoring*  
13          *aquatic habitats to ensure perpetuation of popu-*  
14          *lations of fish and other aquatic organisms;*

15          (9) *the United States can achieve significant*  
16          *progress toward providing aquatic habitats for the*  
17          *conservation and restoration of fish and other aquatic*  
18          *organisms through a voluntary, nonregulatory incen-*  
19          *tive program that is based on technical and financial*  
20          *assistance provided by the Federal Government;*

21          (10) *the creation of partnerships between local*  
22          *citizens, Indian tribes, Alaska Native organizations,*  
23          *corporations, nongovernmental organizations, and*  
24          *Federal, State, and tribal agencies is critical to the*

1 *success of activities to restore aquatic habitats and*  
2 *ecosystems;*

3 *(11) the Federal Government has numerous regu-*  
4 *latory and land and water management agencies that*  
5 *are critical to the implementation of the National*  
6 *Fish Habitat Action Plan, including—*

7 *(A) the United States Fish and Wildlife*  
8 *Service;*

9 *(B) the Bureau of Land Management;*

10 *(C) the National Park Service;*

11 *(D) the Bureau of Reclamation;*

12 *(E) the Bureau of Indian Affairs;*

13 *(F) the National Marine Fisheries Service;*

14 *(G) the Forest Service;*

15 *(H) the Natural Resources Conservation*  
16 *Service; and*

17 *(I) the Environmental Protection Agency;*

18 *(12) the United States Fish and Wildlife Service,*  
19 *the Forest Service, the Bureau of Land Management,*  
20 *and the National Marine Fisheries Service each play*  
21 *a vital role in—*

22 *(A) the protection, restoration, and enhance-*  
23 *ment of the fish communities and aquatic habi-*  
24 *tats in the United States; and*

1           (B) the development, operation, and long-  
2           term success of fish habitat partnerships and  
3           project implementation;

4           (13) the United States Geological Survey, the  
5           United States Fish and Wildlife Service, and the Na-  
6           tional Marine Fisheries Service each play a vital role  
7           in scientific evaluation, data collection, and mapping  
8           for fishery resources in the United States; and

9           (14) many of the programs for conservation on  
10          private farmland, ranchland, and forestland that are  
11          carried out by the Secretary of Agriculture, including  
12          the Natural Resources Conservation Service and the  
13          State and Private Forestry programs of the Forest  
14          Service, are able to significantly contribute to the im-  
15          plementation of the National Fish Habitat Action  
16          Plan through the engagement of private landowners.

17          (b) PURPOSE.—The purpose of this Act is to encourage  
18          partnerships among public agencies and other interested  
19          parties consistent with the mission and goals of the Na-  
20          tional Fish Habitat Action Plan—

21                 (1) to protect and maintain intact and healthy  
22                 aquatic habitats;

23                 (2) to prevent further degradation of aquatic  
24                 habitats that have been adversely affected;

1           (3) to reverse declines in the quality and quan-  
2           tity of aquatic habitats to improve the overall health  
3           of fish and other aquatic organisms;

4           (4) to increase the quality and quantity of  
5           aquatic habitats that support a broad natural diver-  
6           sity of fish and other aquatic species;

7           (5) to improve fisheries habitat in a manner that  
8           leads to improvement of the annual economic output  
9           from recreational, subsistence, and commercial fish-  
10          ing;

11          (6) to ensure coordination and facilitation of ac-  
12          tivities carried out by Federal departments and agen-  
13          cies under the leadership of—

14                (A) the Director of the United States Fish  
15                and Wildlife Service;

16                (B) the Assistant Administrator for Fish-  
17                eries of the National Oceanic and Atmospheric  
18                Administration; and

19                (C) the Director of the United States Geo-  
20                logical Survey; and

21          (7) to achieve other purposes in accordance with  
22          the mission and goals of the National Fish Habitat  
23          Action Plan.

24 **SEC. 3. DEFINITIONS.**

25          *In this Act:*

1           (1) *APPROPRIATE CONGRESSIONAL COMMIT-*  
2           *TEES.*—*The term “appropriate congressional commit-*  
3           *tees” means—*

4                   (A) *the Committee on Commerce, Science,*  
5                   *and Transportation and the Committee on Envi-*  
6                   *ronment and Public Works of the Senate; and*

7                   (B) *the Committee on Natural Resources of*  
8                   *the House of Representatives.*

9           (2) *AQUATIC HABITAT.*—

10                   (A) *IN GENERAL.*—*The term “aquatic habi-*  
11                   *tat” means any area on which an aquatic orga-*  
12                   *nism depends, directly or indirectly, to carry out*  
13                   *the life processes of the organism, including an*  
14                   *area used by the organism for spawning, incuba-*  
15                   *tion, nursery, rearing, growth to maturity, food*  
16                   *supply, or migration.*

17                   (B) *INCLUSIONS.*—*The term “aquatic habi-*  
18                   *tat” includes an area adjacent to an aquatic en-*  
19                   *vironment, if the adjacent area—*

20                           (i) *contributes an element, such as the*  
21                           *input of detrital material or the promotion*  
22                           *of a planktonic or insect population pro-*  
23                           *viding food, that makes fish life possible;*

24                           (ii) *protects the quality and quantity*  
25                           *of water sources;*

1                   (iii) provides public access for the use  
2                   of fishery resources; or

3                   (iv) serves as a buffer protecting the  
4                   aquatic environment.

5                   (3) ASSISTANT ADMINISTRATOR.—The term “As-  
6                   sistant Administrator” means the Assistant Adminis-  
7                   trator for Fisheries of the National Oceanic and At-  
8                   mospheric Administration.

9                   (4) BOARD.—The term “Board” means the Na-  
10                  tional Fish Habitat Board established by section  
11                  4(a)(1).

12                  (5) CONSERVATION; CONSERVE; MANAGE; MAN-  
13                  AGEMENT.—The terms “conservation”, “conserve”,  
14                  “manage”, and “management” mean to protect, sus-  
15                  tain, and, where appropriate, restore and enhance,  
16                  using methods and procedures associated with modern  
17                  scientific resource programs (including protection, re-  
18                  search, census, law enforcement, habitat management,  
19                  propagation, live trapping and transplantation, and  
20                  regulated taking)—

21                         (A) a healthy population of fish, wildlife, or  
22                         plant life;

23                         (B) a habitat required to sustain fish, wild-  
24                         life, or plant life; or

1           (C) a habitat required to sustain fish, wild-  
2           life, or plant life productivity.

3           (6) *DIRECTOR.*—The term “Director” means the  
4           Director of the United States Fish and Wildlife Serv-  
5           ice.

6           (7) *FISH.*—

7           (A) *IN GENERAL.*—The term “fish” means  
8           any freshwater, diadromous, estuarine, or ma-  
9           rine finfish or shellfish.

10          (B) *INCLUSIONS.*—The term “fish” includes  
11          the egg, spawn, spat, larval, and other juvenile  
12          stages of an organism described in subparagraph  
13          (A).

14          (8) *FISH HABITAT CONSERVATION PROJECT.*—

15          (A) *IN GENERAL.*—The term “fish habitat  
16          conservation project” means a project that—

17               (i) is submitted to the Board by a  
18               Partnership and approved by the Secretary  
19               under section 6; and

20               (ii) provides for the conservation or  
21               management of an aquatic habitat.

22          (B) *INCLUSIONS.*—The term “fish habitat  
23          conservation project” includes—

24               (i) the provision of technical assistance  
25               to a State, Indian tribe, or local community

1           by the National Fish Habitat Conservation  
2           Partnership Office or any other agency to  
3           facilitate the development of strategies and  
4           priorities for the conservation of aquatic  
5           habitats; or

6           (ii) the obtaining of a real property  
7           interest in land or water, including water  
8           rights, in accordance with terms and condi-  
9           tions that ensure that the real property will  
10          be administered for the long-term conserva-  
11          tion of—

12                           (I) the land or water; and

13                           (II) the fish dependent on the land  
14                           or water.

15           (9) *INDIAN TRIBE*.—The term “Indian tribe” has  
16           the meaning given the term in section 4 of the Indian  
17           Self-Determination and Education Assistance Act (25  
18           U.S.C. 450b).

19           (10) *NATIONAL FISH HABITAT ACTION PLAN*.—  
20           The term “National Fish Habitat Action Plan”  
21           means the National Fish Habitat Action Plan dated  
22           April 24, 2006, and any subsequent revisions or  
23           amendments to that plan.

24           (11) *PARTNERSHIP*.—The term “Partnership”  
25           means an entity designated by the Board as a Fish

1       *Habitat Conservation Partnership pursuant to section*  
2       5(a).

3           (12) *REAL PROPERTY INTEREST.*—*The term*  
4       “*real property interest*” *means an ownership interest*  
5       *in—*

6           (A) *land;*

7           (B) *water (including water rights); or*

8           (C) *a building or object that is permanently*  
9       *affixed to land.*

10          (13) *SECRETARY.*—*The term “Secretary” means*  
11       *the Secretary of the Interior.*

12          (14) *STATE AGENCY.*—*The term “State agency”*  
13       *means—*

14           (A) *the fish and wildlife agency of a State;*

15           (B) *any department or division of a depart-*  
16       *ment or agency of a State that manages in the*  
17       *public trust the inland or marine fishery re-*  
18       *sources or the habitat for those fishery resources*  
19       *of the State pursuant to State law or the con-*  
20       *stitution of the State; or*

21           (C) *the fish and wildlife agency of the Com-*  
22       *monwealth of Puerto Rico, Guam, the Virgin Is-*  
23       *lands, or any other territory or possession of the*  
24       *United States.*

1 **SEC. 4. NATIONAL FISH HABITAT BOARD.**

2 (a) *ESTABLISHMENT.*—

3 (1) *IN GENERAL.*—*There is established a board,*  
4 *to be known as the “National Fish Habitat Board”—*

5 (A) *to promote, oversee, and coordinate the*  
6 *implementation of this Act and the National*  
7 *Fish Habitat Action Plan;*

8 (B) *to establish national goals and prior-*  
9 *ities for aquatic habitat conservation;*

10 (C) *to designate Partnerships; and*

11 (D) *to review and make recommendations*  
12 *regarding fish habitat conservation projects.*

13 (2) *MEMBERSHIP.*—*The Board shall be composed*  
14 *of 27 members, of whom—*

15 (A) *1 shall be the Director;*

16 (B) *1 shall be the Assistant Administrator;*

17 (C) *1 shall be the Chief of the Natural Re-*  
18 *sources Conservation Service;*

19 (D) *1 shall be the Chief of the Forest Serv-*  
20 *ice;*

21 (E) *1 shall be the Assistant Administrator*  
22 *for Water of the Environmental Protection Agen-*  
23 *cy;*

24 (F) *1 shall be the President of the Associa-*  
25 *tion of Fish and Wildlife Agencies;*

1           (G) 1 shall be the Secretary of the Board of  
2           Directors of the National Fish and Wildlife  
3           Foundation appointed pursuant to section  
4           3(g)(2)(B) of the National Fish and Wildlife  
5           Foundation Establishment Act (16 U.S.C.  
6           3702(g)(2)(B));

7           (H) 4 shall be representatives of State agen-  
8           cies, 1 of whom shall be nominated by a regional  
9           association of fish and wildlife agencies from  
10          each of the Northeast, Southeast, Midwest, and  
11          Western regions of the United States;

12          (I) 1 shall be a representative of the Amer-  
13          ican Fisheries Society;

14          (J) 2 shall be representatives of Indian  
15          tribes, of whom—

16               (i) 1 shall represent Indian tribes from  
17               the State of Alaska; and

18               (ii) 1 shall represent Indian tribes  
19               from the other States;

20          (K) 1 shall be a representative of the Re-  
21          gional Fishery Management Councils established  
22          under section 302 of the Magnuson-Stevens Fish-  
23          ery Conservation and Management Act (16  
24          U.S.C. 1852);

1                   (L) 1 shall be a representative of the Marine  
2 Fisheries Commissions, which is composed of—

3                   (i) the Atlantic States Marine Fish-  
4 eries Commission;

5                   (ii) the Gulf States Marine Fisheries  
6 Commission; and

7                   (iii) the Pacific States Marine Fish-  
8 eries Commission;

9                   (M) 1 shall be a representative of the  
10 Sportfishing and Boating Partnership Council;  
11 and

12                   (N) 10 shall be representatives selected from  
13 each of the following groups:

14                   (i) The recreational sportfishing indus-  
15 try.

16                   (ii) The commercial fishing industry.

17                   (iii) Marine recreational anglers.

18                   (iv) Freshwater recreational anglers.

19                   (v) Terrestrial resource conservation  
20 organizations.

21                   (vi) Aquatic resource conservation or-  
22 ganizations.

23                   (vii) The livestock and poultry produc-  
24 tion industry.

25                   (viii) The land development industry.

1                   *(ix) The row crop industry.*

2                   *(x) Natural resource commodity inter-*  
3                   *ests, such as petroleum or mineral extrac-*  
4                   *tion.*

5                   (3) *COMPENSATION.*—*A member of the Board*  
6                   *shall serve without compensation.*

7                   (4) *TRAVEL EXPENSES.*—*A member of the Board*  
8                   *shall be allowed travel expenses, including per diem*  
9                   *in lieu of subsistence, at rates authorized for an em-*  
10                  *ployee of an agency under subchapter I of chapter 57*  
11                  *of title 5, United States Code, while away from the*  
12                  *home or regular place of business of the member in*  
13                  *the performance of the duties of the Board.*

14                  (b) *APPOINTMENT AND TERMS.*—

15                  (1) *IN GENERAL.*—*Except as otherwise provided*  
16                  *in this subsection, a member of the Board described*  
17                  *in any of subparagraphs (H) through (N) of sub-*  
18                  *section (a)(2) shall serve for a term of 3 years.*

19                  (2) *INITIAL BOARD MEMBERSHIP.*—

20                  (A) *IN GENERAL.*—*Not later than 180 days*  
21                  *after the date of enactment of this Act, the rep-*  
22                  *resentatives of the board established by the Na-*  
23                  *tional Fish Habitat Action Plan shall appoint*  
24                  *the initial members of the Board described in*

1           subparagraphs (H) through (I) and (K) through  
2           (N) of subsection (a)(2).

3           (B) *TRIBAL REPRESENTATIVES.*—Not later  
4           than 180 days after the enactment of this Act,  
5           the Secretary shall provide to the board estab-  
6           lished by the National Fish Habitat Action Plan  
7           a recommendation of not less than 4 tribal rep-  
8           resentatives, from which that board shall appoint  
9           2 representatives pursuant to subparagraph (J)  
10          of subsection (a)(2).

11          (3) *TRANSITIONAL TERMS.*—Of the members de-  
12          scribed in subsection (a)(2)(N) initially appointed to  
13          the Board—

14                (A) 4 shall be appointed for a term of 1  
15                year;

16                (B) 4 shall be appointed for a term of 2  
17                years; and

18                (C) 3 shall be appointed for a term of 3  
19                years.

20          (4) *VACANCIES.*—

21                (A) *IN GENERAL.*—A vacancy of a member  
22                of the Board described in any of subparagraphs  
23                (H) through (I) or (K) through (N) of subsection  
24                (a)(2) shall be filled by an appointment made by  
25                the remaining members of the Board.

1           (B) *TRIBAL REPRESENTATIVES.*—*Following*  
 2           *a vacancy of a member of the Board described in*  
 3           *subparagraph (J) of subsection (a)(2), the Sec-*  
 4           *retary shall recommend to the Board not less*  
 5           *than 4 tribal representatives, from which the re-*  
 6           *maining members of the Board shall appoint a*  
 7           *representative to fill the vacancy.*

8           (5) *CONTINUATION OF SERVICE.*—*An individual*  
 9           *whose term of service as a member of the Board ex-*  
 10          *pires may continue to serve on the Board until a suc-*  
 11          *cessor is appointed.*

12          (6) *REMOVAL.*—*If a member of the Board de-*  
 13          *scribed in any of subparagraphs (H) through (N) of*  
 14          *subsection (a)(2) misses 3 consecutive regularly sched-*  
 15          *uled Board meetings, the members of the Board*  
 16          *may—*

17                   (A) *vote to remove that member; and*

18                   (B) *appoint another individual in accord-*  
 19                   *ance with paragraph (4).*

20          (c) *CHAIRPERSON.*—

21                   (1) *IN GENERAL.*—*The Board shall elect a mem-*  
 22                   *ber of the Board to serve as Chairperson of the Board.*

23                   (2) *TERM.*—*The Chairperson of the Board shall*  
 24                   *serve for a term of 3 years.*

25          (d) *MEETINGS.*—

1           (1) *IN GENERAL.*—*The Board shall meet—*

2                   (A) *at the call of the Chairperson; but*

3                   (B) *not less frequently than twice each cal-*  
4                   *endar year.*

5           (2) *PUBLIC ACCESS.*—*All meetings of the Board*  
6           *shall be open to the public.*

7           (e) *PROCEDURES.*—

8                   (1) *IN GENERAL.*—*The Board shall establish pro-*  
9                   *cedures to carry out the business of the Board, includ-*  
10                   *ing—*

11                           (A) *a requirement that a quorum of the*  
12                           *members of the Board be present to transact*  
13                           *business;*

14                           (B) *a requirement that no recommendations*  
15                           *may be adopted by the Board, except by the vote*  
16                           *of  $\frac{2}{3}$  of all members present and voting;*

17                           (C) *procedures for establishing national*  
18                           *goals and priorities for aquatic habitat conserva-*  
19                           *tion for the purposes of this Act;*

20                           (D) *procedures for designating Partnerships*  
21                           *under section 5; and*

22                           (E) *procedures for reviewing, evaluating,*  
23                           *and making recommendations regarding fish*  
24                           *habitat conservation projects.*

1           (2) *QUORUM.*—A majority of the members of the  
2       Board shall constitute a quorum.

3 **SEC. 5. FISH HABITAT PARTNERSHIPS.**

4       (a) *AUTHORITY TO DESIGNATE.*—The Board may des-  
5       ignate Fish Habitat Partnerships in accordance with this  
6       section.

7       (b) *PURPOSES.*—The purposes of a Partnership shall  
8       be—

9           (1) to coordinate the implementation of the Na-  
10       tional Fish Habitat Action Plan at a regional level;

11          (2) to identify strategic priorities for fish habitat  
12       conservation;

13          (3) to recommend to the Board fish habitat con-  
14       servation projects that address a strategic priority of  
15       the Board; and

16          (4) to develop and carry out fish habitat con-  
17       servation projects.

18       (c) *APPLICATIONS.*—An entity seeking to be designated  
19       as a Partnership shall submit to the Board an application  
20       at such time, in such manner, and containing such infor-  
21       mation as the Board may reasonably require.

22       (d) *APPROVAL.*—The Board may approve an applica-  
23       tion for a Partnership submitted under subsection (c) if the  
24       Board determines that the applicant—

1           (1) includes representatives of a diverse group of  
2           public and private partners, including Federal, State,  
3           or local governments, nonprofit entities, Indian tribes,  
4           and private individuals, that are focused on conserva-  
5           tion of aquatic habitats to achieve results across jurisdic-  
6           tional boundaries on public and private land;

7           (2) is organized to promote the health of impor-  
8           tant aquatic habitats and distinct geographical areas,  
9           keystone fish species, or system types, including res-  
10          ervoirs, natural lakes, coastal and marine environ-  
11          ments, and estuaries;

12          (3) identifies strategic fish and aquatic habitat  
13          priorities for the Partnership area in the form of geo-  
14          graphical focus areas or key stressors or impairments  
15          to facilitate strategic planning and decisionmaking;

16          (4) is able to address issues and priorities on a  
17          nationally significant scale;

18          (5) includes a governance structure that—

19                (A) reflects the range of all partners; and

20                (B) promotes joint strategic planning and  
21                decisionmaking by the applicant;

22          (6) demonstrates completion of, or significant  
23          progress toward the development of, a strategic plan  
24          to address the causes of system decline in fish popu-  
25          lations, rather than simply treating symptoms in ac-

1 *cordance with the National Fish Habitat Action*  
 2 *Plan; and*

3 *(7) ensures collaboration in developing a stra-*  
 4 *tegic vision and implementation program that is sci-*  
 5 *entifically sound and achievable.*

6 **SEC. 6. FISH HABITAT CONSERVATION PROJECTS.**

7 *(a) SUBMISSION TO BOARD.—Not later than March 31*  
 8 *of each calendar year, each Partnership shall submit to the*  
 9 *Board a list of fish habitat conservation projects rec-*  
 10 *ommended by the Partnership for annual funding under*  
 11 *this Act.*

12 *(b) RECOMMENDATIONS BY BOARD.—Not later than*  
 13 *July 1 of each calendar year, the Board shall submit to*  
 14 *the Secretary a description, including estimated costs, of*  
 15 *each fish habitat conservation project that the Board rec-*  
 16 *ommends that the Secretary approve and fund under this*  
 17 *Act, in order of priority, for the following fiscal year.*

18 *(c) CONSIDERATIONS.—The Board shall select each fish*  
 19 *habitat conservation project to be recommended to the Sec-*  
 20 *retary under subsection (b)—*

21 *(1) based on a recommendation of the Partner-*  
 22 *ship that is, or will be, participating actively in car-*  
 23 *rying out the fish habitat conservation project; and*

24 *(2) after taking into consideration—*

1           (A) *the extent to which the fish habitat con-*  
2 *servaion project fulfills a purpose of this Act or*  
3 *a goal of the National Fish Habitat Action Plan;*

4           (B) *the extent to which the fish habitat con-*  
5 *servaion project addresses the national priorities*  
6 *established by the Board;*

7           (C) *the availability of sufficient non-Fed-*  
8 *eral funds to match Federal contributions for the*  
9 *fish habitat conservaion project, as required by*  
10 *subsection (e);*

11           (D) *the extent to which the fish habitat con-*  
12 *servaion project—*

13               (i) *increases fishing opportunities for*  
14 *the public;*

15               (ii) *will be carried out through a coop-*  
16 *erative agreement among Federal, State,*  
17 *and local governments, Indian tribes, and*  
18 *private entities;*

19               (iii) *increases public access to land or*  
20 *water;*

21               (iv) *advances the conservaion of fish*  
22 *and wildlife species that are listed, or are*  
23 *candidates to be listed, as threatened species*  
24 *or endangered species under the Endangered*

1                   *Species Act of 1973 (16 U.S.C. 1531 et*  
2                   *seq.);*

3                   *(v) where appropriate, advances the*  
4                   *conservation of fish and fish habitats under*  
5                   *the Magnuson-Stevens Act (16 U.S.C. 1801*  
6                   *et seq.) and other relevant Federal law and*  
7                   *State wildlife action plans; and*

8                   *(vi) promotes resilience such that de-*  
9                   *sired biological communities are able to per-*  
10                  *sist and adapt to environmental stressors*  
11                  *such as climate change; and*

12                  *(E) the substantiality of the character and*  
13                  *design of the fish habitat conservation project.*

14                  *(d) LIMITATIONS.—*

15                  *(1) REQUIREMENTS FOR EVALUATION.—No fish*  
16                  *habitat conservation project may be recommended by*  
17                  *the Board under subsection (b) or provided financial*  
18                  *assistance under this Act unless the fish habitat con-*  
19                  *servation project includes an evaluation plan de-*  
20                  *signed—*

21                  *(A) to appropriately assess the biological,*  
22                  *ecological, or other results of the habitat protec-*  
23                  *tion, restoration, or enhancement activities car-*  
24                  *ried out using the assistance;*

1           (B) to reflect appropriate changes to the fish  
 2           habitat conservation project if the assessment  
 3           substantiates that the fish habitat conservation  
 4           project objectives are not being met; and

5           (C) to require the submission to the Board  
 6           of a report describing the findings of the assess-  
 7           ment.

8           (2) ACQUISITION OF REAL PROPERTY INTER-  
 9           ESTS.—

10           (A) IN GENERAL.—No fish habitat conserva-  
 11           tion project that will result in the acquisition by  
 12           the State, local government, or other non-Federal  
 13           entity, in whole or in part, of any real property  
 14           interest may be recommended by the Board  
 15           under subsection (b) or provided financial assist-  
 16           ance under this Act unless the project meets the  
 17           requirements of subparagraph (B).

18           (B) REQUIREMENTS.—

19           (i) IN GENERAL.—A real property in-  
 20           terest may not be acquired pursuant to a  
 21           fish habitat conservation project by a State,  
 22           public agency, or other non-Federal entity  
 23           unless the State, agency, or other non-Fed-  
 24           eral entity is obligated to undertake the

1           *management of the property being acquired*  
2           *in accordance with the purposes of this Act.*

3           (ii) *ADDITIONAL CONDITIONS.—Any*  
4           *real property interest acquired by a State,*  
5           *local government, or other non-Federal enti-*

7           *project shall be subject to terms and condi-*  
8           *tions that ensure that the interest will be*  
9           *administered for the long-term conservation*  
10           *and management of the aquatic ecosystem*  
11           *and the fish and wildlife dependent on that*  
12           *ecosystem.*

13       (e) *NON-FEDERAL CONTRIBUTIONS.—*

14           (1) *IN GENERAL.—Except as provided in para-*  
15           *graph (2), no fish habitat conservation project may be*  
16           *recommended by the Board under subsection (b) or*  
17           *provided financial assistance under this Act unless at*  
18           *least 50 percent of the cost of the fish habitat con-*  
19           *servation project will be funded with non-Federal*  
20           *funds.*

21           (2) *PROJECTS ON FEDERAL LAND OR WATER.—*  
22           *Notwithstanding paragraph (1), Federal funds may*  
23           *be used for payment of 100 percent of the costs of a*  
24           *fish habitat conservation project located on Federal*

1       *land or water, including the acquisition of inholdings*  
2       *within such land or water.*

3               (3) *NON-FEDERAL SHARE.*—*The non-Federal*  
4       *share of the cost of a fish habitat conservation*  
5       *project—*

6                       (A) *may not be derived from a Federal*  
7               *grant program; but*

8                       (B) *may include in-kind contributions and*  
9               *cash.*

10               (4) *SPECIAL RULE FOR INDIAN TRIBES.*—*Not-*  
11       *withstanding paragraph (1) or any other provision of*  
12       *law, any funds made available to an Indian tribe*  
13       *pursuant to this Act may be considered to be non-*  
14       *Federal funds for the purpose of paragraph (1).*

15       (f) *APPROVAL.*—

16               (1) *IN GENERAL.*—*Not later than 180 days after*  
17       *the date of receipt of the recommendations of the*  
18       *Board for fish habitat conservation projects under*  
19       *subsection (b), and based, to the maximum extent*  
20       *practicable, on the criteria described in subsection*  
21       *(c)—*

22                       (A) *the Secretary shall approve, reject, or*  
23               *reorder the priority of any fish habitat conserva-*  
24               *tion project recommended by the Board that is*  
25               *not within a marine or estuarine habitat; and*

1           (B) the Secretary and the Secretary of Com-  
2 merce shall jointly approve, reject, or reorder the  
3 priority of any fish habitat conservation project  
4 recommended by the Board that is within a ma-  
5 rine or estuarine habitat.

6           (2) *FUNDING.*—If the Secretary, or the Secretary  
7 and the Secretary of Commerce jointly, approves a  
8 fish habitat conservation project under paragraph (1),  
9 the Secretary, or the Secretary and the Secretary of  
10 Commerce jointly, shall use amounts made available  
11 to carry out this Act to provide funds to carry out  
12 the fish habitat conservation project.

13           (3) *NOTIFICATION.*—If the Secretary, or the Sec-  
14 retary and the Secretary of Commerce jointly, rejects  
15 or reorders the priority of any fish habitat conserva-  
16 tion project recommended by the Board under sub-

18 Secretary of Commerce jointly, shall provide to the

14          (9) *coordinate technical and scientific reporting*

17 *activities of Federal departments and agencies to*  
18 *carry out this Act in an efficient manner; and*

19          (11) *provide support to the Board for national*  
20 *communication and outreach efforts that promote*  
21 *public awareness of fish habitat conservation.*

22          (c) *INTERAGENCY OPERATIONAL PLAN.—Not later*  
23 *than 1 year after the date of enactment of this Act, and*  
24 *every 5 years thereafter, the Director, in cooperation with*  
25 *the Assistant Administrator and the heads of other appro-*

1 *appropriate Federal departments and agencies, shall develop an*  
2 *interagency operational plan for the National Fish Habitat*  
3 *Conservation Partnership Office that describes—*

4           (1) *the functional, operational, technical, sci-*  
5 *entific, and general staff, administrative, and mate-*  
6 *rial needs of the Office; and*

7           (2) *any interagency agreements between or*

1 **SEC. 9. CONSERVATION OF AQUATIC HABITAT FOR FISH**  
2 **AND OTHER AQUATIC ORGANISMS ON FED-**  
3 **ERAL LAND.**

4 *To the extent consistent with the mission and author-*  
5 *ity of the applicable department or agency, the head of each*  
6 *Federal department and agency responsible for acquiring,*

16                   (C) *a description of the opportunities for*  
17 *public fishing established under the National*  
18 *Fish Habitat Action Plan during that period;*  
19 *and*

20                   (D) *an assessment of the status of fish habi-*  
21 *tat conservation projects carried out with funds*  
22 *provided under this Act during that period,*  
23 *disaggregated by year, including—*

1           (i) a description of the fish habitat  
2           conservation projects recommended by the  
3           Board under section 6(b);

4           (ii) a description of each fish habitat  
5           conservation project approved by the Sec-  
6           retary under section 6(f), in order of pri-  
7           ority for funding;

8           (iii) a justification for—

9                   (I) the approval of each fish habi-  
10                  tat conservation project; and

11                   (II) the order of priority for fund-  
12                  ing of each fish habitat conservation  
13                  project;

14           (iv) a justification for any rejection or  
15           reordering of the priority of each fish habi-  
16           tat conservation project recommended by the  
17           Board under section 6(b) that was based on  
18           a factor other than the criteria described in  
19           section 6(c); and

20           (v) an accounting of expenditures by  
21           Federal, State, or local governments, Indian  
22           tribes, or other entities to carry out fish  
23           habitat conservation projects.

24           (b) *STATUS AND TRENDS REPORT.*—Not later than  
25           December 31, 2010, and every 5 years thereafter, the Board

1 *shall submit to the appropriate congressional committees a*  
2 *report describing the status of aquatic habitats in the*  
3 *United States.*

4 *(c) REVISIONS.—Not later than December 31, 2011,*  
5 *and every 5 years thereafter, the Board shall revise the goals*  
6 *and other elements of the National Fish Habitat Action*  
7 *Plan, after consideration of each report required by sub-*  
8 *section (b).*

9 **SEC. 12. REGULATIONS.**

10 *The Secretary may promulgate such regulations as the*

12 **SEC. 13. EFFECT OF ACT.**

13 *(a) WATER RIGHTS.—Nothing in this Act—*

14 *(1) establishes any express or implied reserved*

18 *(3) affects any Federal or State law in existence*

5           *abrogates, abridges, affects, modifies, supersedes, or alters*

9                 *the United States;*

10                (2) *Federal law (including regulations);*

11                (3) *an Executive order; or*

12                (4) *a judicial decree.*

13           (d) *ADJUDICATION OF WATER RIGHTS.—Nothing in*  
14           *this Act diminishes or affects the ability of the Secretary*  
15           *to join an adjudication of rights to the use of water pursu-*  
16           *ant to subsection (a), (b), or (c) of section 208 of the Depart-*  
17           *ment of Justice Appropriation Act, 1953 (43 U.S.C. 666).*

18           (e) *EFFECT ON OTHER AUTHORITIES.—*

19                 (1) *ACQUISITION OF LAND AND WATER.—Nothing*  
20                 *in this Act alters or otherwise affects the authorities,*  
21                 *responsibilities, obligations, or powers of the Sec-*  
22                 *retary to acquire land, water, or an interest in land*  
23                 *or water under any other provision of law.*

24                 (2) *PRIVATE PROPERTY PROTECTION.—Nothing*
