SCHUMER) introduced the following bill; which was read twice and re-
ferred to the Committee on Finance

A BILL

To provide for duty-free treatment of certain recreational
performance outerwear, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “United States Optimal
5 Use of Trade to Develop Outerwear and Outdoor Recre-
6 ation Act” or the “U.S. OUTDOOR Act”.

7 **SEC. 2. FINDINGS.**

8 Congress finds the following:

1 (1) The outdoor industry contributes
2 \$730,000,000,000 to the United States economy an-
3 nually.

4 (2) Outdoor activities are vitally important to
5 the health and well-being of the people of the United
6 States.

7 (3) Duty rates on recreational performance ap-
8 parel are among the highest duty rates imposed by
9 the United States Government, with duties on some
10 recreational performance apparel as high as 28.2
11 percent.

12 (4) The duties currently imposed by the United
13 States on recreational performance apparel were set
14 in an era during which high rates of duty were in-
15 tended to protect the production of other apparel in
16 the United States, and before the technologies and
17 innovations that create today's recreational perform-
18 ance apparel industry were developed.

19 (5) In July 2007, the International Trade Com-
20 mission confirmed in USITC Publication 3937 that
21 recreational performance apparel produced in the
22 United States makes up less than 1 percent of the
23 total recreational performance apparel market and
24 therefore concluded that there is no commercially

1 viable production of recreational performance ap-
2 parel in the United States.

3 (6) On November 1, 2005, the Committee for
4 the Implementation of Textile Agreements confirmed
5 in the Federal Register that imports of certain rec-
6 reational performance apparel do not contribute to
7 domestic market disruption or adversely affect
8 United States textile and apparel producers (70 Fed.
9 Reg. 65889).

10 (7) The elimination of duties on the importation
11 of certain recreational performance apparel would
12 provide an economic benefit to United States con-
13 sumers of outdoor products and would promote in-
14 creased participation in healthy and active lifestyles.

15 **SEC. 3. KNIT APPAREL AND ACCESSORIES.**

16 (a) DEFINITIONS.—The Additional U.S. Note to
17 Chapter 61 of the Harmonized Tariff Schedule of the
18 United States is amended—

19 (1) in the heading, by striking “Additional U.S.
20 Note” and inserting “Additional U.S. Notes”; and

21 (2) by adding at the end the following new
22 notes:

23 “2. (a) For purposes of this chapter, the term ‘rec-
24 reational performance outerwear’ means trousers (includ-
25 ing, but not limited to, paddling pants, ski or snowboard

1 pants, and ski or snowboard pants intended for sale as
2 parts of ski-suits), coveralls and bib overalls, and jackets
3 (including, but not limited to, full zip jackets, paddling
4 jackets, ski jackets, and ski jackets intended for sale as
5 parts of ski-suits), windbreakers, and similar articles (in-
6 cluding padded, sleeveless jackets) predominately com-
7 posed of knit fabrics of cotton, wool, hemp, bamboo, silk,
8 or manmade fiber, or a combination of such fibers, that
9 are either water-resistant or visibly coated, or both, with
10 critically sealed seams, and with 5 or more of the following
11 features:

12 “(i) Insulation for cold weather protection.

13 “(ii) Pockets, at least one of which has a
14 zippered, hook and loop, or other type of closure.

15 “(iii) Elastic, drawcord, or other means of
16 tightening around the waist or leg hems, including
17 hidden leg sleeves with a means of tightening at the
18 ankle for trousers and tightening around the waist
19 or bottom hem for jackets.

20 “(iv) Venting, not including grommet(s).

21 “(v) Articulated elbows or knees.

22 “(vi) Reinforcement in one of the following
23 areas: the elbows, shoulders, seat, knees, or ankles
24 or cuffs.

1 “(vii) Weatherproof closure at the waist or
2 front.

3 “(viii) Multi-adjustable hood or adjustable col-
4 lar.

5 “(ix) Adjustable powder skirt, inner protective
6 skirt, or adjustable inner protective cuff at sleeve
7 hem.

8 “(x) Construction at the arm gusset that uti-
9 lizes fabric, design, or patterning to allow radial arm
10 movement.

11 “(xi) Odor control technology.

12 The term ‘recreational performance outerwear’ does not
13 include occupational outerwear or garments with an outer
14 surface predominantly of looped pile.

15 “(b) For purposes of this Note, the following terms
16 have the following meanings:

17 “(i) The term ‘water-resistant’ means that a
18 garment must have a water resistance (see ASTM
19 designations D 3779–81 and D 7017) such that,
20 under a head pressure of 600 millimeters, not more
21 than 1.0 gram of water penetrates after two minutes
22 when tested in accordance with the current version
23 of AATCC Test Method 35. The water resistance of
24 the garment is the result of a rubber or plastics ap-
25 plication to the outer shell, lining, or inner lining.

1 “(ii) The term ‘visibly coated’ refers to fabric
2 that is impregnated, coated, covered, or laminated
3 with plastics, such as fabrics described in Note 2 to
4 chapter 59.

5 “(iii) The term ‘sealed seams’ means seams
6 that have been covered by means of taping, gluing,
7 bonding, cementing, fusing, welding, or a similar
8 process so that water cannot pass through the seams
9 when tested in accordance with the current version
10 of AATCC Test Method 35.

11 “(iv) The term ‘critically sealed seams’
12 means—

13 “(A) for jackets, sealed seams that are
14 sealed at the front and back yokes, or at the
15 shoulders, arm holes, or both, where applicable;
16 and

17 “(B) for trousers, sealed seams that are
18 sealed at the front (up to the zipper or other
19 means of closure) and back rise.

20 “(v) The term ‘insulation for cold weather pro-
21 tection’ means insulation with either synthetic fill,
22 down, a laminated thermal backing, or other lining
23 for thermal protection from cold weather.

24 “(vi) The term ‘venting’ refers to closeable or
25 permanent constructed openings in a garment (ex-

cluding front, primary zipper closures and grommet(s)) to allow increased expulsion of built-up heat during outdoor activities. In a jacket, such openings are often positioned on the underarm seam of a garment but may also be placed along other seams in the front or back of a garment. In trousers, such openings are often positioned on the inner or outer leg seams of a garment but may also be placed along other seams in the front or back of a garment.

“(vii) The term ‘articulated elbows or knees’ refers to the construction of a sleeve (or pant leg) to allow improved mobility at the elbow (or knee) through the use of extra seams, darts, gussets, or other means.

“(viii) The term ‘reinforcement’ refers to the use of a double layer of fabric or section(s) of fabric that is abrasion-resistant or otherwise more durable than the predominant or face fabric of the garment.

“(ix) The term ‘weatherproof closure’ means a closure (including, but not limited to, laminated or coated zippers, storm flaps, or other weatherproof construction) that has been reinforced or engineered in a manner to reduce the penetration or absorption of moisture or air through an opening in the garment.

1 “(x) The term ‘multi-adjustable hood or adjust-
2 able collar’ means a draw cord, adjustment tab, or
3 elastic incorporated into the hood or collar construc-
4 tion to allow volume adjustments around a helmet,
5 the crown of the head, neck, or face.

6 “(xi) The terms ‘adjustable powder skirt’ and
7 ‘inner protective skirt’ refer to a partial lower inner
8 lining with means of tightening around the waist for
9 additional protection from the elements.

10 “(xii) The term ‘arm gusset’ means construc-
11 tion at the arm of a gusset that utilizes an extra
12 fabric piece in the under arm usually diamond- or
13 triangular-shaped, design, or pattern to allow radial
14 arm movement.

15 “(xiii) The term ‘radial arm movement’ refers
16 to unrestricted, 180-degree range of motion for the
17 arm while wearing performance outerwear.

18 “(xiv) The term ‘odor control technology’ means
19 an additive in a fabric or garment capable of adsorb-
20 ing, absorbing, or reacting with human odors, or ef-
21 fective in reducing odor-causing bacteria, including
22 but not limited to activated carbon, silver, copper, or
23 any combination thereof.

24 “(xv) The term ‘occupational outerwear’ means
25 outerwear garments, including uniforms, designed or

1 marketed for use in the workplace or at a worksite
 2 to provide durable protection from cold or inclement
 3 weather and/or workplace hazards, such as fire, elec-
 4 trical, abrasion, or chemical hazards, or impacts,
 5 cuts, punctures, or similar hazards.

6 “3. For purposes of this chapter, the importer of
 7 record shall specify upon entry whether garments claimed
 8 as recreational performance outerwear have an outer sur-
 9 face that is water-resistant, visibly coated, or a combina-
 10 tion thereof, and shall further enumerate the specific fea-
 11 tures that make the garments eligible to be classified as
 12 recreational performance outerwear.”.

26 “(i) Insulation for cold weather protection.

1 “(ii) Pockets, at least one of which has a
2 zippered, hook and loop, or other type of closure.

3 “(iii) Elastic, drawcord, or other means of
4 tightening around the waist or leg hems, including
5 hidden leg sleeves with a means of tightening at the
6 ankle for trousers and tightening around the waist
7 or bottom hem for jackets.

8 “(iv) Venting, not including grommet(s).

9 “(v) Articulated elbows or knees.

10 “(vi) Reinforcement in one of the following
11 areas: the elbows, shoulders, seat, knees, or ankles
12 or cuffs.

13 “(vii) Weatherproof closure at the waist or
14 front.

15 “(viii) Multi-adjustable hood or adjustable col-
16 lar.

17 “(ix) Adjustable powder skirt, inner protective
18 skirt, or adjustable inner protective cuff at sleeve
19 hem.

20 “(x) Construction at the arm gusset that uti-
21 lizes fabric, design, or patterning to allow radial arm
22 movement.

23 “(xi) Odor control technology.

24 The term ‘recreational performance outerwear’ does not
25 include occupational outerwear.

1 “(b) For purposes of this Note, the following terms
2 have the following meanings:

3 “(i) The term ‘water-resistant’ means that a
4 garment must have a water resistance (see ASTM
5 designations D 3779–81 and D 7017) such that,
6 under a head pressure of 600 millimeters, not more
7 than 1.0 gram of water penetrates after two minutes
8 when tested in accordance with the current version
9 of AATCC Test Method 35. The water resistance of
10 the garment is the result of a rubber or plastics ap-
11 plication to the outer shell, lining, or inner lining.

12 “(ii) The term ‘visibly coated’ refers to fabric
13 that is impregnated, coated, covered, or laminated
14 with plastics, such as fabrics described in Note 2 to
15 chapter 59.

16 “(iii) The term ‘sealed seams’ means seams
17 that have been covered by means of taping, gluing,
18 bonding, cementing, fusing, welding, or a similar
19 process so that water cannot pass through the seams
20 when tested in accordance with the current version
21 of AATCC Test Method 35.

22 “(iv) The term ‘critically sealed seams’ means
23 seams’ that are sealed—

1 “(A) for jackets, at the front and back
2 yokes, or at the shoulders, arm holes, or both,
3 where applicable; and

4 “(B) for trousers, at the front (up to the
5 zipper or other means of closure) and back rise.

6 “(v) The term ‘insulation for cold weather pro-
7 tection’ means insulation with either synthetic fill,
8 down, a laminated thermal backing, or other lining
9 for thermal protection from cold weather.

10 “(vi) The term ‘venting’ refers to closeable or
11 permanent constructed openings in a garment (ex-
12 cluding front, primary zipper closures and grom-
13 met(s)) to allow increased expulsion of built-up heat
14 during outdoor activities. In a jacket, such openings
15 are often positioned on the underarm seam of a gar-
16 ment but may also be placed along other seams in
17 the front or back of a garment. In trousers, such
18 openings are often positioned on the inner or outer
19 leg seams of a garment but may also be placed along
20 other seams in the front or back of a garment.

21 “(vii) The term ‘articulated elbows or knees’ re-
22 fers to the construction of a sleeve (or pant leg) to
23 allow improved mobility at the elbow (or knee)
24 through the use of extra seams, darts, gussets, or
25 other means.

1 “(viii) The term ‘reinforcement’ refers to the
2 use of a double layer of fabric or section(s) of fabric
3 that is abrasion-resistant or otherwise more durable
4 than the predominant or face fabric of the garment.

5 “(ix) The term ‘weatherproof closure’ means a
6 closure (including, but not limited to, laminated or
7 coated zippers, storm flaps, or other weatherproof
8 construction) that has been reinforced or engineered
9 in a manner to reduce the penetration or absorption
10 of moisture or air through an opening in the gar-
11 ment.

12 “(x) The term ‘multi-adjustable hood or adjust-
13 able collar’ means a draw cord, adjustment tab, or
14 elastic incorporated into the hood or collar construc-
15 tion to allow volume adjustments around a helmet,
16 the crown of the head, neck, or face.

17 “(xi) The terms ‘adjustable powder skirt’ and
18 ‘inner protective skirt’ refer to a partial lower inner
19 lining with means of tightening around the waist for
20 additional protection from the elements.

21 “(xii) The term ‘arm gusset’ means construc-
22 tion at the arm of a gusset that utilizes an extra
23 fabric piece in the under arm usually diamond- or
24 triangular-shaped, design, or pattern to allow radial
25 arm movement.

1 “(xiii) The term ‘radial arm movement’ refers
2 to unrestricted, 180-degree range of motion for the
3 arm while wearing performance outerwear.

4 “(xiv) The term ‘odor control technology’ means
5 an additive in a fabric or garment capable of adsorb-
6 ing, absorbing, or reacting with human odors, or ef-
7 fective in reducing odor-causing bacteria, including
8 but not limited to activated carbon, silver, copper, or
9 any combination thereof.

10 “(xv) The term ‘occupational outerwear’ means
11 outerwear garments, including uniforms, designed or
12 marketed for use in the workplace or at a worksite
13 to provide durable protection from cold or inclement
14 weather and/or workplace hazards, such as fire, elec-
15 trical, abrasion, or chemical hazards, or impacts,
16 cuts, punctures, or similar hazards.

7 **SEC. 5. SUSTAINABLE TEXTILE AND APPAREL RESEARCH**
8 **FUND.**

9 (a) ESTABLISHMENT.—There is established in the
10 Treasury of the United States the Sustainable Textile and
11 Apparel Research Fund (in this section referred to as the
12 “STAR Fund”).

1 (b) DEPOSITS.—There shall be deposited into the
2 STAR Fund amounts equal to the fees collected on rec-
3 reational performance outerwear under subsection (d).

4 (c) BOARD OF DIRECTORS.—

5 (1) IN GENERAL.—The STAR Fund shall be
6 administered by a board of directors (in this section
7 referred to as the “Board”) composed of 5 individ-
8 uals familiar with the recreational performance out-
9 erwear textile and apparel industry, including the
10 production of raw materials and the finished prod-
11 ucts thereof, who shall be appointed by the Presi-
12 dent.

13 (2) MEMBERS.—Not less than 2 of the individ-
14 uals appointed to the Board under paragraph (1)
15 shall be representatives of entities involved in the
16 production of fabrics or raw materials for use in rec-
17 reational performance outerwear in the United
18 States, and not less than 2 of such individuals shall
19 be representatives of entities involved in the produc-
20 tion of recreational performance outerwear that pay
21 the fees imposed on the importation of such outer-
22 wear under subsection (d).

23 (3) INELIGIBLE INDIVIDUALS.—The President
24 may not appoint individuals to the Board under
25 paragraph (1) who are representatives of entities not

involved in the production of recreational performance outerwear, such as customs brokers, converters, forwarders, or shippers.

(d) FUNDING.—

(1) FEE.—In addition to any other fee authorized by law, the Secretary of the Treasury shall charge and collect upon entry, or withdrawal from warehouse for consumption, a fee of 1.5 percent of the appraised value of imported garments (as determined under section 402 of the Tariff Act of 1930 (19 U.S.C. 1401a)) that are classifiable under the Harmonized Tariff Schedule of the United States as recreational performance outerwear (as defined in U.S. Note 2 to chapter 61 and U.S. Note 3 to chapter 62 of the Harmonized Tariff Schedule of the United States).

(2) EXCLUSIONS.—The assessment of fees under paragraph (1) shall not apply to imports of recreational performance outerwear from the following:

(A) Any country that is party to a free trade agreement with the United States that—

(i) is in effect on the day before the date of the enactment of this Act; or

1 (ii) enters into force under the Bipar-
2 tisan Trade Promotion Authority Act of
3 2002 (19 U.S.C. 3801 et seq.), or similar
4 subsequent authority.

5 (B) Any country designated as a CBTPA
6 beneficiary country under section 213(b)(5)(B)
7 of the Caribbean Basin Economic Recovery Act
8 (19 U.S.C. 2703(b)(5)(B)).

9 (C) Any country designated as a bene-
10 ficiary sub-Saharan African country under sec-
11 tion 506A(a)(1) of the Trade Act of 1974 (19
12 U.S.C. 2466a(a)(1)), if the President has deter-
13 mined that the country has satisfied the re-
14 quirements of section 113(a) of the African
15 Growth and Opportunity Act (19 U.S.C.
16 3722(a)), and has published that determination
17 in the Federal Register.

18 (D) Any country designated as an
19 ATPDEA beneficiary country under section
20 204(b)(6)(B) of the Andean Trade Preference
21 Act (19 U.S.C. 3203(b)(6)(B)).

22 (3) TERMINATION.—The fee under paragraph
23 (1) shall apply only to entries, or withdrawals from
24 warehouse for consumption, that are made during

1 the 10-year period beginning on the date of the en-
2 actment of this Act.

3 (e) DISTRIBUTION.—

4 (1) QUARTERLY DISTRIBUTIONS.—The Sec-
5 retary of Commerce, upon a majority vote of the
6 Board, taken annually, shall, not later than 60 days
7 after the end of each calendar quarter, distribute
8 amounts in the STAR Fund to one or more entities
9 that the Board considers appropriate to use the
10 funds in accordance with subsection (f).

11 (2) ELIGIBILITY REQUIREMENTS.—An entity
12 may receive funds under paragraph (1) only if the
13 entity—

14 (A) is an organization described in section
15 501(c)(6) of the Internal Revenue Code of 1986
16 that is exempt from tax under section 501(a) of
17 such Code;

18 (B) is an organization having at least 10
19 years of experience providing applied research,
20 technology development, and education to all
21 parts of the textile and apparel supply chain,
22 with a research capability demonstrated
23 through past research programs involving sup-
24 ply chain management, product development, fit
25 specifications, operations management, lean

1 manufacturing, or digital supply chain tech-
2 nologies on behalf of the textile and sewn prod-
3 ucts industries in the United States; and

4 (C) is comprised of members representing
5 the following segments of the supply chain:

6 (i) One or more of the following types
7 of producers: fiber, yarn, or fabric pro-
8 ducers in the United States.

9 (ii) Apparel producers in the United
10 States.

11 (iii) Retail companies in the United
12 States.

13 (f) USE OF FUNDS.—Funds distributed under sub-
14 section (e) may be used only to conduct applied research,
15 development, and education activities to enhance the com-
16 petitiveness of businesses in the United States in clean,
17 eco-friendly apparel, other textile and apparel articles, and
18 sewn-product design and manufacturing.

19 (g) REQUIREMENTS.—The Secretary of Commerce
20 may impose such requirements on the use of funds distrib-
21 uted under subsection (e) as the Secretary considers nec-
22 essary to ensure compliance with subsection (f), including
23 requiring reporting and assurances by the entities using
24 the funds.

1 (h) REPORTS TO CONGRESS.—The Secretary of Com-
2 merce shall submit to Congress a report, not later than
3 April 1 of each year, explaining in detail how amounts in
4 the STAR Fund were distributed under subsection (e) and
5 used under subsection (f) during the preceding calendar
6 year.

7 **SEC. 6. EFFECTIVE DATE.**

8 This Act and the amendments made by this Act
9 shall—

10 (1) take effect on the 15th day after the date
11 of the enactment of this Act; and

12 (2) apply to garments entered, or withdrawn
13 from warehouse for consumption, on or after such
14 day.
