A BILL

- To amend title XVIII of the Social Security Act to stabilize and modernize the provision of partial hospitalization services under the Medicare program, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Outpatient Mental
 - 5 Health Modernization Act of 2009".
 - 6 SEC. 2. ALLOWABLE PARTIAL HOSPITALIZATION SERVICES.
- 7 (a) IN GENERAL.—Section 1861(ff)(2) of the Social
- 8 Security Act (42 U.S.C. 1395x(ff)(2)) is amended—

- 1 (1) in subparagraph (H) by striking ", and" at 2 the end;
- 3 (2) by redesignating subparagraph (I) as sub-4 paragraph (J);
- 5 (3) in subparagraph (J), as redesignated by 6 paragraph (2), by striking "(but in no event to in-7 clude meals and transportation)";
- 8 (4) by inserting after subparagraph (H) the following new subparagraph:
- 10 "(A) nutritional planning, meals, and transpor-11 tation, and"; and
 - (5) by adding at the end the following new sentence: "The guidelines established under the preceding sentence shall not allow for nutritional planning, meals, and transportation to be considered as meeting the minimum number of services requirement in order to receive payment for such items and services.".
- 19 (b) Effective Date.—The amendments made by 20 this section shall apply to services furnished on or after 21 January 1, 2010.
- 22 SEC. 3. BEHAVIORAL HEALTH ADVISORY COMMITTEE.
- 23 (a) Not later than January 1, 2011, the Secretary
- 24 of Health and Human Services shall convene a Behavioral
- 25 Health Advisory Committee (in this section referred to as

- 3 (b) Duties.—The Advisory Committee shall address
- 4 issues relating to—
- 5 (1) discrimination against the chronically men-
- 6 tally ill, elderly, and United States veterans as it re-
- 7 lates to receiving treatment for mental illness;
- 8 (2) the establishment of conditions of participa-
- 9 tion for community mental health centers (as de-
- fined in paragraph (3)(B) of section 1861(ff) of the
- Social Security Act (42 U.S.C. 1395x(ff)) that pro-
- vide partial hospitalization services (as defined in
- paragraph (1) of such section) under the Medicare
- program under title XVIII of such Act; and
- 15 (3) other matters to be determined jointly by
- the Secretary and the Advisory Committee.
- 17 (c) Implementation.—Not later than January 1,
- 18 2012, the Secretary of Health and Human Services, in
- 19 consultation with the Advisory Committee, shall imple-
- 20 ment conditions of participation for community mental
- 21 health centers (as so defined) that provide partial hos-
- 22 pitalization services (as so defined) under the Medicare
- 23 program under title XVIII of the Social Security Act.
