Mr. MCCAIN (for himself and Mr. KYL) introduced the following bill; which was read twice and referred to the Committee on Energy and Natural Resources

A BILL

To direct the Secretary of the Interior and the Secretary of Agriculture to jointly conduct a study of certain land adjacent to the Walnut Canyon National Monument in the State of Arizona.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Walnut Canyon Study
5 Act of 2009”.

6 **SEC. 2. DEFINITIONS.**

7 In this Act:

1 (1) MAP.—The term “map” means the map en-
2 titled “Walnut Canyon Proposed Study Area” and
3 dated July 17, 2007.

4 (2) SECRETARIES.—The term “Secretaries”
5 means the Secretary of the Interior and the Sec-
6 retary of Agriculture, acting jointly.

7 (3) STUDY AREA.—The term “study area”
8 means the area identified on the map as the “Wal-
9 nut Canyon Proposed Study Area”.

10 **SEC. 3. STUDY.**

11 (a) IN GENERAL.—The Secretaries shall conduct a
12 study of the study area to assess—

13 (1) the suitability and feasibility of designating
14 all or part of the study area as an addition to Wal-
15 nut Canyon National Monument, in accordance with
16 section 8(c) of Public Law 91–383 (16 U.S.C. 1a–
17 5(c));

18 (2) continued management of the study area by
19 the Forest Service; or

20 (3) any other designation or management op-
21 tion that would provide for—

22 (A) protection of resources within the
23 study area; and

24 (B) continued access to, and use of, the
25 study area by the public.

1 (b) CONSULTATION.—The Secretaries shall provide
2 for public comment in the preparation of the study, includ-
3 ing consultation with appropriate Federal, State, and local
4 governmental entities.

5 (c) REPORT.—Not later than 18 months after the
6 date on which funds are made available to carry out this
7 Act, the Secretaries shall submit to the Committee on En-
8 ergy and Natural Resources of the Senate and the Com-
9 mittee on Natural Resources of the House of Representa-
10 tives a report that describes—

11 (1) the results of the study; and

12 (2) any recommendations of the Secretaries.

13 (d) AUTHORIZATION OF APPROPRIATIONS.—There
14 are authorized to be appropriated such sums as are nec-
15 essary to carry out this Act.
