A BILL

To provide for the conveyance of certain parcels of land
to the town of Alta, Utah.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 ~~SECTION 1. CONVEYANCE.~~

4 ~~(a) DEFINITIONS.—In this Act:~~

1 (1) NATIONAL FOREST SYSTEM LAND.—The
 2 term “National Forest System land” means the par-
 3 cels of National Forest System land that—

4 (A) are located—

5 (i) in sec. 5, T. 3 S., R. 3 E., Salt
 6 Lake meridian;

7 (ii) in, and adjacent to, parcels of
 8 land subject to special use permit
 9 SLC102708, the authority of which expires
 10 on December 30, 2026;

11 (iii) in the Wasatch-Cache National
 12 Forest in Salt Lake County, Utah; and

13 (iv) in the incorporated boundary of
 14 the town of Alta, Utah; and

15 (B) consist of approximately 2 acres (in-
 16 cluding appurtenances).

17 (2) SECRETARY.—The term “Secretary” means
 18 the Secretary of Agriculture.

19 (3) TOWN.—The term “Town” means the town
 20 of Alta, Utah.

21 (b) CONVEYANCE.—As soon as practicable after the
 22 date of enactment of this Act, the Secretary shall convey
 23 to the Town, without consideration, all right, title, and in-
 24 terest of the United States in and to the National Forest
 25 System land.

1 (c) SURVEY.—

2 (1) IN GENERAL.—In accordance with para-
3 graphs (2) and (3), the exact acreage and legal de-
4 scription of the National Forest System land shall
5 be determined by a survey approved by the Sec-
6 retary.

7 (2) MAXIMUM AREA.—The acreage of the Na-
8 tional Forest System land determined under para-
9 graph (1) may not exceed 2 acres.

10 (3) COST.—The Town shall pay each cost aris-
11 ing from a survey described in paragraph (1).

12 (d) USE OF NATIONAL FOREST SYSTEM LAND.—As
13 a condition of the conveyance under subsection (b), the
14 Town shall use the National Forest System land only for
15 public purposes.

16 (e) REVERSIONARY INTEREST.—In the deed to the
17 Town, the Secretary shall provide that the National Forest
18 System land shall revert to the Secretary, at the election
19 of the Secretary based on the best interests of the United
20 States, if the National Forest System land is used for a
21 purpose other than a public purpose.

22 (f) ADDITIONAL TERMS AND CONDITIONS.—With re-
23 spect to the conveyance under subsection (b), the Sec-
24 retary may require such additional terms and conditions

1 as the Secretary determines to be appropriate to protect
 2 the interests of the United States.

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Wasatch-Cache National*
 5 *Forest Land Conveyance Act of 2010”.*

6 **SEC. 2. DEFINITIONS.**

7 *In this Act:*

8 (1) *FEDERAL LAND.*—*The term “Federal land”*
 9 *means the following 3 parcels of National Forest Sys-*
 10 *tem land located in the Wasatch-Cache National For-*
 11 *est in the incorporated boundary of the Town:*

12 (A) *A parcel of land occupied by the admin-*
 13 *istration building of the Town pursuant to For-*
 14 *est Service special use permit SLC102708.*

15 (B) *A parcel of land occupied by the public*
 16 *service building of the Town pursuant to Forest*
 17 *Service special use permit SLC102708.*

18 (C) *A parcel of land occupied by the water*
 19 *service building of the Town pursuant to Forest*
 20 *Service special use permit SLC102707.*

21 (2) *SECRETARY.*—*The term “Secretary” means*
 22 *the Secretary of Agriculture.*

23 (3) *TOWN.*—*The term “Town” means the town of*
 24 *Alta, Utah.*

1 **SEC. 3. CONVEYANCE OF FEDERAL LAND TO ALTA, UTAH.**

2 (a) *IN GENERAL.*—Subject to subsection (b) and valid
3 existing rights, as soon as practicable after the date of en-
4 actment of this Act, the Secretary shall convey to the Town,
5 without consideration, all right, title, and interest of the
6 United States in and to the Federal land.

7 (b) *CONDITIONS.*—

8 (1) *USE OF FEDERAL LAND.*—As a condition of
9 the conveyance under subsection (a), the Town shall
10 use the Federal land only for public purposes con-
11 sistent with the applicable special use permit de-
12 scribed in section 2(1).

13 (2) *DEED AND REVERSION.*—The conveyance
14 under subsection (a) shall be by quitclaim deed, which
15 shall provide that the Federal land shall revert to the
16 Secretary, at the election of the Secretary, if the Fed-
17 eral land is used for a purpose other than a purpose
18 provided under paragraph (1).

19 (3) *ACREAGE.*—

20 (A) *IN GENERAL.*—The boundaries of the
21 Federal land conveyed under subsection (a) shall
22 be determined by the Secretary, in consultation
23 with the Town, subject to the condition that the
24 Federal land conveyed may not exceed a total of
25 2 acres.

1 (B) *SURVEY AND LEGAL DESCRIPTION.*—

2 *The exact acreage and legal description of the*
3 *Federal land shall be determined, in accordance*
4 *with subparagraph (A), by a survey approved by*
5 *the Secretary.*

6 (4) *COSTS.*—*The Town shall pay each adminis-*
7 *trative cost of the conveyance under subsection (a),*
8 *including the costs of the survey carried out under*
9 *paragraph (3).*

10 (5) *ADDITIONAL TERMS AND CONDITIONS.*—*The*
11 *conveyance under subsection (a) shall be subject to*
12 *such terms and conditions as the Secretary may re-*
13 *quire.*
