 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Colorado Northern
 - 5 Front Range Mountain Backdrop Protection Study Act".
 - 6 SEC. 2. PURPOSE.
 - 7 The purpose of this Act is to identify options that
 - 8 may be available to assist in maintaining the open space

characteristics of land that is part of the mountain back-2 drop of communities in the northern section of the Front Range area of Colorado. 3 4 SEC. 3. DEFINITIONS. 5 In this Act: (1) Secretary.—The term "Secretary" means 6 7 the Secretary of Agriculture, acting through the 8 Chief of the Forest Service. (2) STATE.—The term "State" means the State 9 10 of Colorado. 11 (3) Study area.— (A) IN GENERAL.—The term "study area" 12 13 means the land in southern Boulder, northern 14 Jefferson, and northern Gilpin Counties, Colo-15 rado, that is located west of Colorado State 16 Highway 93, south and east of Colorado State 17 Highway 119, and north of Colorado State 18 Highway 46, as generally depicted on the map 19 "Colorado Northern Front Range entitled 20 Mountain Backdrop Protection Study Act: 21 Study Area" and dated August 27, 2008. 22 (B) Exclusions.—The term "study area" 23 does not include land within the city limits of 24 the cities of Arvada, Boulder, or Golden, Colo-

rado.
