A BILL

To provide for the liquidation or reliquidation of certain line items in entries of tailored garments from Costa Rica.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. LIQUIDATION OR RELIQUIDATION OF CERTAIN**
4 **LINE ITEMS IN ENTRIES OF TAILORED GAR-**
5 **MENTS FROM COSTA RICA.**

6 (a) LIQUIDATION OR RELIQUIDATION OF LINE ITEMS
7 IN ENTRIES.—Notwithstanding sections 514 and 520 of
8 the Tariff Act of 1930 (19 U.S.C. 1514 and 1520), or
9 any other provision of law, U.S. Customs and Border Pro-

1 tection shall, not later than 180 days after the date of
 2 the enactment of this Act—

3 (1) liquidate or reliquidate at the rate of zero
 4 percent the goods entered under the entry summary
 5 (CBP Form 7501) line items listed in subsection (b)
 6 containing tailored garments from Costa Rica; and

7 (2) refund to the importer of record the amount
 8 of excess duties previously collected on those line
 9 items.
