A BILL

To authorize additional resources to identify and eliminate illicit sources of firearms smuggled into Mexico for use by violent drug trafficking organizations, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Southwest Border Vio-
5 lence Reduction Act of 2009”.

6 **SEC. 2. PROJECT GUNRUNNER.**

7 (a) IN GENERAL.—The Attorney General shall dedi-
8 cate and expand the resources provided for the Project

1 Gunrunner initiative of the Bureau of Alcohol, Tobacco,
2 Firearms, and Explosives to identify, investigate, and
3 prosecute individuals involved in the trafficking of fire-
4 arms across the international border between the United
5 States and Mexico.

6 (b) ACTIVITIES.—In carrying out this section, the At-
7 torney General shall—

8 (1) assign additional agents of the Bureau of
9 Alcohol, Tobacco, Firearms, and Explosives to the
10 area of the United States adjacent to the inter-
11 national border between the United States and Mex-
12 ico to support the expansion of Project Gunrunner
13 teams;

14 (2) establish not fewer than 1 Project Gun-
15 runner team in each State along the international
16 border between the United States and Mexico; and

17 (3) coordinate with the heads of other relevant
18 Federal law enforcement agencies and State and
19 local law enforcement agencies to address firearms
20 trafficking in a comprehensive manner.

21 (c) ADDITIONAL STAFF.—The Attorney General may
22 hire Bureau of Alcohol, Tobacco, Firearms, and Explo-
23 sives agents for, and otherwise expend additional resources
24 needed to adequately support, Project Gunrunner.

1 (d) AUTHORIZATION OF APPROPRIATIONS.—There
 2 are authorized to be appropriated \$15,000,000 for each
 3 of fiscal years 2010 and 2011 to carry out this section.

4 **SEC. 3. ENHANCED INTERNATIONAL COOPERATION.**

5 (a) IN GENERAL.—The Attorney General, in coopera-
 6 tion with the Secretary of State, shall—

7 (1) assign agents of the Bureau of Alcohol, To-
 8 bacco, Firearms, and Explosives to the United
 9 States mission in Mexico, to work with Mexican law
 10 enforcement agencies in conducting investigations
 11 relating to firearms trafficking and other criminal
 12 enterprises;

13 (2) provide the equipment and technological re-
 14 sources necessary to support investigations and to
 15 trace firearms recovered in Mexico; and

16 (3) support the training of Mexican law en-
 17 forcement officers in serial number restoration tech-
 18 niques, canine explosive detection, and
 19 antitrafficking tactics.

20 (b) AUTHORIZATION OF APPROPRIATIONS.—There
 21 are authorized to be appropriated \$9,500,000 for each of
 22 fiscal years 2010 and 2011 to carry out this section.
