Mr. GRAHAM introduced the following bill; which was read twice and referred to the Committee on Finance

A BILL

To liquidate or reliquidate certain entries of truck tires entered on or after April 13, 2004, and on or before December 28, 2004.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. LIQUIDATION OR RELIQUIDATION OF CERTAIN**
4 **ENTRIES OF TRUCK TIRES ENTERED ON OR**
5 **AFTER APRIL 13, 2004, AND ON OR BEFORE**
6 **DECEMBER 28, 2004.**

7 (a) LIQUIDATION OR RELIQUIDATION REQUIRED.—
8 Notwithstanding sections 514 and 520 of the Tariff Act
9 of 1930 (19 U.S.C. 1514 and 1520), or any other provi-
10 sion of law, U.S. Customs and Border Protection shall,

1 not later than 180 days after the date of the enactment
 2 of this Act—

3 (1) liquidate or reliquidate as free of duty each
 4 entry described in subsection (b) containing any
 5 merchandise which, at the time of original liquida-
 6 tion, was merchandise eligible for duty-free treat-
 7 ment under title V of the Trade Act of 1974 (19
 8 U.S.C. 2461 et seq.); and

9 (2) refund any duties and interest paid on such
 10 entries.
