A BILL

To modify the boundary of the Minuteman Missile National Historic Site in the State of South Dakota, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Minuteman Missile Na-
- 5 tional Historic Site Boundary Modification Act".

1 SEC. 2. BOUNDARY MODIFICATION.

2	Section 3(a) of the Minuteman Missile National His-
3	toric Site Establishment Act of 1999 (16 U.S.C. 461 note;
4	Public Law 106–115) is amended—
5	(1) by redesignating paragraphs (3) and (4) as
6	paragraphs (4) and (5), respectively; and
7	(2) by inserting after paragraph (2) the fol-
8	lowing:
9	"(3) VISITOR FACILITY AND ADMINISTRATIVE
10	SITE.—The historic site shall consist of a visitor fa-
11	cility and administrative site located on a parcel of
12	land that—
13	"(A) consists of approximately 25 acres of
14	Forest Service land located in the Buffalo Gap
15	National Grasslands;
16	"(B) is located north of exit 131 on Inter-
17	state 90 in Jackson Country, South Dakota;
18	and
19	"(C) is generally depicted on the map enti-
20	tled 'Minuteman Missile National Historic Site
21	Boundary Modification', numbered 406/80,011,
22	and dated July 17, 2009.".
23	"(3) Visitor facility and administrative
24	SITE.—
25	"(A) In general.—In addition to the com-
26	ponents described in paragraph (2), the historic

1	site shall include a visitor facility and adminis-
2	trative site located on the parcel of land de-
3	scribed in subparagraph (B).
4	"(B) Description of Land.—The land re-
5	ferred to in subparagraph (A) consists of ap-
6	proximately 25 acres of land within the Buffalo
7	Gap National Grassland in South Dakota as
8	generally depicted on the map entitled 'Minute-
9	man Missile National Historic Site Boundary
10	Modification', numbered 406/80,011, and dated
11	July 17, 2009.
12	"(C) Availability of map.—The map de-
13	scribed in subparagraph (B) shall be kept on file
14	and available for public inspection in the appro-
15	priate offices of the National Park Service.
16	"(D) Transfer of administrative juris-
17	DICTION.—Administrative jurisdiction over the
18	land described in subparagraph (B) is trans-
19	ferred from the Secretary of Agriculture to the
20	Secretary, to be administered as part of the his-
21	$toric\ site.$
22	"(E) Boundary adjustment.—The bound-
