 - 3 SECTION 1. SHORT TITLE.

SEC. 2. USE OF FEDERAL FUNDS TO REMEDIATE DAMAGE

- 3 (a) ROAD HOME PROGRAM.—Notwithstanding any
- 4 other provision of law, any Federal funds provided to the
- 5 Road Home Program created by the Louisiana Recovery
- 6 Authority and funded by amounts made available to the
- 7 State of Louisiana from the community development block
- 8 grant program under title I of the Housing and Commu-
- 9 nity Development Act of 1974 (42 U.S.C. 5301 et seq.)
- 10 may be used to provide any resident of the State of Lou-
- 11 isiana, whether a participant or nonparticipant in the
- 12 Road Home Program, with such monetary assistance as
- 13 may be necessary to repair or replace tainted drywall.
- 14 (b) CDBG AMOUNTS.—Notwithstanding any other
- 15 provision of law, including any provision under title I of
- 16 the Housing and Community Development Act of 1974
- 17 (42 U.S.C. 5301 et seq.), the Secretary of Housing and
- 18 Urban Development may permit any State or unit of gen-
- 19 eral local government receiving assistance pursuant to sec-
- 20 tion 106 of such Act to use such assistance to provide
- 21 homeowners residing in such State or unit of general local
- 22 government with such monetary assistance as may be nec-
- 23 essary to repair or replace tainted drywall.
- 24 (c) Definition.—As used in this section, the term
- 25 "tainted drywall" means drywall that—

1	(1) was manufactured in the People's Republic
2	of China;
3	(2) was imported into the United States during
4	the period beginning on January 1, 2004, and end-
5	ing on December 31, 2008; and
6	(3) contains elevated levels of sulphur or stron-
7	tium.
