# A BILL

To amend the Omnibus Crime Control and Safe Streets Act of 1968 to provide adequate benefits for public safety officers injured or killed in the line of duty, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "First Responders Sup-
- 5 port Act of 2009".

#### 1 SEC. 2. EXPANDING DISABILITY BENEFITS.

- 2 (a) IN GENERAL.—Section 1201 of the Omnibus
- 3 Crime Control and Safe Streets Act of 1968 (42 U.S.C.
- 4 3796) is amended—
- 5 (1) in subsection (a), by striking "\$250,000"
- 6 and inserting "\$350,000"; and
- 7 (2) in subsection (h), by striking "the effective
- 8 date of this subsection" and inserting "the date of
- 9 enactment of the First Responders Support Act of
- 10 2009".
- 11 (b) Expediting Benefits.—Section 1201 of the
- 12 Omnibus Crime Control and Safe Streets Act of 1968 (42
- 13 U.S.C. 3796) is amended by adding at the end the fol-
- 14 lowing:
- 15 "(n) Not later than 12 months after the date on
- 16 which a claimant submits all information required for a
- 17 claim under this subpart, the Bureau shall determine
- 18 whether the claimant is eligible to receive a benefit under
- 19 this subpart.".
- 20 (c) Regulations.—Not later than 9 months after
- 21 the date of enactment of this Act, the Attorney General
- 22 shall promulgate regulations to carry out the amendments
- 23 made by this section.
- 24 (d) Authorization of Appropriations.—There
- 25 are authorized to be appropriated to the Attorney General,

- 1 in addition to any other amounts otherwise authorized to
- 2 be appropriated—
- 3 (1) \$2,000,000 for each of fiscal years 2011
- through 2015 to hire employees for the Bureau of
- 5 Justice Assistance and obtain the technology and
- 6 equipment necessary to educate and assist eligible
- 7 agencies with the filing and application of claims for
- 8 the Public Safety Officer Benefits Programs and to
- 9 provide supplemental materials for continuing edu-
- 10 cation of claims information and procedure; and
- 11 (2) \$800,000 for each of fiscal years 2011
- through 2015 for the education and assistance to
- public safety officers and first responders in jurisdic-
- tions located in rural areas and urban areas with a
- population of less than 25,000.
- 16 SEC. 3. EDUCATIONAL BENEFITS.
- 17 Section 1212(a) of the Omnibus Crime Control and
- 18 Safe Streets Act of 1968 (42 U.S.C. 3796d–1(a)) is
- 19 amended—
- 20 (1) by striking paragraph (2) and inserting the
- 21 following:
- 22 "(2)(A) Except as provided in paragraph (3), and
- 23 subject to subparagraph (C) of this paragraph, financial
- 24 assistance under this subpart shall—

1	"(i) consist of direct payments to an eligible de-
2	pendent; and
3	"(ii) be paid at the monthly rate of not more
4	than \$1,500.
5	"(B) The Director shall promulgate regulations to es-
6	tablish the amount of financial assistance under subpara-
7	graph (A) for an eligible dependent, which shall be based
8	on the portion of the normal full-time academic workload
9	for the course of study, as determined by the eligible edu-
10	cational institution, that the eligible dependent is pur-
11	suing.
12	"(C) On October 1 of each fiscal year beginning after
13	the date of enactment of the First Responders Support
14	Act of 2009, the Director shall adjust the level of the ben-
15	efit payable during that fiscal year under subparagraph
16	(A)(ii), to reflect the annual percentage change in the
17	Consumer Price Index for All Urban Consumers, pub-
18	lished by the Bureau of Labor Statistics, occurring in the
19	1-year period ending on June 1 immediately preceding
20	such October 1."; and
21	(2) in paragraph (3)(A), by striking "to which
22	the eligible dependent would otherwise be entitled to
23	receive" and inserting "that the eligible dependent
24	receives".

## 1 SEC. 4. PRIORITIZATION OF CLAIMS.

2	Section 1205 of the Omnibus Crime Control and Safe
3	Streets Act of 1968 (42 U.S.C. 3796c) is amended by add-
4	ing at the end the following:
5	(d)(1) The Bureau shall adopt and apply a system
6	of prioritization of claims for benefits under this part
7	based on the severity of the claim and the likelihood of
8	approval of the claim.
9	"(2) For purposes of this subsection, a claim for a
10	death benefit or 100 percent disability shall be considered
11	more severe and given priority.".
12	SEC. 5. EXPANDING COUNSELING AND MENTAL HEALTH
13	SERVICES.
14	(a) Definitions.—In this section—
15	(1) the term "Director" means the Director of
16	the Bureau of Justice Assistance;
17	(2) the term "eligible organization" means an
18	organization that provides free or reduced cost men-
19	tal health services or counseling to public safety offi-
20	cers seriously injured in the line of duty and the
21	family members of public safety officers killed or se-
22	riously injured in the line of duty;
23	(3) the term "public safety officer" has the
24	meaning given that term in section 1204 of the Om-
25	nibus Crime Control and Safe Streets Act of 1968
26	(42 U.S.C. 3796b); and

- 1 (4) the term "reduced cost", relating to mental 2 health services or counseling, means that the organi-3 zation providing the services or counseling charges 4 not more than 50 percent of the amount that the or-5 ganization would otherwise charge for the services or
- 7 (b) AUTHORIZATION TO MAKE GRANTS.—The Direc8 tor may make grants to eligible organizations to provide
  9 mental health services or counseling to public safety offi10 cers seriously injured in the line of duty and the family
  11 members of public safety officers killed or seriously in12 jured in the line of duty.
- 13 (c) APPLICATION.—An eligible organization desiring 14 a grant under this section shall submit an application at 15 such time, in such manner, and accompanied by such in-16 formation as the Director may establish.

#### 17 SEC. 6. OVERSIGHT OF THE PSOB PROGRAM.

- The Director of the Bureau of Justice Assistance 19 shall—
- 20 (1) not later than 12 months after the date of 21 enactment of this Act, structure, design, and imple-22 ment a performance measure for the Public Safety 23 Officers Benefits program to monitor the claims 24 process and payment of benefits to officers and 25 beneficiaries; and

counseling.

1 (2) report to Congress annually on the perform-2 ance of the program, and its activities, including 3 technological updates, the status of payments and 4 claims, and the results of any education and out-5 reach activities performed in accordance to this Act.
