A BILL

To amend title 31, United States Code, to enhance the oversight authorities of the Comptroller General, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Government Account-
- 5 ability Office Improvement Act of 2010".

SEC. 2. AUTHORITY TO OBTAIN INFORMATION.

- 2 (a) AUTHORITY TO OBTAIN RECORDS.—Section 716
- 3 of title 31, United States Code, is amended in subsection
- 4 $\frac{(a)}{}$
- 5 (1) by striking "(a)" and inserting "(2)"; and
- 6 (2) by inserting after the section heading the
- 7 following:
- 8 "(a)(1) The Comptroller General is authorized to ob-
- 9 tain such agency records as the Comptroller General re-
- 10 quires to discharge his duties (including audit, evaluation,
- 11 and investigative duties), including through the bringing
- 12 of civil actions under this section. In reviewing a civil ac-
- 13 tion under this section, the court shall recognize the con-
- 14 tinuing force and effect of the authorization in the pre-
- 15 ceding sentence until such time as the authorization is re-
- 16 pealed pursuant to law.".
- 17 (b) Copies and Interviews.—Section 716(a) of
- 18 title 31, United States Code, as amended by subsection
- 19 (a), is further amended in the second sentence of para-
- 20 graph (2) by striking "inspect an agency record" and in-
- 21 serting "inspect, and make and retain copies of, an agency
- 22 record and interview agency officers and employees".
- 23 (e) Rules of Construction.—Section 716 of title
- 24 31, United States Code, is amended by adding at the end
- 25 the following new subsection:

- 1 "(f) No provision of any law in existence on the date
- 2 of the enactment of this section or enacted after such date
- 3 shall be construed to limit, amend, or supersede the au-
- 4 thority of the Comptroller General to obtain any informa-
- 5 tion, to inspect any record, or to interview any officer or
- 6 employee under this section in carrying out any authorized
- 7 audit, evaluation, or investigation, except to the extent
- 8 such provision expressly and specifically refers to this sec-
- 9 tion and provides for such limitation, amendment, or
- 10 supersession.".

11 SEC. 3. ADMINISTERING OATHS.

- 12 Paragraph (4) of section 711 of title 31, United
- 13 States Code, is amended to read as follows:
- 14 "(4) administer oaths to witnesses, except that,
- in matters other than auditing and settling accounts,
- the authority of an officer or employee to administer
- oaths to witnesses pursuant to a delegation under
- 18 paragraph (2) shall not be available without the
- 19 prior express approval of the Comptroller General
- 20 (or a designee).".

- 2 tinuing force and effect of the authorization in the pre-
- 3 ceding sentence until such time as the authorization is re-
- 4 pealed pursuant to law.".
- 5 (b) Copies.—Section 716(a) of title 31, United States
- 6 Code, as amended by subsection (a), is further amended in
- 7 the second sentence of paragraph (2) by striking "inspect
- 8 an agency record" and inserting "inspect, and make and
- 9 retain copies of, an agency record".

10 SEC. 3. ADMINISTERING OATHS.

- 11 Section 711 of title 31, United States Code, is amended
- 12 by striking paragraph (4) and inserting the following:
- 13 "(4) administer oaths to witnesses when auditing
- and settling accounts and, with the prior express ap-
- 15 proval of the Comptroller General, when investigating
- 16 fraud or attempts to defraud the United States, or ir-
- 17 regularity or misconduct of an employee or agent of
- 18 the United States.".

19 SEC. 4. ACCESS TO CERTAIN INFORMATION.

- 20 (a) Access to Certain Information.—Subchapter
- 21 II of chapter 7 of title 31, United States Code, is amended
- 22 by adding at the end the following:

23 "§ 721. Access to certain information

- 24 "(a) No provision of the Social Security Act, including
- 25 section 453(l) of that Act (42 U.S.C. 653(l)), shall be con-

- 1 strued to limit, amend, or supersede the authority of the
- 2 Comptroller General to obtain any information or to in-
- 3 spect or copy any record under section 716 of this title.
- 4 "(b) No provision of the Federal Food, Drug, and Cos-
- 5 metic Act, including section 301(j) of that Act (21 U.S.C.
- 6 331(j)), shall be construed to limit, amend, or supersede the
- 7 authority of the Comptroller General to obtain any infor-
- 8 mation or to inspect or copy any record under section 716
- 9 of this title.
- 10 "(c) No provision of the Hart-Scott-Rodino Antitrust
- 11 Improvements Act of 1976 (Public Law 94–435) and the
- 12 amendments made by that Act shall be construed to limit,
- 13 amend, or supersede the authority of the Comptroller Gen-
- 14 eral to obtain any information or to inspect or copy any
- 15 record under section 716 of this title, including with respect
- 16 to any information disclosed to the Assistant Attorney Gen-
- 17 eral of the Antitrust Division of the Department of Justice
- 18 or the Federal Trade Commission for purposes of pre-merg-
- 19 er review under section 7A of the Clayton Act (15 U.S.C.
- 20 *18a*).
- 21 "(d)(1) The Comptroller General shall prescribe such
- 22 policies and procedures as are necessary to protect from
- 23 public disclosure proprietary or trade secret information
- 24 obtained consistent with this section.
- 25 "(2) Nothing in this section shall be construed—

1	"(A) to alter or amend the prohibitions against				
2	the disclosure of trade secret or other sensitive infor				
3	mation prohibited by section 1905 of title 18 and				
4	other applicable laws; or				
5	"(B) to affect the applicability of section 716(e)				
6	of this title, including the protections against unau				
7	thorized disclosure contained in that section, to infor				
8	mation obtained consistent with this section.				
9	"(e) Specific references to statutes in this section shall				
10	not be construed to affect access by the Government Account-				
11	ability Office to information under statutes that are not				
12	so referenced.".
