A BILL

To require semiannual indexing of certain Federal child nutrition programs.

1 Be it enacted by the Senate and House of Representa-

2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "National Child Hunger

5 Relief Act".

6 SEC. 2. SCHOOL MEALS.

7 (a) COMMODITIES.—Section 6(c)(1) of the Richard

8 B. Russell National School Lunch Act (42 U.S.C.

9 1755(c)(1)) is amended—

1	(1) in subparagraph (A), by striking "on July
2	1, 1982, and each July 1 thereafter" and inserting
3	"in accordance with subparagraph (B)"; and
4	(2) by striking subparagraph (B) and inserting
5	the following:
6	"(B) ADJUSTMENT.—The Secretary shall—
7	"(i) on each January 1, increase the value of
8	food assistance for each meal by the annual percent-
9	age change in a 3-month average value of the Price
10	Index for Foods Used in Schools and Institutions for
11	September, October, and November each year;
12	"(ii) on each July 1, increase the value of food
13	assistance for each meal by the annual percentage
14	change in a 3-month average value of the Price
15	Index for Foods Used in Schools and Institutions for
16	March, April, and May each year; and
17	"(iii) round the result of each increase to the
18	nearest higher $\frac{1}{4}$ cent.".
19	(b) Overall Adjustment.—Section 11(a) of the
20	Richard B. Russell National School Lunch Act (42 U.S.C.
21	1759a(a)) is amended—
22	(1) in paragraph (2), by striking "98.75 cents"
23	and inserting "the amount computed under para-
24	graph (3)"; and
25	(2) in paragraph (3) —

1	(A) in subparagraph (A)—
2	(i) in the matter before clause (i), by
3	striking "July 1, 1982, and on each subse-
4	quent July 1, an annual adjustment" and
5	inserting "each January 1 and July 1, a
6	semiannual increase"; and
7	(ii) in clause (ii), by striking "(as es-
8	tablished under paragraph (2) of this sub-
9	section)";
10	(B) in subparagraph (B)—
11	(i) in clause (i), by striking "annual
12	adjustment" and inserting "semiannual in-
13	crease'';
14	(ii) in clause (ii)—
15	(I) by striking "annual adjust-
16	ment" and inserting "semiannual in-
17	crease"; and
18	(II) by striking "12-month pe-
19	riod" and inserting "6-month period";
20	and
21	(iii) by striking clause (iii) and insert-
22	ing the following:
23	"(iii) Rounding.—On each January
24	1 and July 1, the national average pay-

1	ment rates for meals and supplements
2	shall be—
3	"(I) increased to the nearest
4	higher cent; and
5	"(II) based on the unrounded
6	amount previously in effect.".
7	(c) PAYMENTS TO SERVICE INSTITUTIONS.—Section
8	13(b)(1) of the Richard B. Russell National School Lunch
9	Act (42 U.S.C. 1761(b)(1)) is amended by striking sub-
10	paragraph (B) and inserting the following:
11	"(B) Adjustments.—The Secretary
12	shall—
13	"(i) on each January 1, increase each
14	amount specified in subparagraph (A) as
15	adjusted through the preceding July 1 to
16	reflect changes for the 6-month period end-
17	ing the preceding November 30 in the se-
18	ries for food away from home of the Con-
19	sumer Price Index for All Urban Con-
20	sumers published by the Bureau of Labor
21	Statistics of the Department of Labor;
22	"(ii) on each July 1, increase each
23	amount specified in subparagraph (A) as
24	adjusted through the preceding January 1
25	to reflect changes for the 6-month period

1	ending the preceding May 31 in the series
2	for food away from home of the Consumer
3	Price Index for All Urban Consumers pub-
4	lished by the Bureau of Labor Statistics of
5	the Department of Labor;
6	"(iii) base each increase on the
7	unrounded amount previously in effect;
8	and
9	"(iv) round each increase described in
10	clauses (i) and (ii) to the nearest higher
11	cent increment.".
12	(d) Reimbursement of Family or Group Day
13	CARE HOME SPONSORING ORGANIZATIONS.—
14	(1) TIER I.—Section $17(f)(3)(A)(ii)(IV)$ of the
15	Richard B. Russell National School Lunch Act (42
16	U.S.C. 1766(f)(3)(A)(ii)(IV)) is amended by striking
17	subclause (IV) and inserting the following:
18	"(IV) ADJUSTMENTS.—On each
19	July 1 and January 1, the Secretary
20	shall—
21	"(aa) increase each reim-
22	bursement factor under this sub-
23	paragraph to reflect the changes
24	in the Consumer Price Index for
25	food at home for the most recent

1	6-month period for which the
2	data are available;
3	"(bb) base each increase on
4	the unrounded amount previously
5	in effect; and
6	"(cc) round each increase
7	described in item (aa) to the
8	nearest higher cent increment.".
9	(2) TIER II.—Section $17(f)(3)(A)(iii)(I)$ of the
10	Richard B. Russell National School Lunch Act (42
11	U.S.C. 1766(f)(3)(A)(iii)(I)) is amended by striking
12	item (bb) and inserting the following:
13	"(bb) Adjustments.—On
14	each July 1 and January 1, the
15	Secretary shall increase the reim-
16	bursement factors to reflect the
17	changes in the Consumer Price
18	Index for food at home for the
19	most recent 6-month period for
20	which the data are available, base
21	the increases on the unrounded
22	amount previously in effect, and
23	round the increases to the near-
24	est higher cent increment.".

4 (1) by striking paragraph (7) and inserting the5 following:

"(7) MINIMUM RATE OF REIMBURSEMENT.---6 7 For each school year, the minimum rate of reim-8 bursement for a ¹/₂ pint of milk served in schools 9 and other eligible institutions shall be not less than 10 minimum rate of reimbursement in effect on Sep-11 tember 30, 2008, as increased on a semiannual basis 12 each school year to reflect changes in the Producer 13 Price Index for Fresh Processed Milk published by 14 the Bureau of Labor Statistics of the Department of Labor."; and 15

16 (2) in paragraph (8), by inserting "higher"17 after "nearest".
