 - 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the "Growing Farm to3 School Programs Act of 2010".

4 SEC. 2. ACCESS TO LOCAL FOODS: FARM TO SCHOOL PRO-

GRAM.

6 Section 18 of the Richard B. Russell National School
7 Lunch Act (42 U.S.C. 1769) is amended—

8 (1) by redesignating subsections (h) and (i) as
9 subsections (i) and (j), respectively;

(2) in subsection (g), by striking "(g) ACCESS
TO LOCAL FOODS AND SCHOOL GARDENS.—" and
all that follows through "(3) PILOT PROGRAM FOR
HIGH-POVERTY SCHOOLS.—" and inserting the following:

15 "(g) ACCESS TO LOCAL FOODS: FARM TO SCHOOL16 PROGRAM.—

"(1) DEFINITION OF ELIGIBLE SCHOOL.—In
this subsection, the term 'eligible school' means a
school or institution that participates in a program
under this Act or the school breakfast program established under section 4 of the Child Nutrition Act
of 1966 (42 U.S.C. 1773).

"(2) PROGRAM.—The Secretary shall carry out
a program to assist eligible schools, State and local
agencies, Indian tribal organizations, agricultural
producers or groups of agricultural producers, and

1	nonprofit entities through grants and technical as-
2	sistance to implement farm to school programs that
3	improve access to local foods in eligible schools.
4	"(3) GRANTS.—
5	"(A) IN GENERAL.—The Secretary shall
6	award competitive grants under this subsection
7	to be used for—
8	"(i) training;
9	"(ii) supporting operations;
10	"(iii) planning;
11	"(iv) purchasing equipment;
12	"(v) developing school gardens;
13	"(vi) developing partnerships; and
14	"(vii) implementing farm to school
15	programs.
16	"(B) REGIONAL BALANCE.—In making
17	awards under this subsection, the Secretary
18	shall, to the maximum extent practicable, en-
19	sure—
20	"(i) geographical diversity; and
21	"(ii) equitable treatment of urban,
22	rural, and tribal communities.
23	"(C) MAXIMUM AMOUNT.—The total
24	amount provided to a grant recipient under this
25	subsection shall not exceed \$100,000.

2	"(A) IN GENERAL.—The Federal share of
3	costs for a project funded through a grant
4	awarded under this subsection shall not exceed
5	75 percent of the total cost of the project.
6	"(B) FEDERAL MATCHING.—As a condi-
7	tion of receiving a grant under this subsection,
8	a grant recipient shall provide matching sup-
9	port in the form of cash or in-kind contribu-
10	tions, including facilities, equipment, or services
11	provided by State and local governments, non-
12	profit organizations, and private sources.
13	"(5) CRITERIA FOR SELECTION.—To the max-
14	imum extent practicable, in providing assistance
15	under this subsection, the Secretary shall give the
16	highest priority to funding projects that, as deter-
17	mined by the Secretary—
18	"(A) benefit local small- and medium-sized
19	farms;
20	"(B) make local food products available on
21	the menu of the eligible school;
22	"(C) serve a high proportion of children
23	who are eligible for free or reduced price

1	"(D) incorporate experiential nutrition
2	education activities in curriculum planning that
3	encourage the participation of school children in
4	farm and garden-based agricultural education
5	activities;
6	"(E) demonstrate collaboration between el-
7	igible schools, nongovernmental and community-
8	based organizations, agricultural producer
9	groups, and other community partners;
10	"(F) include adequate and participatory
11	evaluation plans;
12	"(G) demonstrate the potential for long-
13	term program sustainability; and
14	"(H) meet any other criteria that the Sec-
15	retary determines appropriate.
16	"(6) EVALUATION.—As a condition of receiving
17	a grant under this subsection, each grant recipient
18	shall agree to cooperate in an evaluation by the Sec-
19	retary of the program carried out using grant funds.
20	"(7) TECHNICAL ASSISTANCE.—The Secretary
21	shall provide technical assistance and information to
22	assist eligible schools, State and local agencies, In-
23	dian tribal organizations, and nonprofit entities—
24	"(A) to facilitate the coordination and
25	sharing of information and resources in the De-

1	partment that may be applicable to the farm to
2	school program;
3	"(B) to collect and share information on
4	best practices; and
5	"(C) to disseminate research and data on
6	existing farm to school programs and the poten-
7	tial for programs in underserved areas.
8	"(8) FUNDING.—
9	"(A) IN GENERAL.—On October 1, 2010,
10	out of any funds in the Treasury not otherwise
11	appropriated, the Secretary of the Treasury
12	shall transfer to the Secretary to carry out this
13	subsection \$50,000,000, to remain available
14	until expended.
15	"(B) RECEIPT AND ACCEPTANCE.—The
16	Secretary shall be entitled to receive, shall ac-
17	cept, and shall use to carry out this subsection
18	the funds transferred under subparagraph (A),
19	without further appropriation.

7 SEC. 3. BUDGETARY EFFECTS.

8 The budgetary effects of this Act, for the purpose of 9 complying with the Statutory Pay-As-You-Go Act of 2010, 10 shall be determined by reference to the latest statement 11 titled "Budgetary Effects of PAYGO Legislation" for this 12 Act, submitted for printing in the Congressional Record 13 by the Chairman of the House Budget Committee, pro-14 vided that such statement has been submitted prior to the 15 vote on passage.
