A BILL

To amend Public Law 101–377 to revise the boundaries of the Gettysburg National Military Park to include the Gettysburg Train Station, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Gettysburg National
5 Military Park Expansion Act of 2010”.

6 **SEC. 2. GETTYSBURG NATIONAL MILITARY PARK EXPAN-**
7 **SION.**

8 (a) GETTYSBURG NATIONAL MILITARY PARK
9 BOUNDARY REVISION.—Section 1 of Public Law 101–377

1 (16 U.S.C. 430g–4) is amended by adding at the end the
 2 following:

3 “(d) ADDITIONAL LAND.—In addition to the land de-
 4 scribed in subsections (a) and (b), the park shall include—

5 “(1) the property commonly known as the ‘Get-
 6 tysburg Train Station’ (including land located in
 7 close proximity to the Gettysburg Train Station)
 8 that is—

9 “(A) located in the Borough of Gettysburg;
 10 and

11 “(B) depicted on the map entitled ‘Gettys-
 12 burg National Military Park, Proposed Bound-
 13 ary’, numbered 305/80,045, and dated Sep-
 14 tember 2008; and

15 “(2) the property that is—

16 “(A) located adjacent to Plum Run in
 17 Cumberland Township; and

18 “(B) depicted on the map entitled ‘Gettys-
 19 burg National Military Park, Proposed Bound-
 20 ary Addition’, numbered 305/80,046, and dated
 21 February 2009.”.

22 (b) ACQUISITION AND DISPOSAL OF LAND.—Section
 23 2(a) of Public Law 101–377 (16 U.S.C. 430g–5(a)) is
 24 amended—

1 (1) by striking “The Secretary” and inserting
2 the following:

3 “(1) IN GENERAL.—The Secretary”; and

4 (2) by adding at the end the following:

5 “(2) ACQUISITION OF PUBLICLY OWNED
6 LAND.—

7 “(A) IN GENERAL.—Subject to subpara-
8 graph (B), the Secretary may acquire only by
9 purchase from a willing seller publicly owned
10 property that is located within the property de-
11 scribed in section 1(d)(1) if the Secretary deter-
12 mines that efforts to acquire the property with-
13 out cost have been exhausted.

14 “(B) EMINENT DOMAIN.—The Secretary
15 may not acquire by eminent domain property
16 that is located within the property described in
17 section 1(d)(1).”.
