### AN ACT

- To amend the Robert T. Stafford Disaster Relief and Emergency Assistance Act to reauthorize the predisaster hazard mitigation program and for other purposes.
  - 1 Be it enacted by the Senate and House of Representa-

#### 1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the "Predisaster Hazard3 Mitigation Act of 2010".

#### 4 SEC. 2. PREDISASTER HAZARD MITIGATION.

5 (a) ALLOCATION OF FUNDS.—Section 203(f) of the
6 Robert T. Stafford Disaster Relief and Emergency Assist7 ance Act (42 U.S.C. 5133(f)) is amended to read as fol8 lows:

"(f) Allocation of Funds.—

"(1) IN GENERAL.—The President shall award
financial assistance under this section on a competitive basis and in accordance with the criteria in subsection (g).

"(2) MINIMUM AND MAXIMUM AMOUNTS.—In
providing financial assistance under this section, the
President shall ensure that the amount of financial
assistance made available to a State (including
amounts made available to local governments of the
State) for a fiscal year—

- 20 "(A) is not less than the lesser of—
  - "(i) \$575,000; or

22 "(ii) the amount that is equal to 1
23 percent of the total funds appropriated to
24 carry out this section for the fiscal year;

13	"(2) \$190,000,000 for fiscal year 2012;
14	"(3) \$200,000,000 for fiscal year 2013;
15	"(4) \$200,000,000 for fiscal year 2014; and
16	"(5) \$200,000,000 for fiscal year 2015.".
