## A BILL

To reauthorize the national small business tree planting program, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Small Business Envi-
- 5 ronmental Stewardship Assistance Act of 2010".

- 10 ness Environmental Stewardship Assistance Act of 2010,
- 11 and annually thereafter, the Administrator shall submit".
